DESCRIPTION

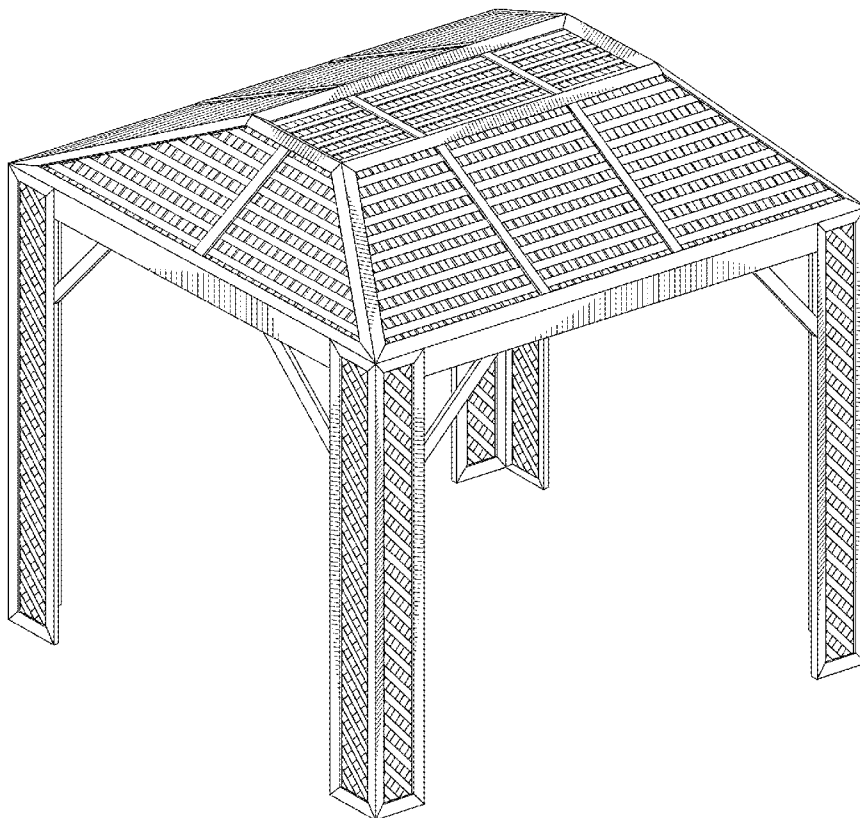
FIG. 1 is a perspective view of a lattice garden building showing our new design;

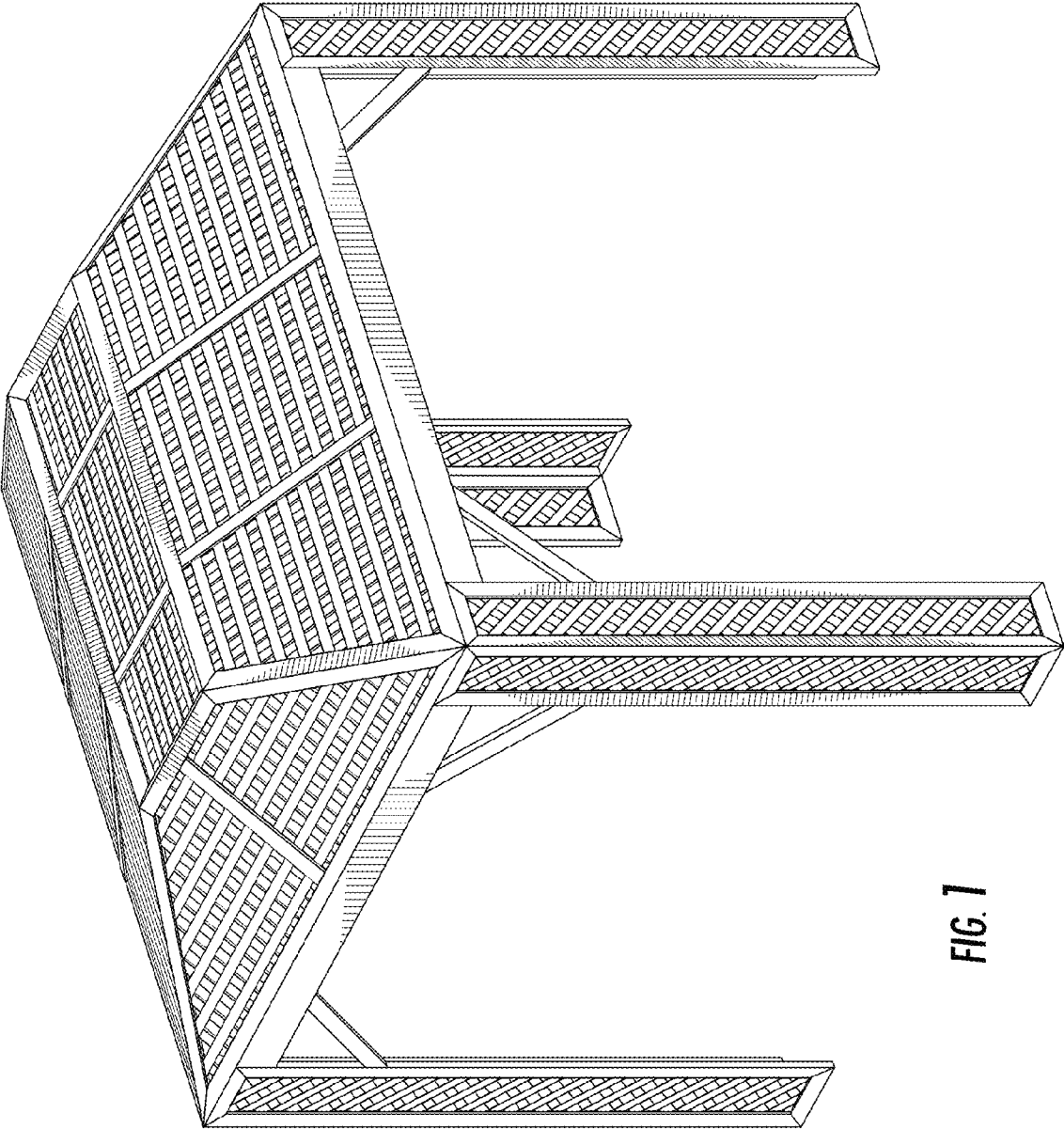

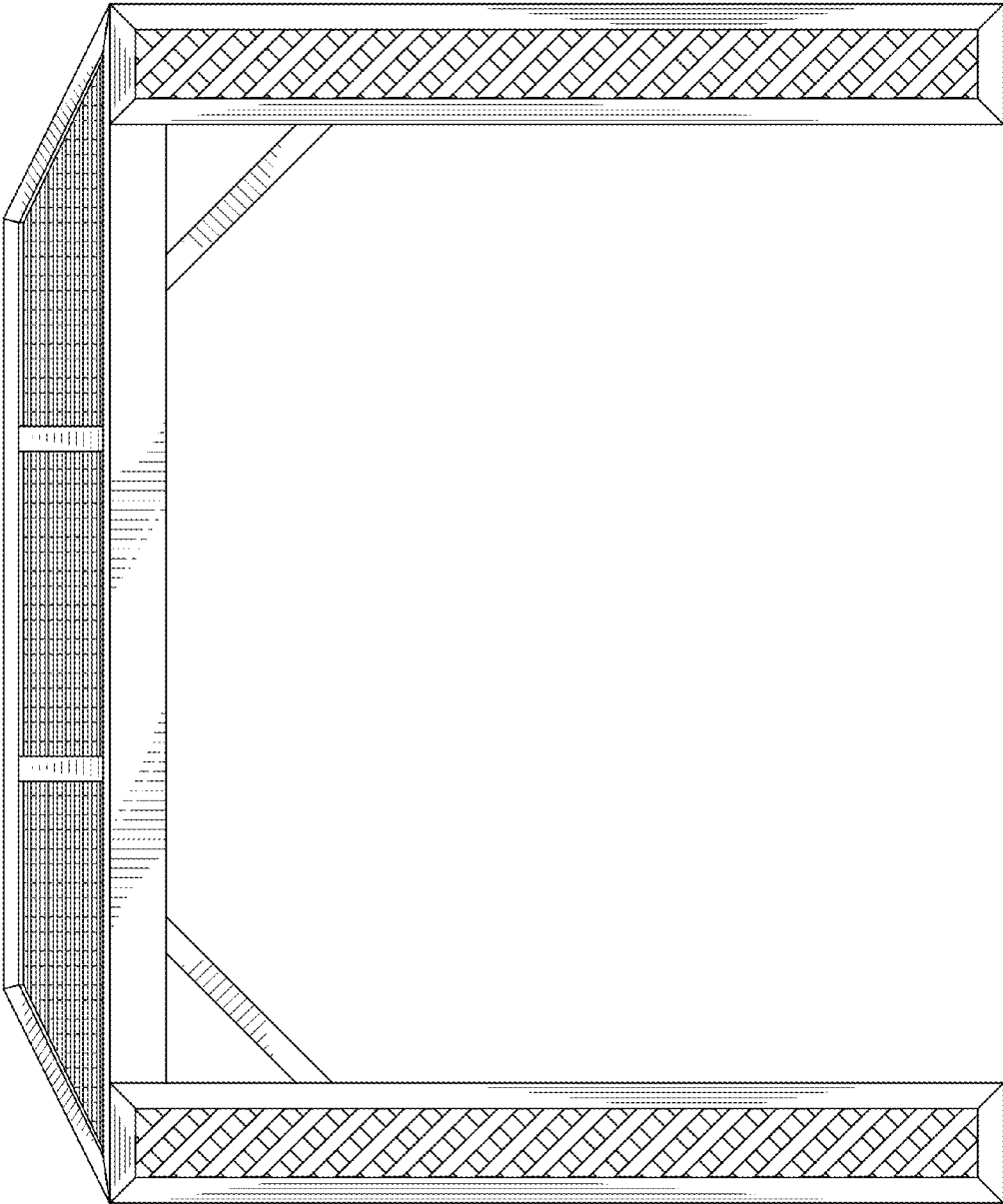

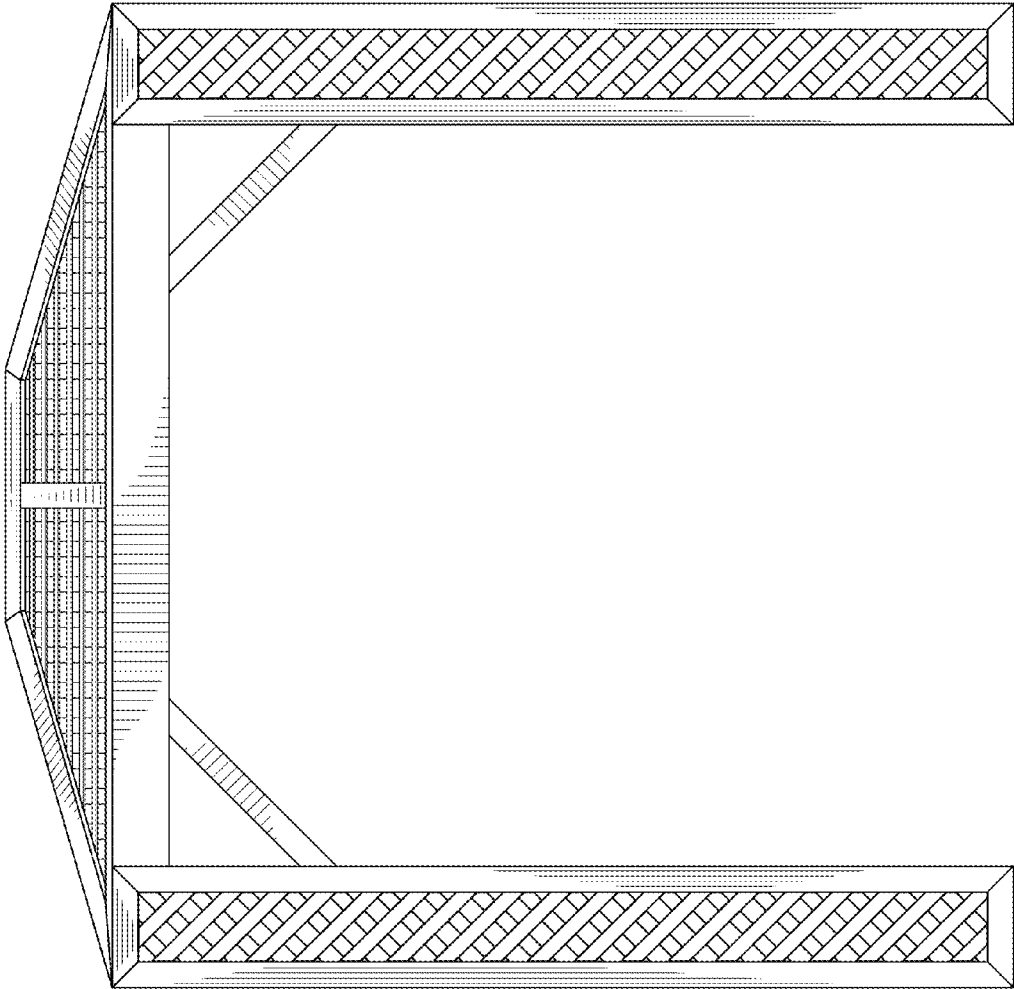

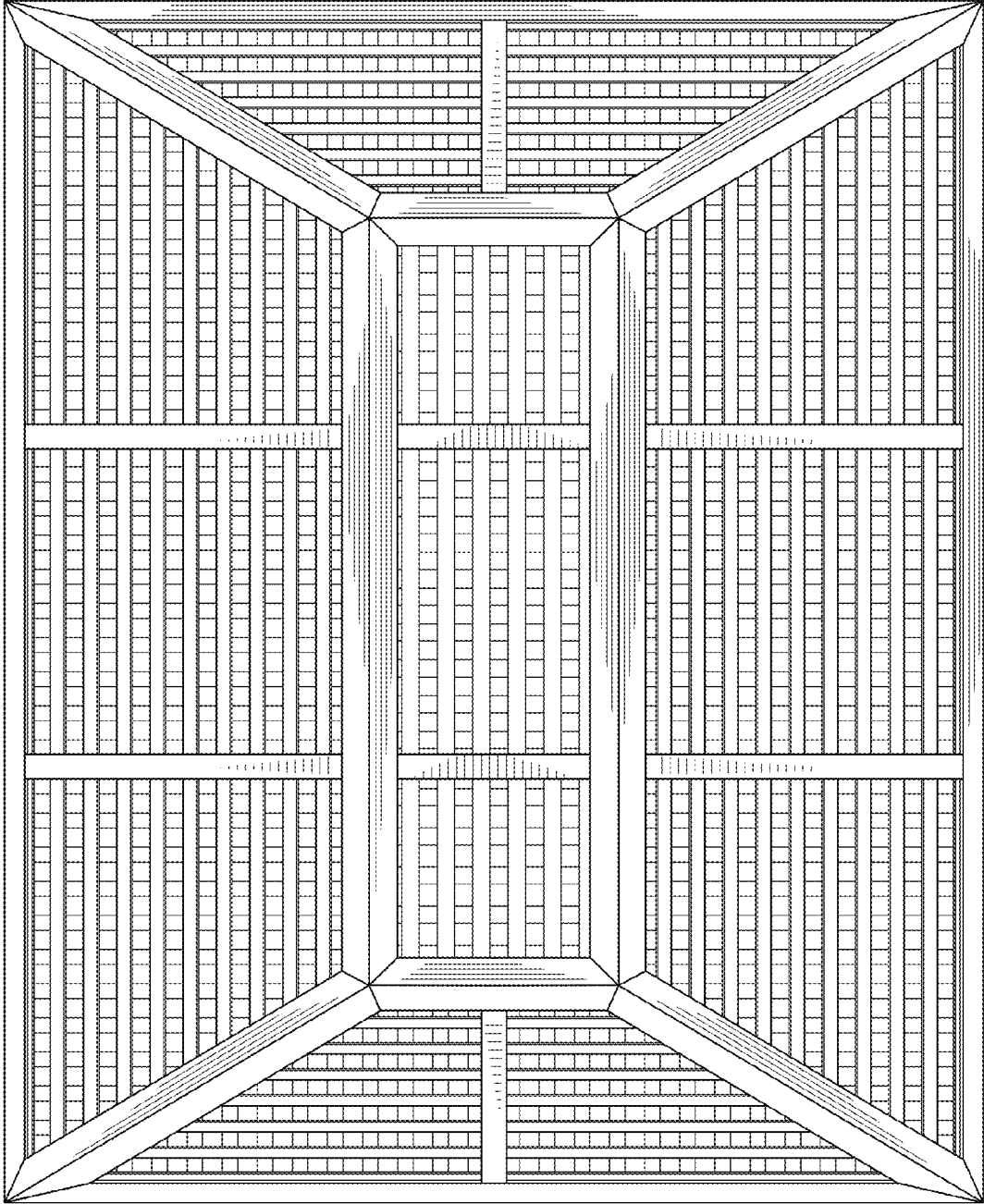
