



(57) Abstract: A connectivity system (30) for facilitating user connectivity in a computer network. The connectivity system includes attention manager (32), an identity manager (34), and an introduction manager (36). The connectivity system is devised to glean user preferences, wants, and needs from user data and user actions, such as data input and user behavior, to facilitate the functions extant applications, such as search engine (80), a discourse engine (82) and a content engine (84) serving the user.
