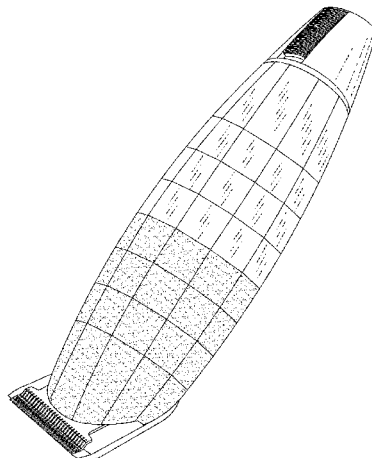
(57) **CLAIM**

We claim the ornamental design for a trimmer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of one embodiment of a design of the trimmer;  
FIG. 2 is a first side elevation view of the design of FIG. 1, with the opposite, second side elevation view being a mirror image of the first side elevation view;  
FIG. 3 is a top plan view of the design of FIG. 1;  
FIG. 4 is a bottom plan view of the design of FIG. 1;  
FIG. 5 is a front elevation view of the design of FIG. 1;  
FIG. 6 is a back elevation view of the design of FIG. 1;  
FIG. 7 is a back perspective view of the design of FIG. 1;  
FIG. 8 is a front perspective view of another embodiment of a design of the trimmer;  
FIG. 9 is a first side elevation view of the design of FIG. 8, with the opposite, second side elevation view being a mirror image of the first side elevation view;  
FIG. 10 is a top plan view of the design of FIG. 8;  
FIG. 11 is a bottom plan view of the design of FIG. 8;  
FIG. 12 is a front elevation view of the design of FIG. 8;  
FIG. 13 is a back elevation view of the design of FIG. 8; and  
FIG. 14 is a back perspective view of the design of FIG. 8. The broken lines illustrate portions of the trimmer and form no part of the claimed design.

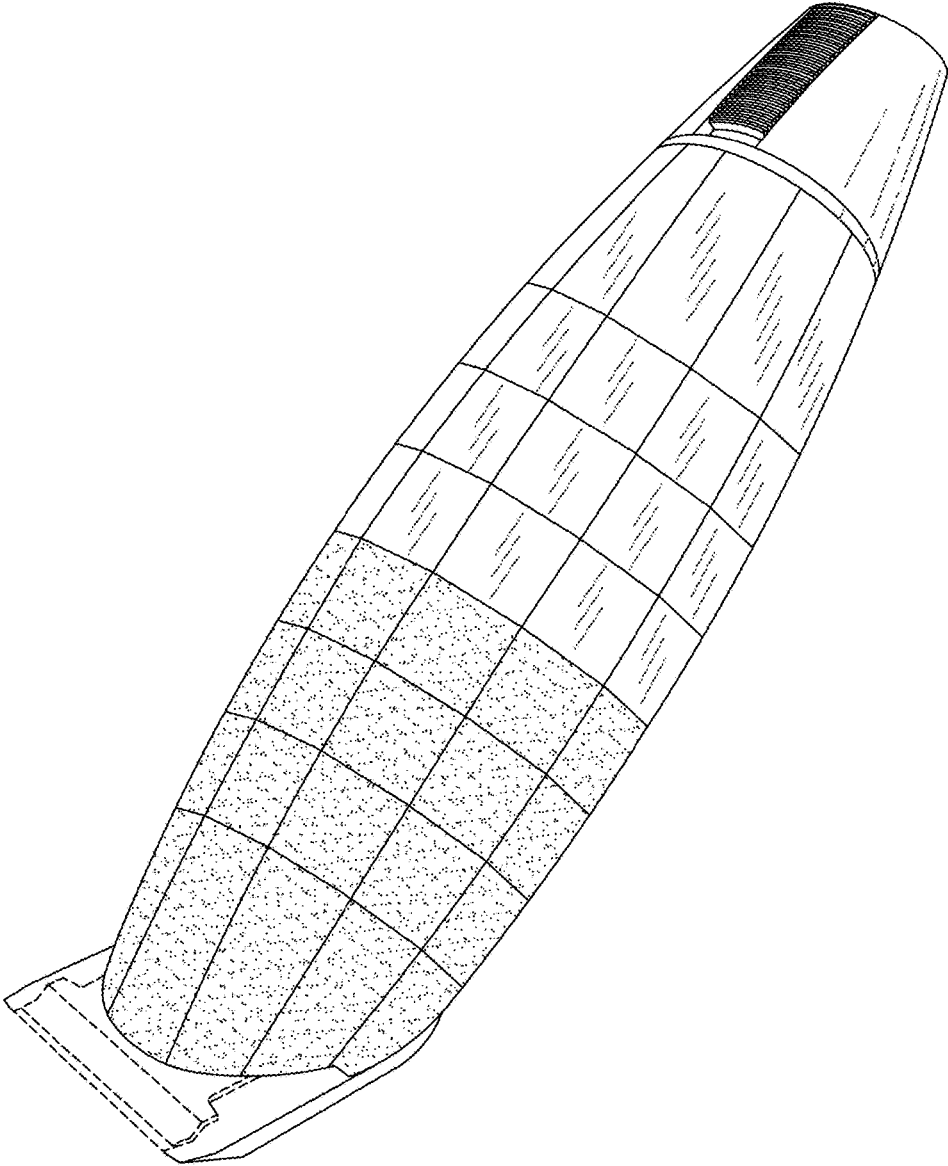

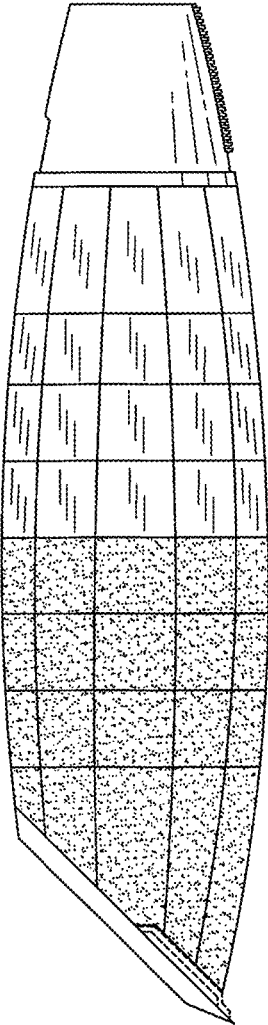

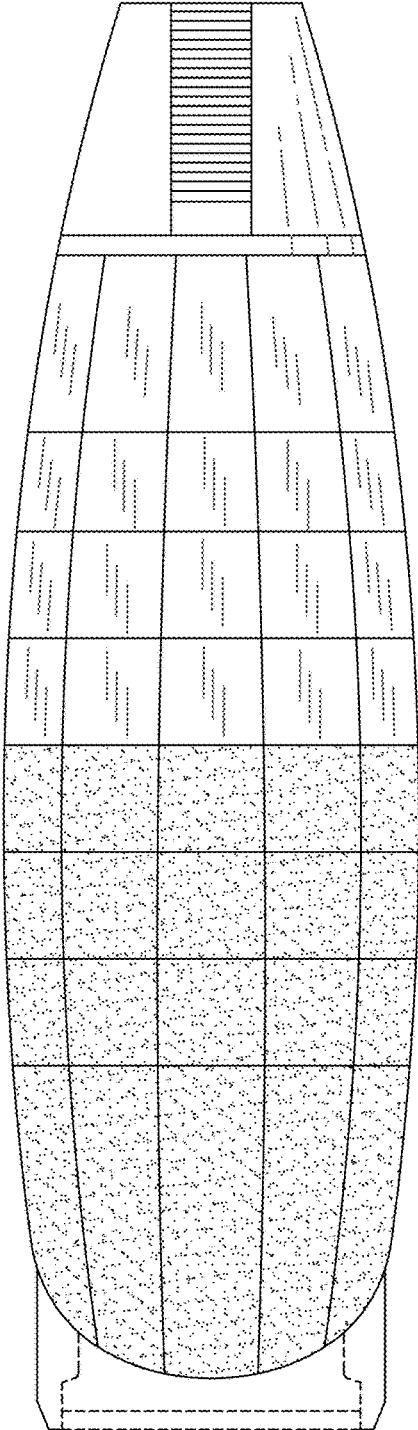

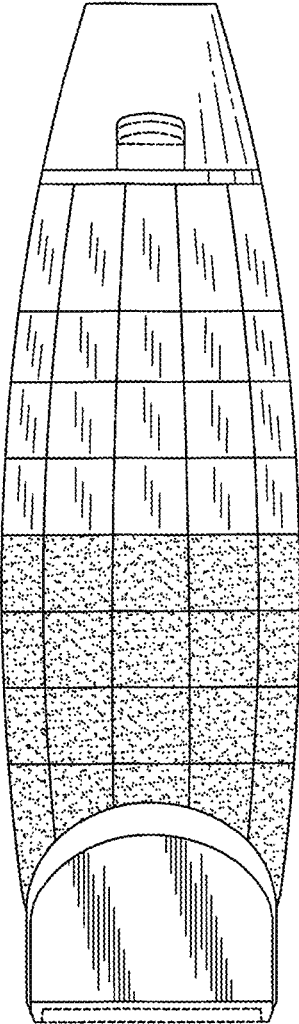

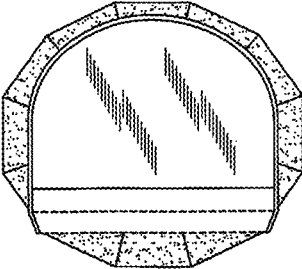

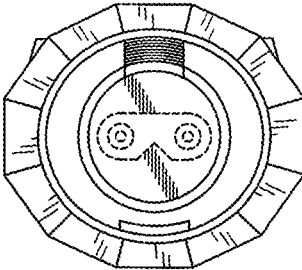

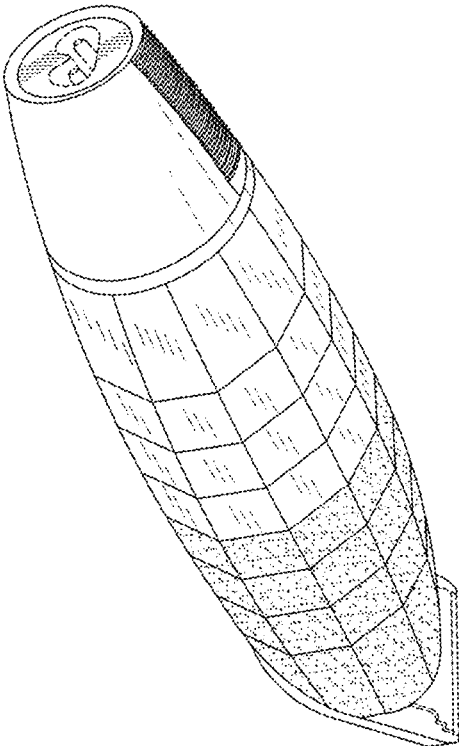

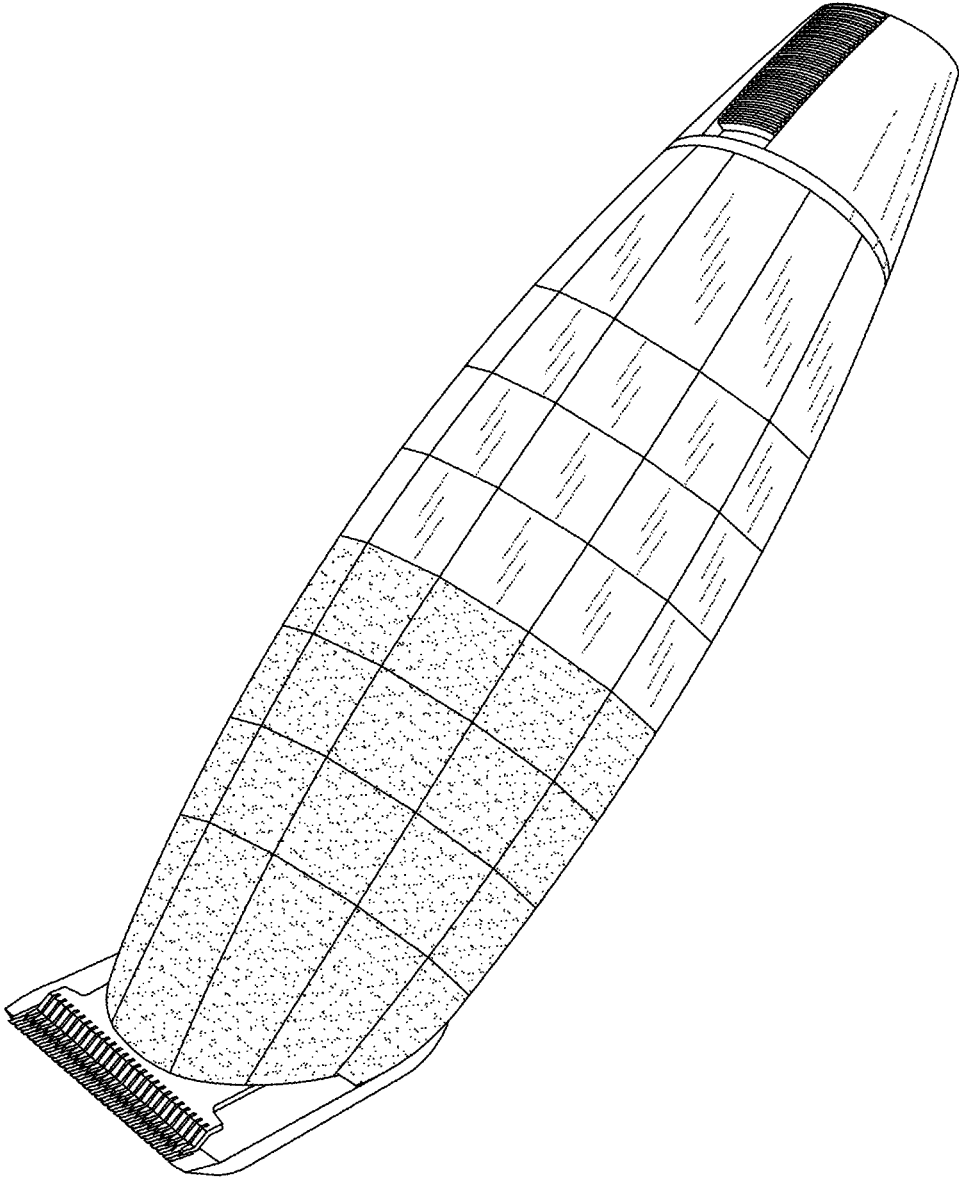

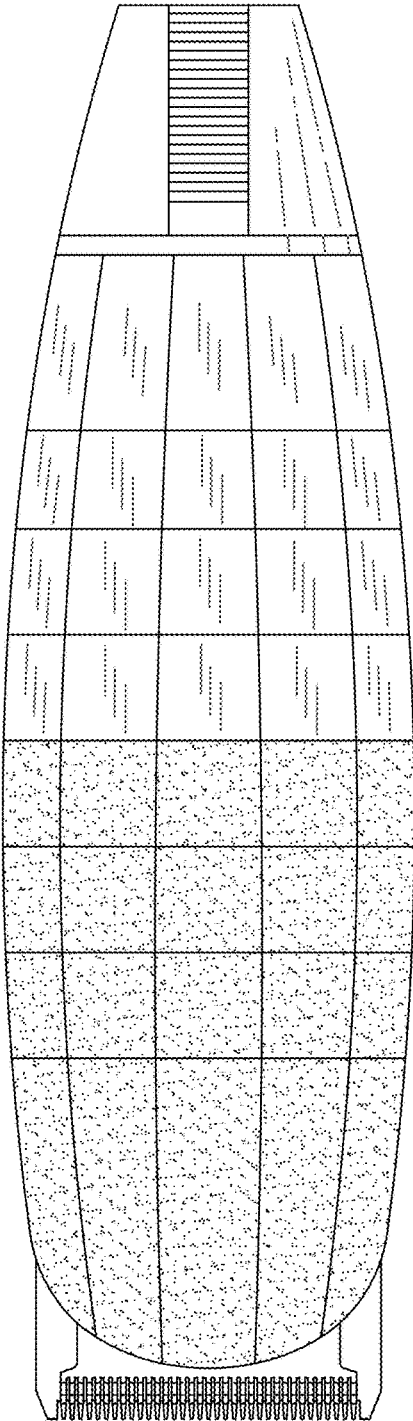

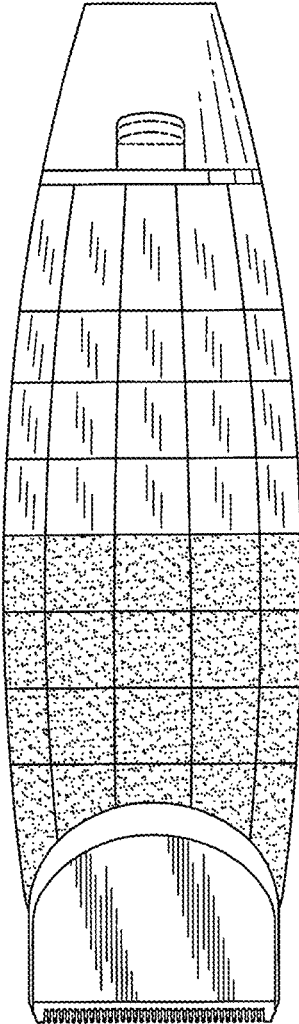

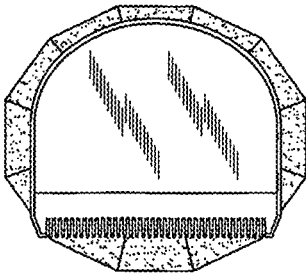

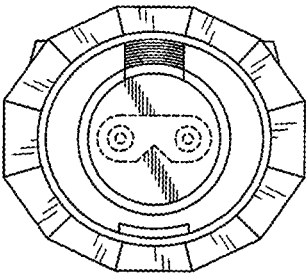

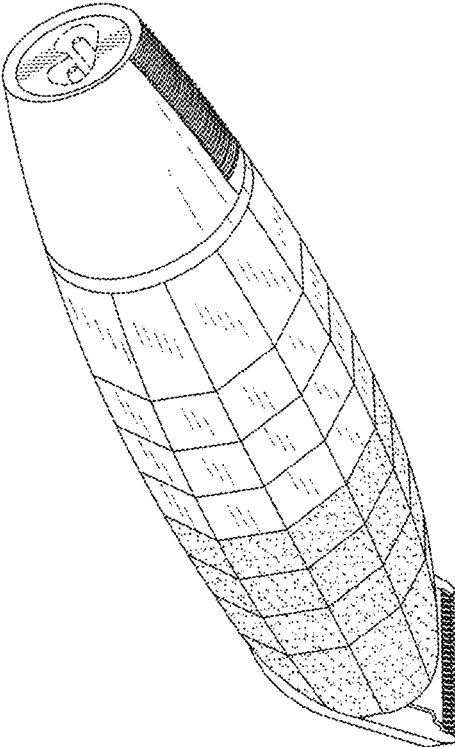
