
(57) **CLAIM**

The ornamental design for a mirror rotation mount for a cycle vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mirror rotation mount for a cycle vehicle showing our new design;
FIG. 2 is a close-up of the perspective view of FIG. 1;
FIG. 3 is a top plan view of the mirror rotation mount for a cycle vehicle;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear plan view thereof;
FIG. 6 is a front plan view thereof;
FIG. 7 is a right plan view thereof; and,
FIG. 8 is a left plan view thereof.
















