The ornamental design for dance footwear, as shown and described.

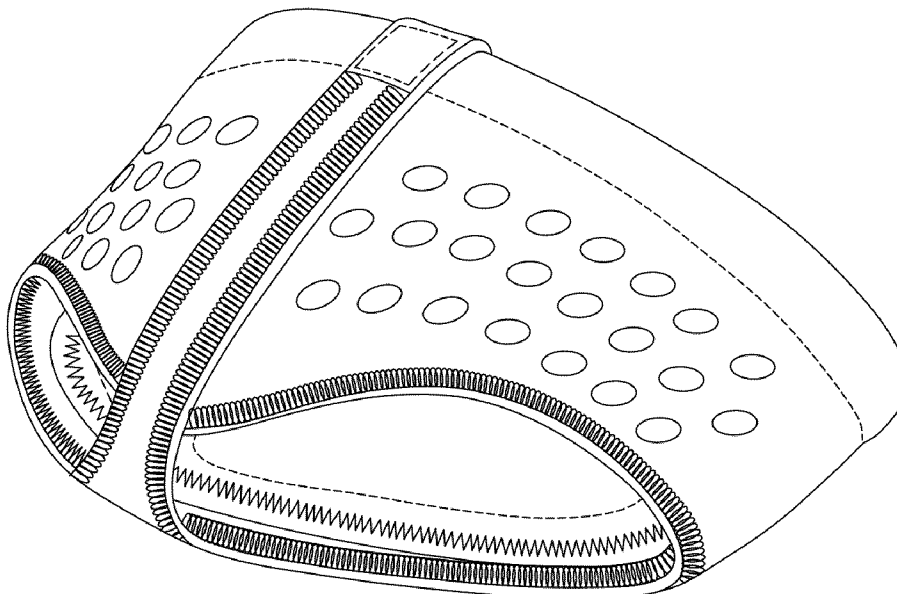
**DESCRIPTION**

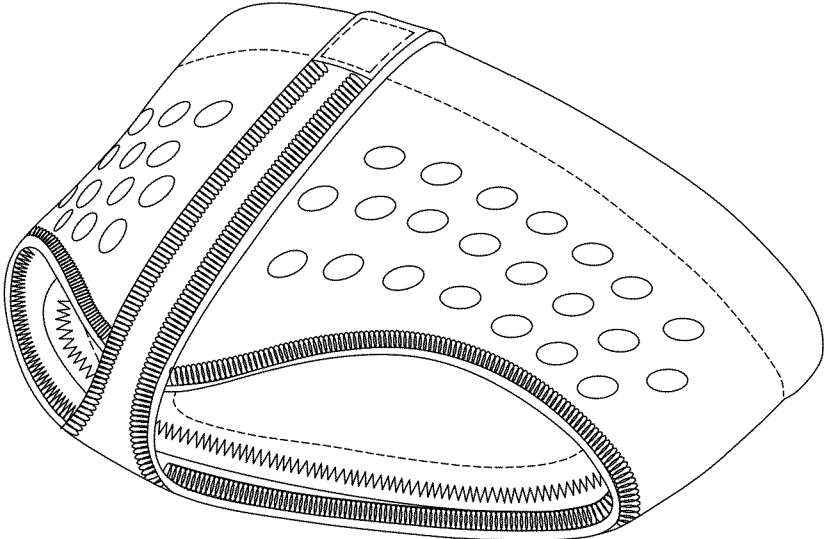

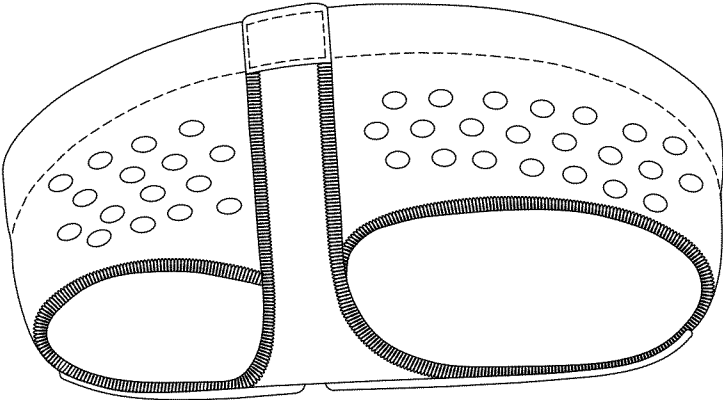

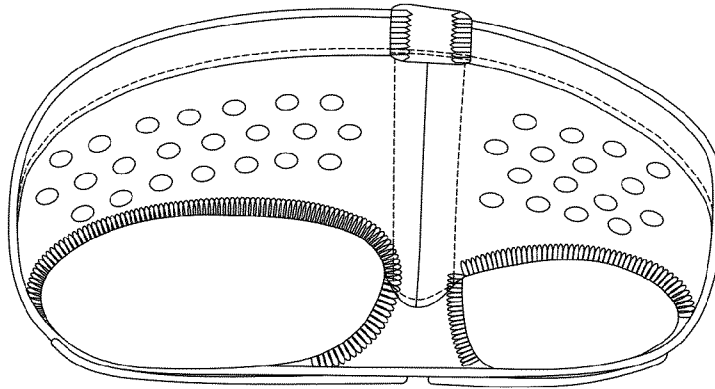

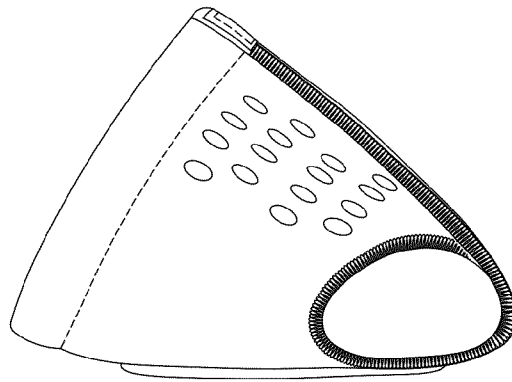

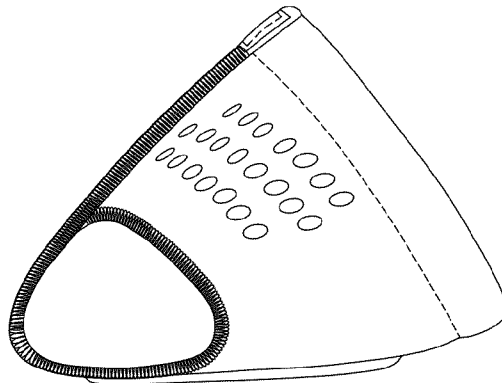

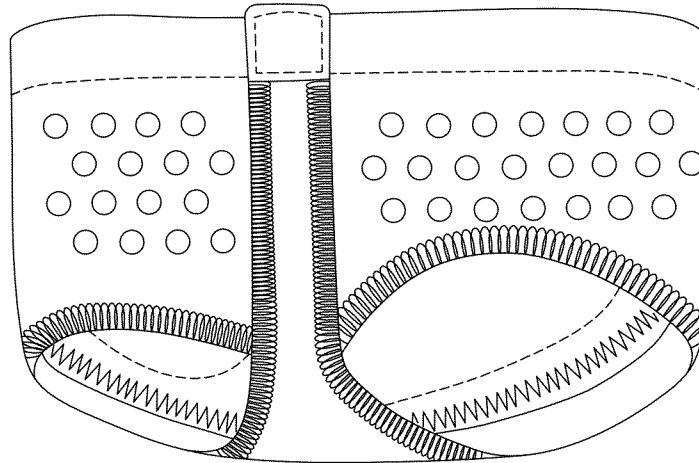

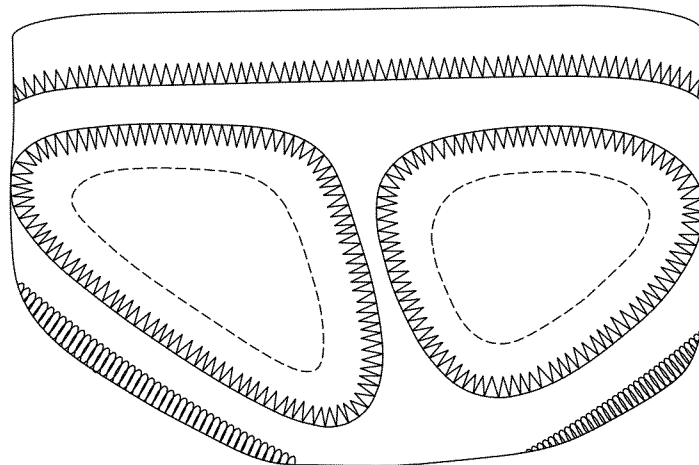
