(54) **Abrading method**

(57) A diamond abrasive compact is used for abrading a workpiece in a corrosive environment. The invention has particular application to abrading wood prod-

ucts which contain resins or organic binders. The diamond abrasive compact is characterised by a second phase which comprises chromium and nickel.
