
(57) **CLAIM**

The ornamental design for a GPS personal locator phone, as shown and described.

DESCRIPTION

FIG. 1 is a front, bottom, right perspective view of a GPS personal locator phone, showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.














