(57) **CLAIM**


The ornamental design for a module housing portion for multi-function equipment, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a module housing portion for multi-function equipment showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a top view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a front view thereof, the rear view being a mirror image.

The broken lines in the drawings represent environmental subject matter and form no part of the claimed design.














