(57) **CLAIM**

We claim the ornamental design for a pouch for digital camera and accessories, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pouch for a digital camera and accessories showing our new design;

FIG. 2 is a front elevational view of the pouch shown in FIG. 1.

FIG. 3 is a rear elevational view of the pouch shown in FIG. 1.

FIG. 4 is a left elevational view of the pouch shown in FIG. 1.

FIG. 5 is a right elevational view of the pouch shown in FIG. 1.

FIG. 6 is a plan view of the pouch shown in FIG. 1.

FIG. 7 is a bottom side view of the pouch shown in FIG. 1.

FIG. 8 is a front perspective view of an alternate embodiment of the pouch shown in FIG. 1.

FIG. 9 is a front elevational view of the pouch shown in FIG. 8.

FIG. 10 is a rear elevational view of the pouch shown in FIG. 8.

FIG. 11 is a left elevational view of the pouch shown in FIG. 8.

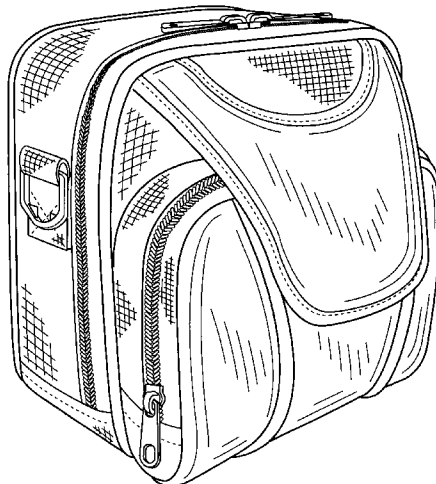
FIG. 12 is a right elevational view of the pouch shown in FIG. 8.

FIG. 13 is a plan view of the pouch shown in FIG. 8; and, FIG. 14 is a bottom side view of the pouch shown in FIG. 8.

The pouch depicted in the drawings is “soft,” meaning that it is largely made of fabric, and is useful for carrying equipment and the accessories related to such equipment. An example of such equipment is a digital camera.

The broken lines shown along the edges of the flap, the sides, and the rear of the views are understood to represent stitching.

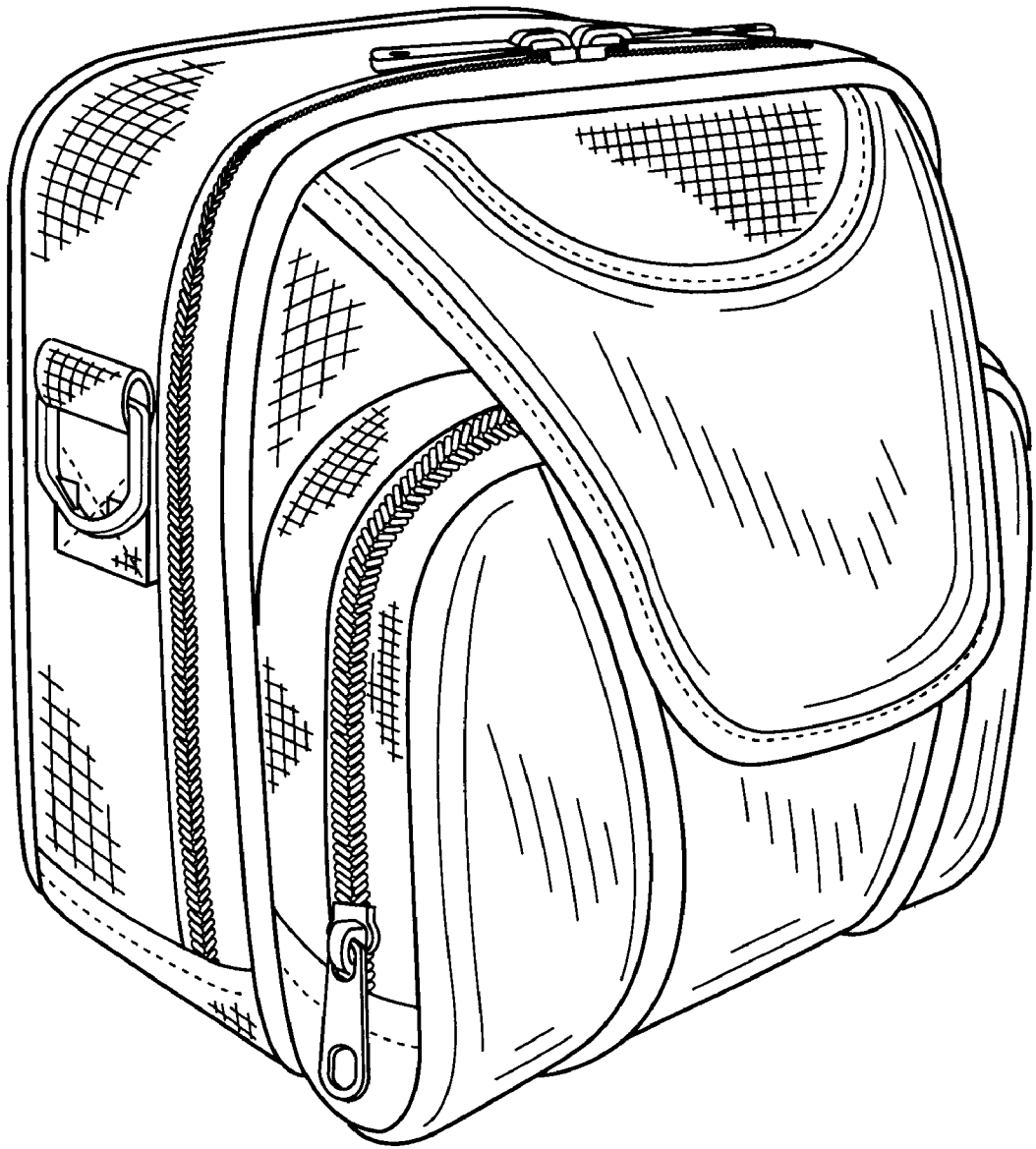

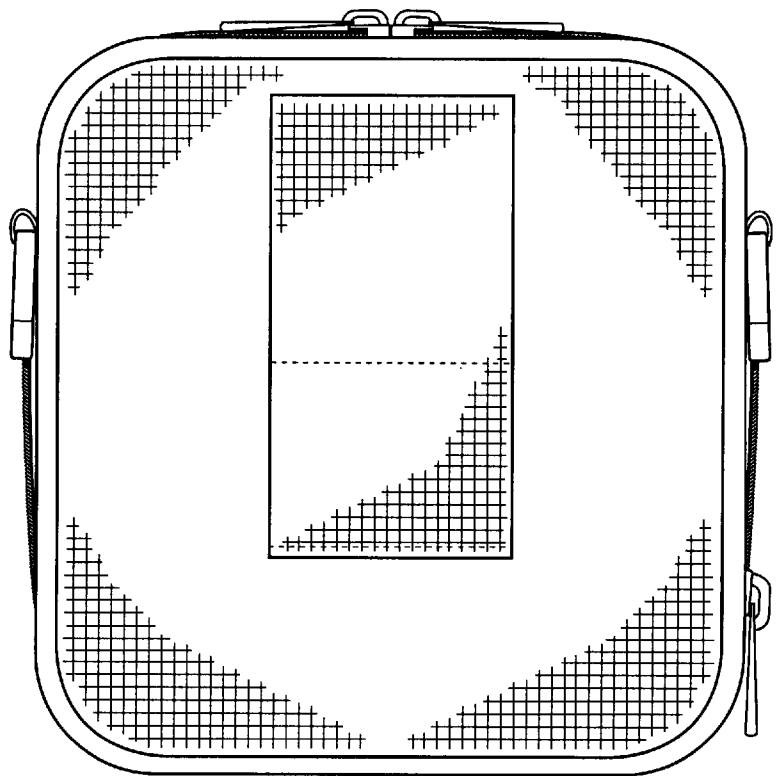

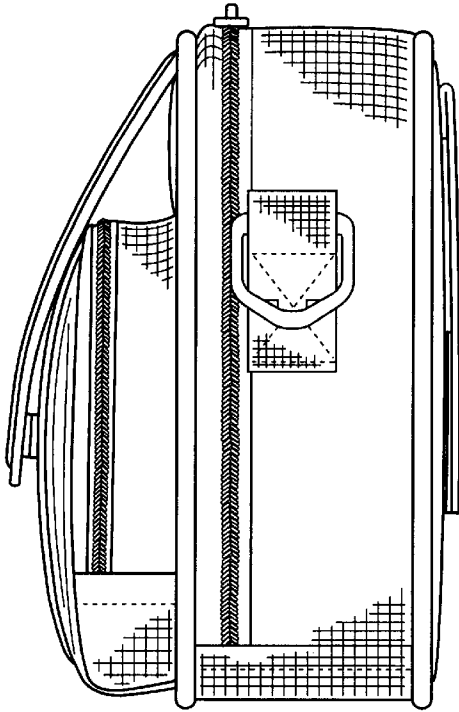
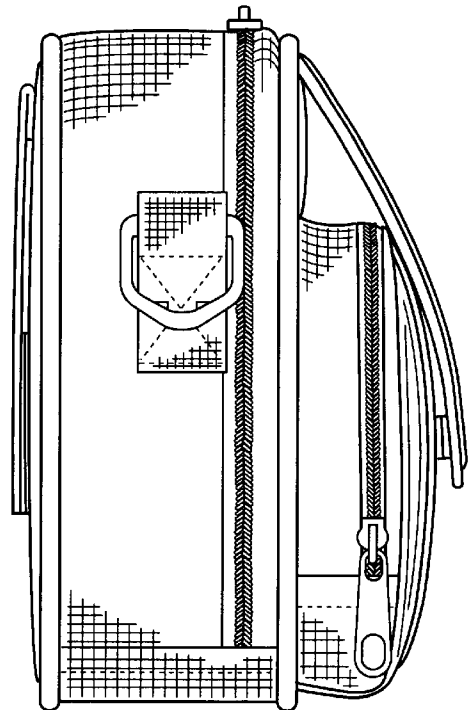

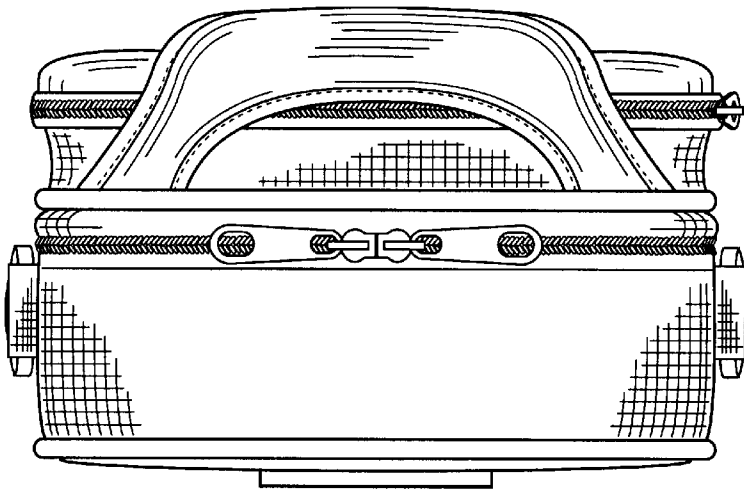

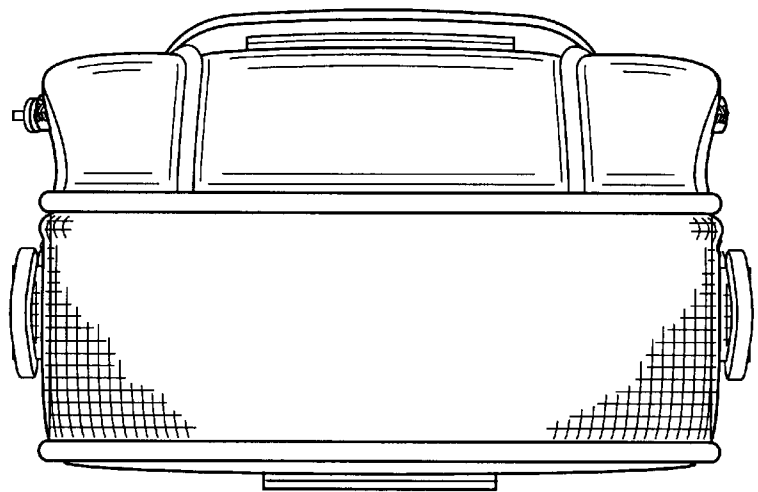

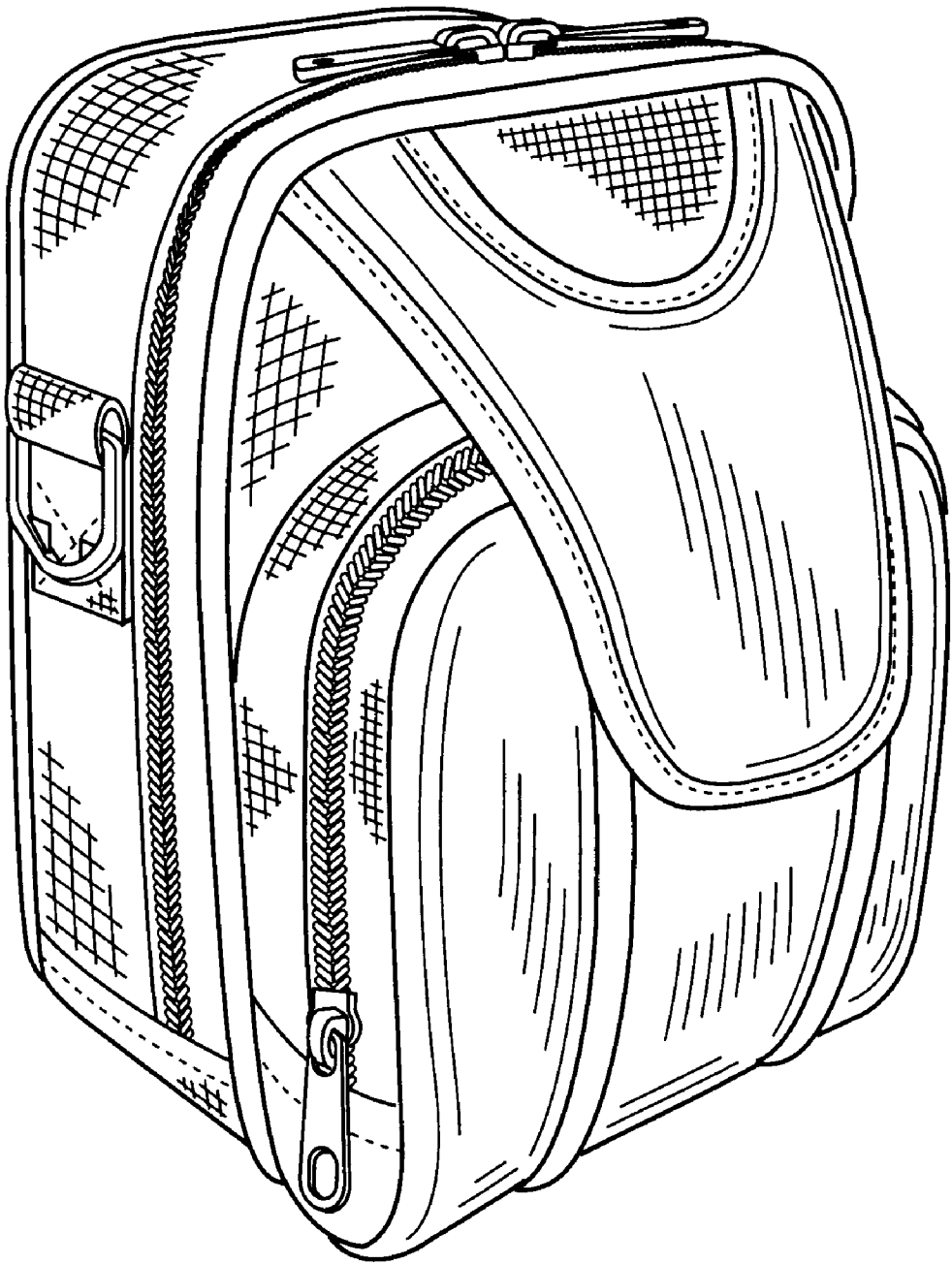

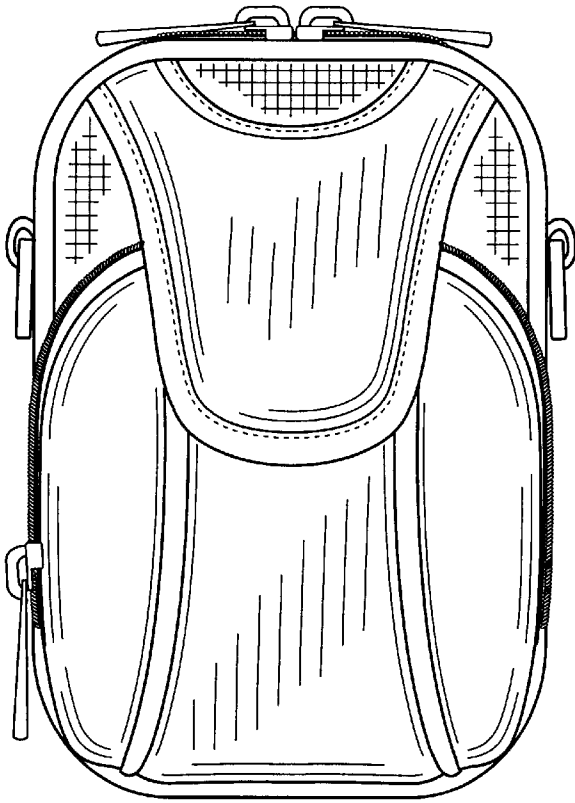

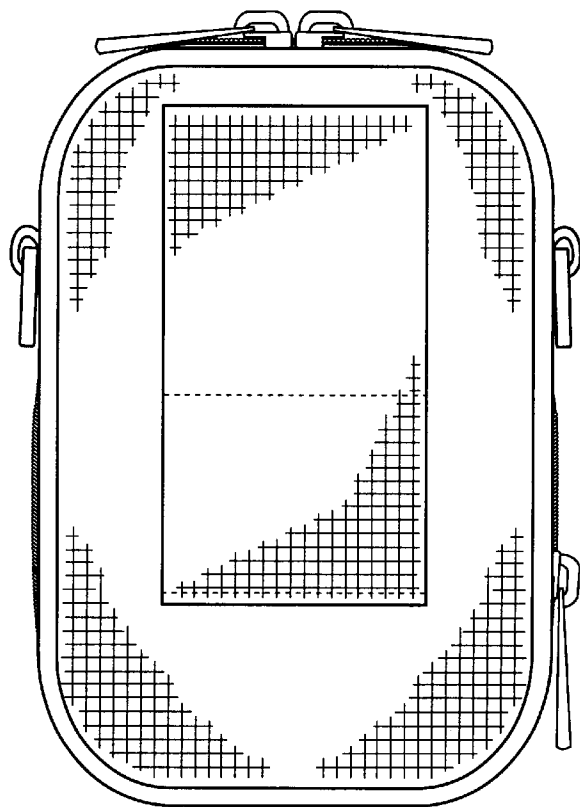

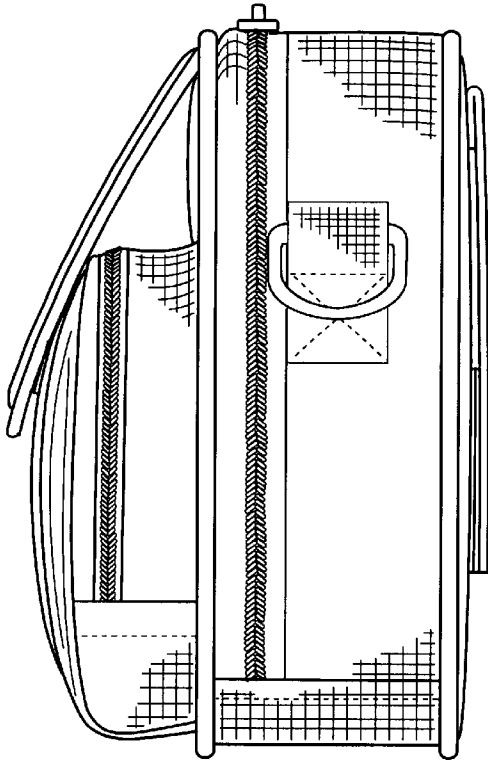
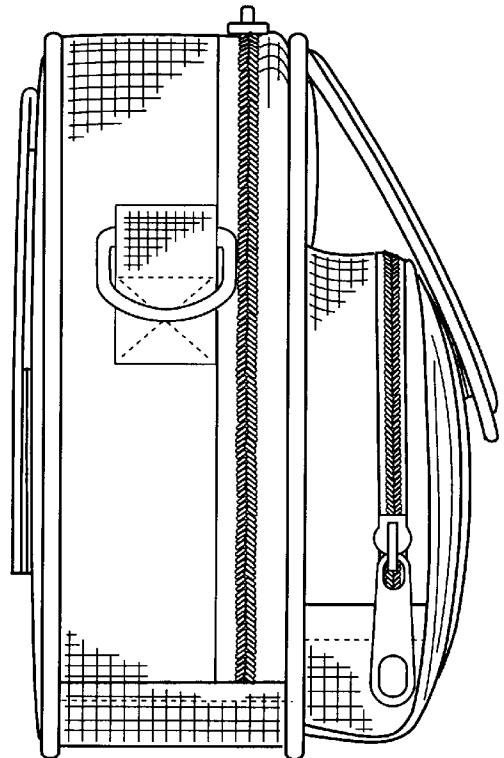

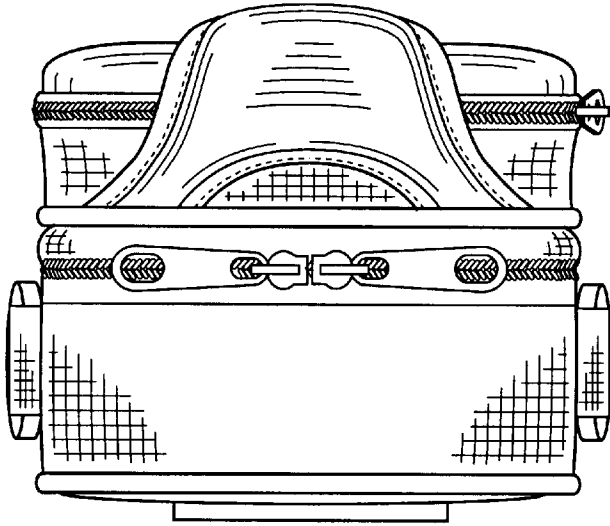
