(57) **CLAIM**

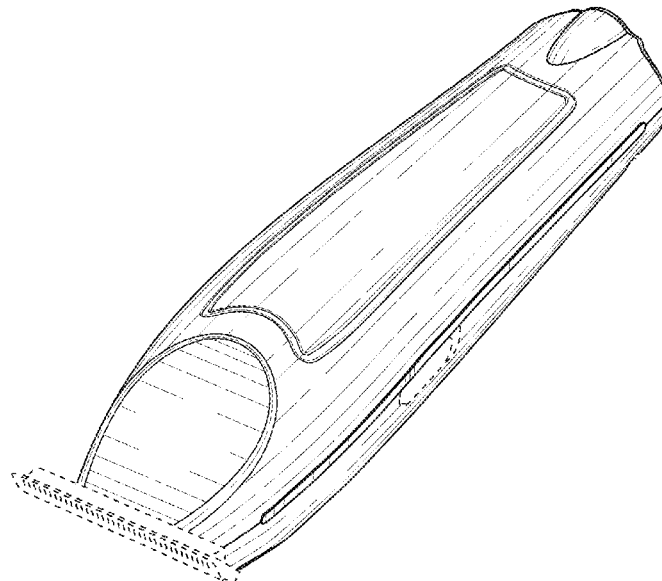
The ornamental design for a hair trimmer housing, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the present hair trimmer housing;

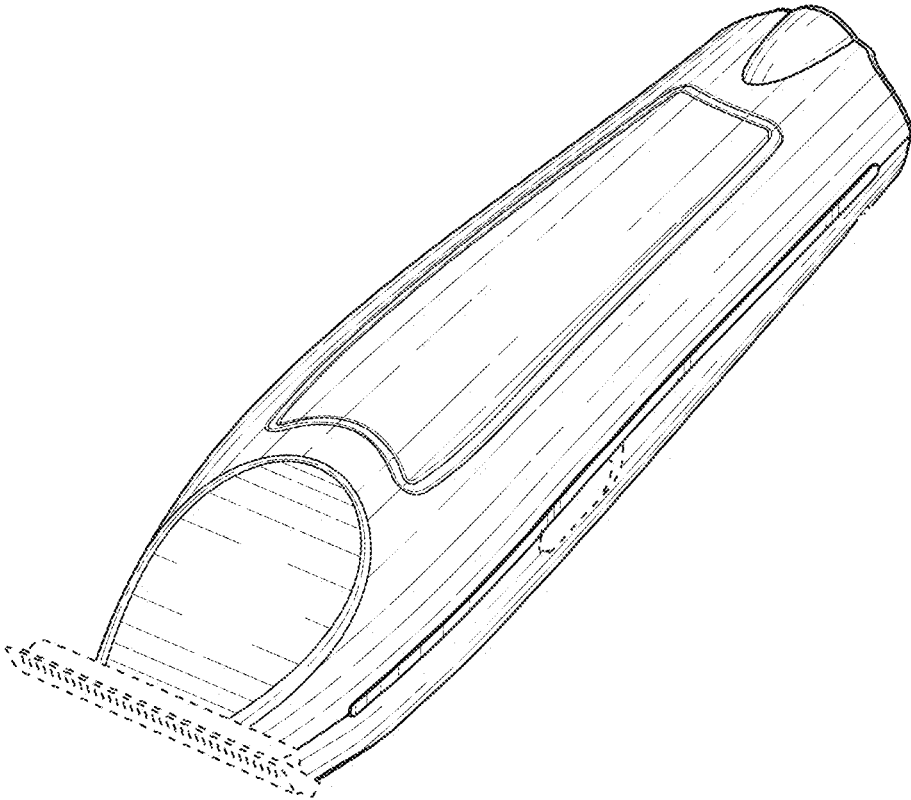

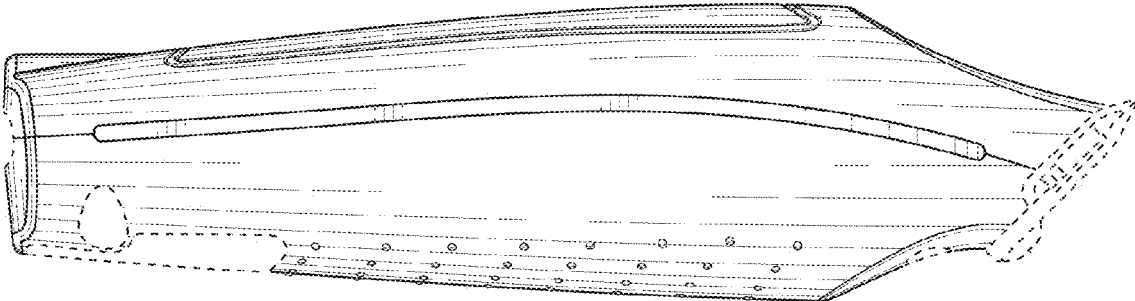

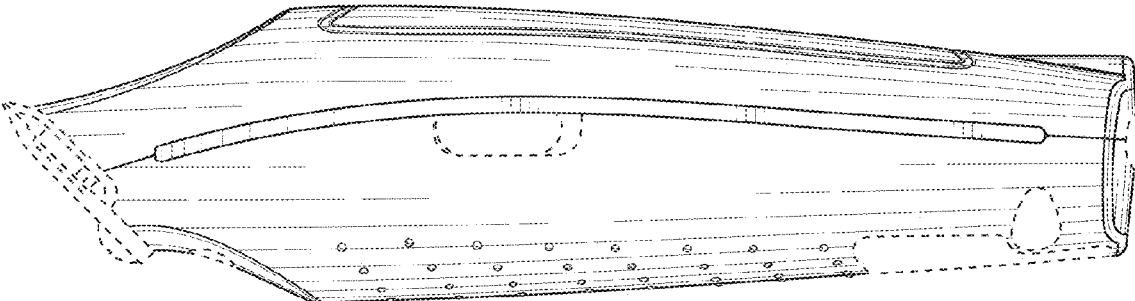

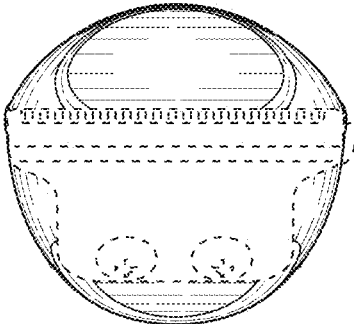

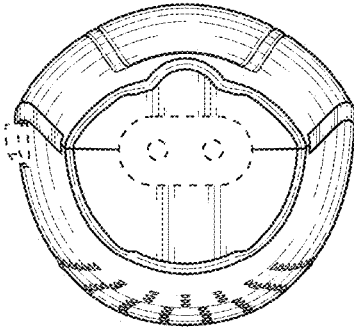

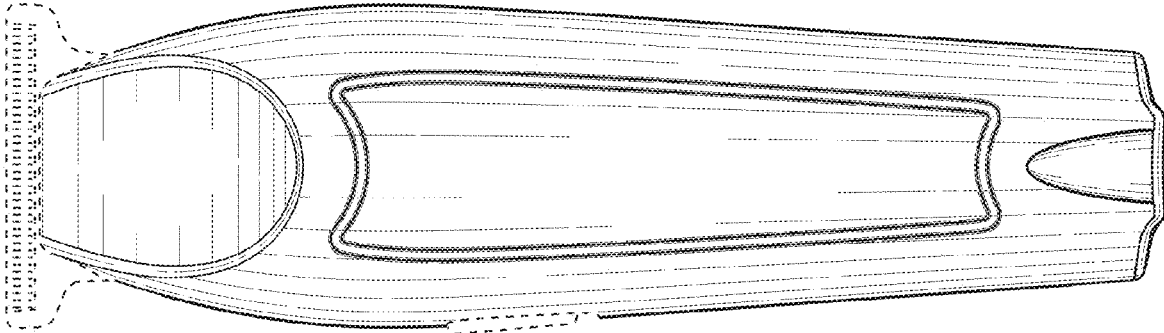

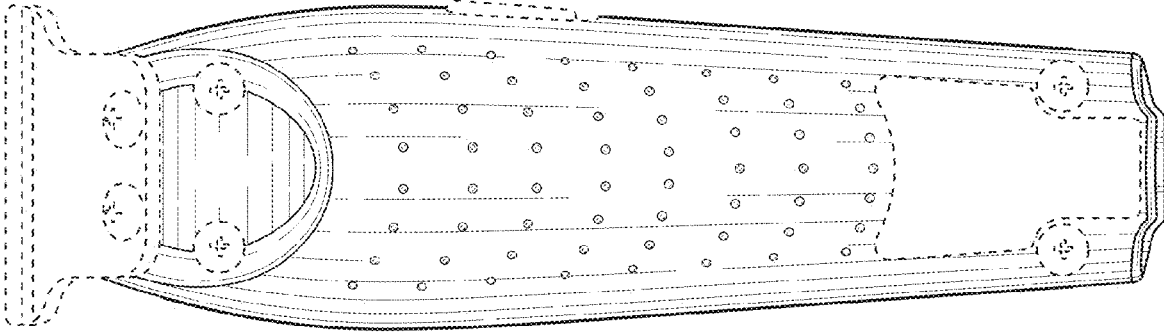
