

(57) Abstract: A method of manufacturing a thin film panel is provided, which includes: forming a gate line (20) on a substrate (10), the gate line including a gate electrode; forming a gate insulating layer on the gate line; forming a silicon layer formed on the gate insulating layer; forming a data line intersecting the gate line and a drain electrode separated from the data line on the silicon layer or on the gate insulating layer; and forming a self assembled monolayer (SAM) (30) on at least one of the gate line and the data line.
