(57) **CLAIM**

The ornamental design for a swivel hook, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the swivel hook of the claimed design, the rear view being a mirror image of the front view.

FIG. 2 is a top plan view of the swivel hook of FIG. 1.

FIG. 3 is a bottom plan view of the swivel hook of FIG. 1.

FIG. 4 is a left side view of the swivel hook of FIG. 1.

FIG. 5 is a right side view of the swivel hook of FIG. 1; and,

FIG. 6 is a perspective view of the swivel hook of FIG. 1.












