(57) **CLAIM**

The ornamental design for a shaped protective cover for a push bar of exit door, as shown and described.

DESCRIPTION

FIG. 1 is a bottom rear perspective view of a shaped protective cover for a push bar of exit door showing my new design;

FIG. 2 is a top front perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;


FIG. 5 is a top view of the shaped protective cover for a door fixture exit push bar of the present design;

FIG. 6 is a top plan view thereof;










