The ornamental design for an earphone, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side, top perspective view of an earphone;

FIG. 2 is a front, left side, top perspective view thereof;

FIG. 3 is a rear, left side, bottom perspective view thereof;

FIG. 4 is a rear, right side, bottom perspective view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a front elevation view thereof;

FIG. 7 is a right side elevation view thereof;

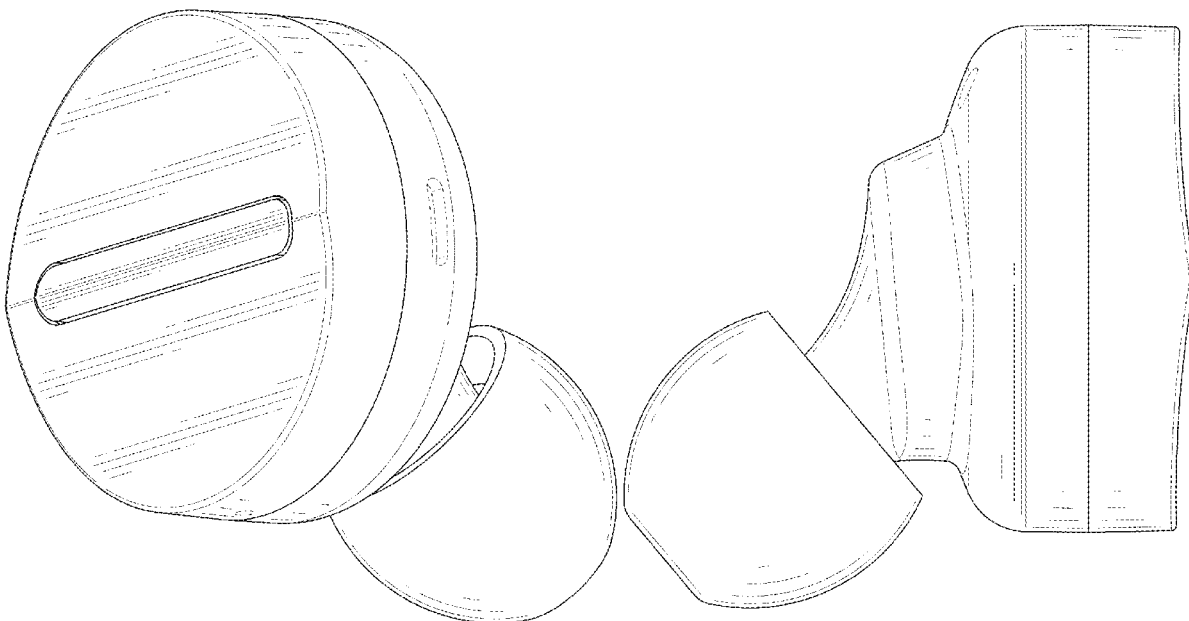
FIG. 8 is a left side elevation view thereof;

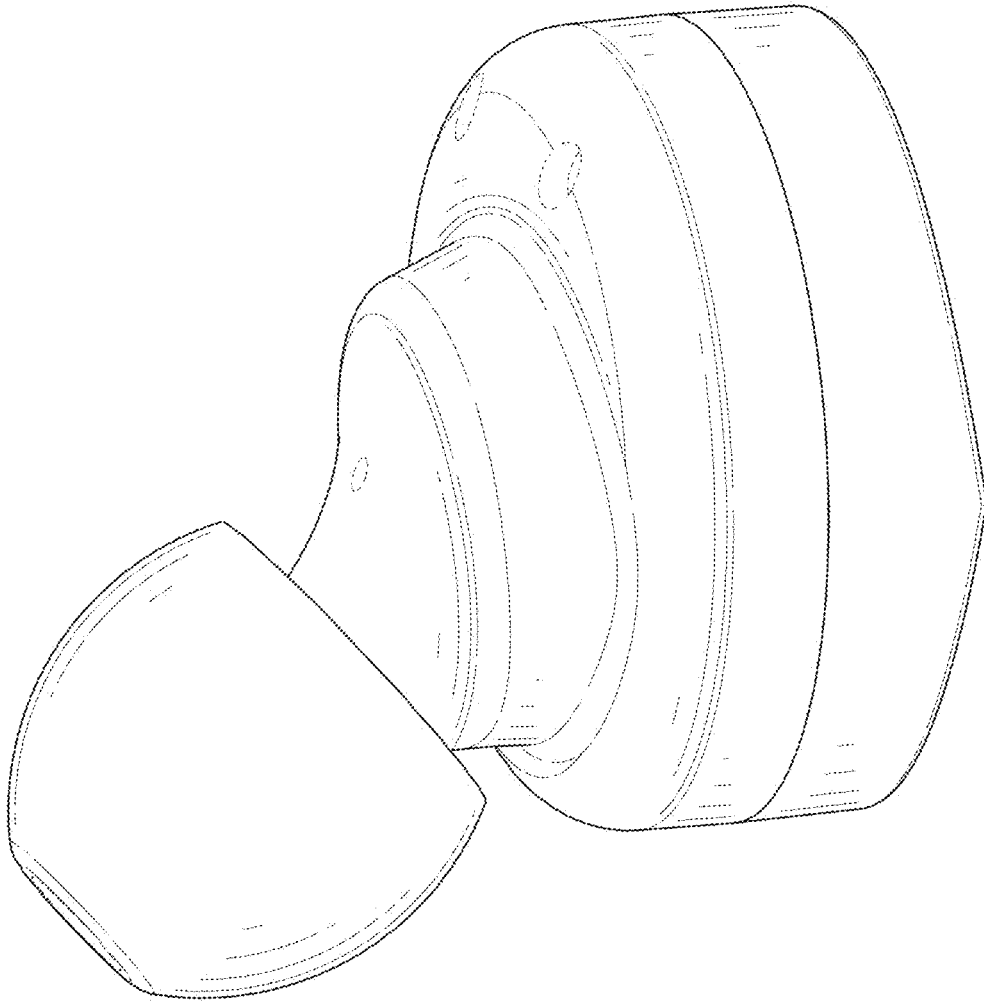

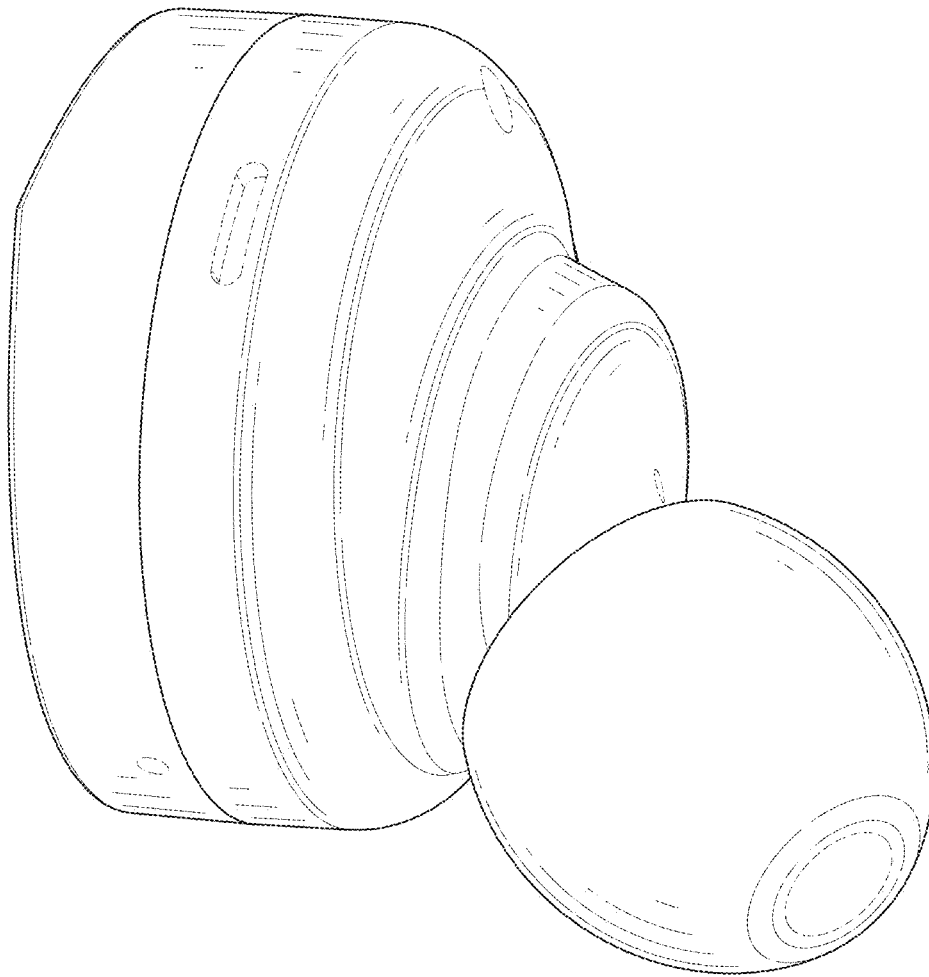

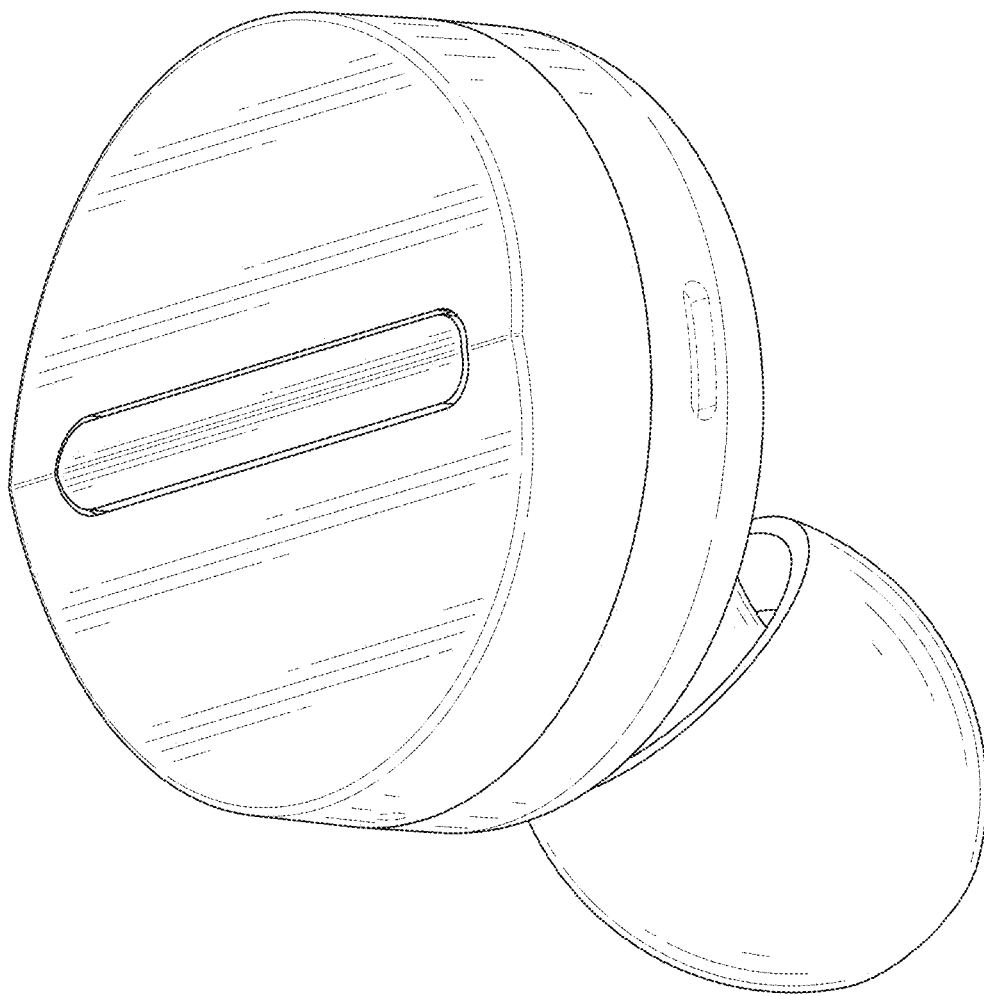

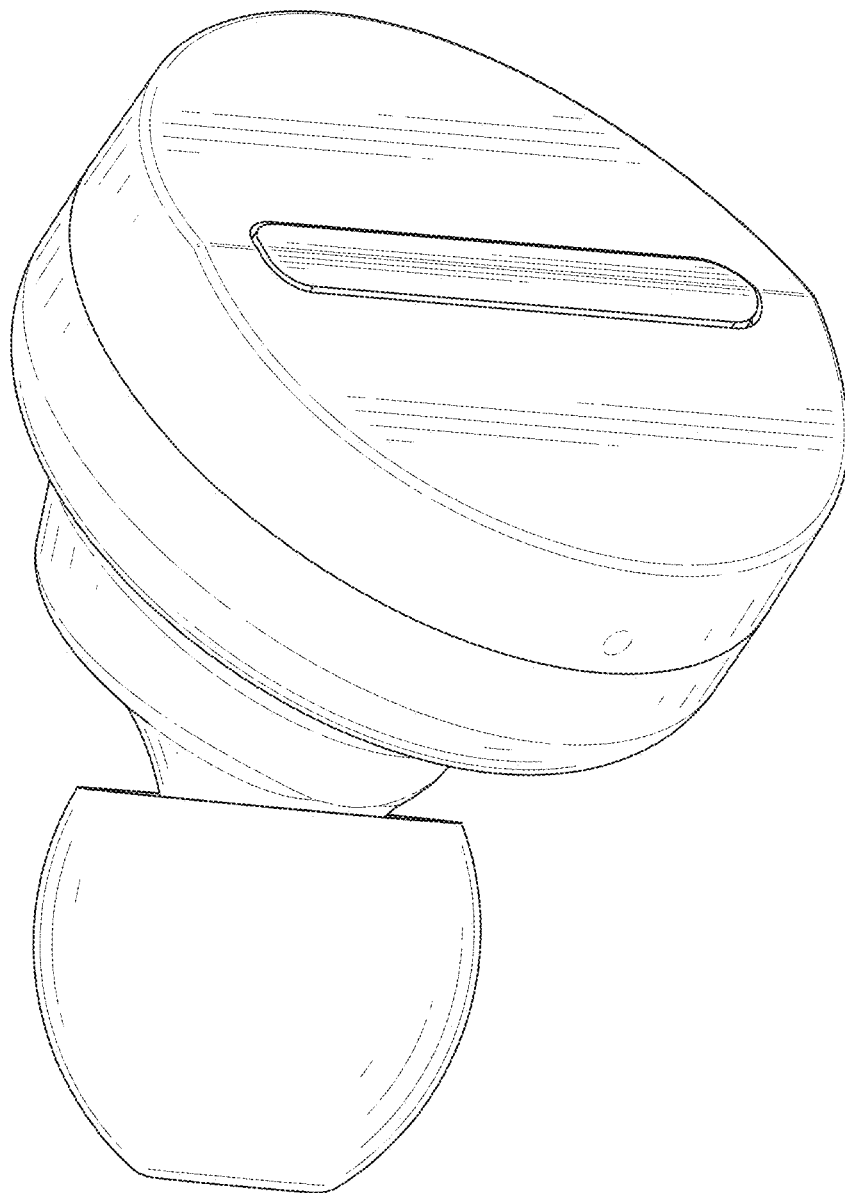

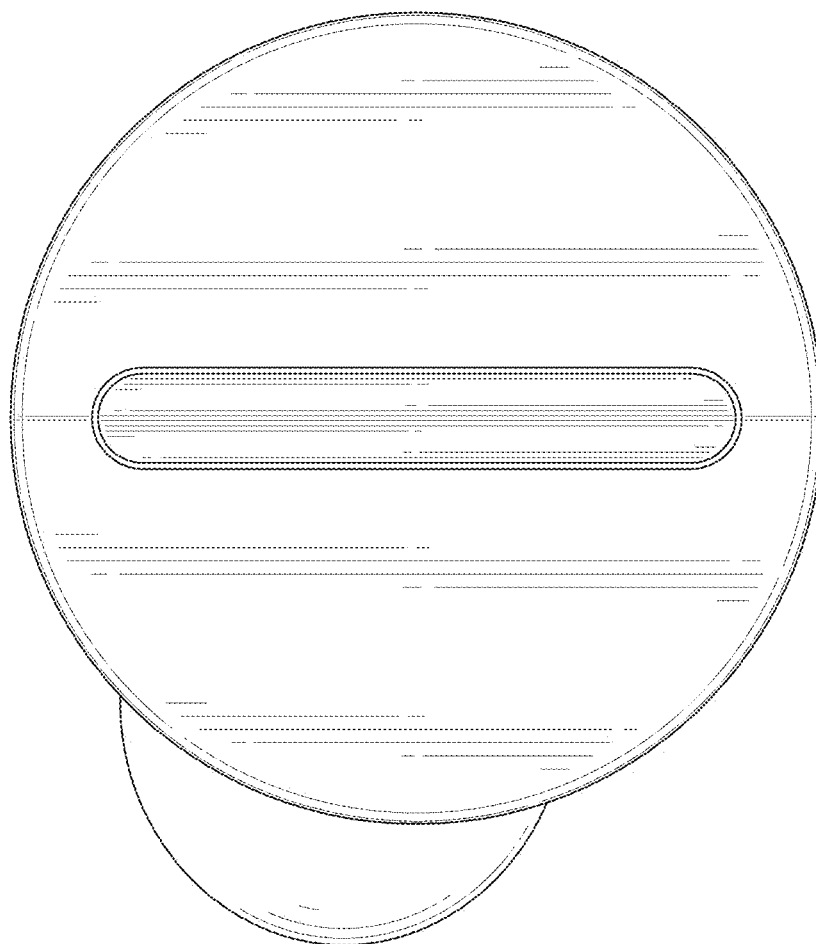

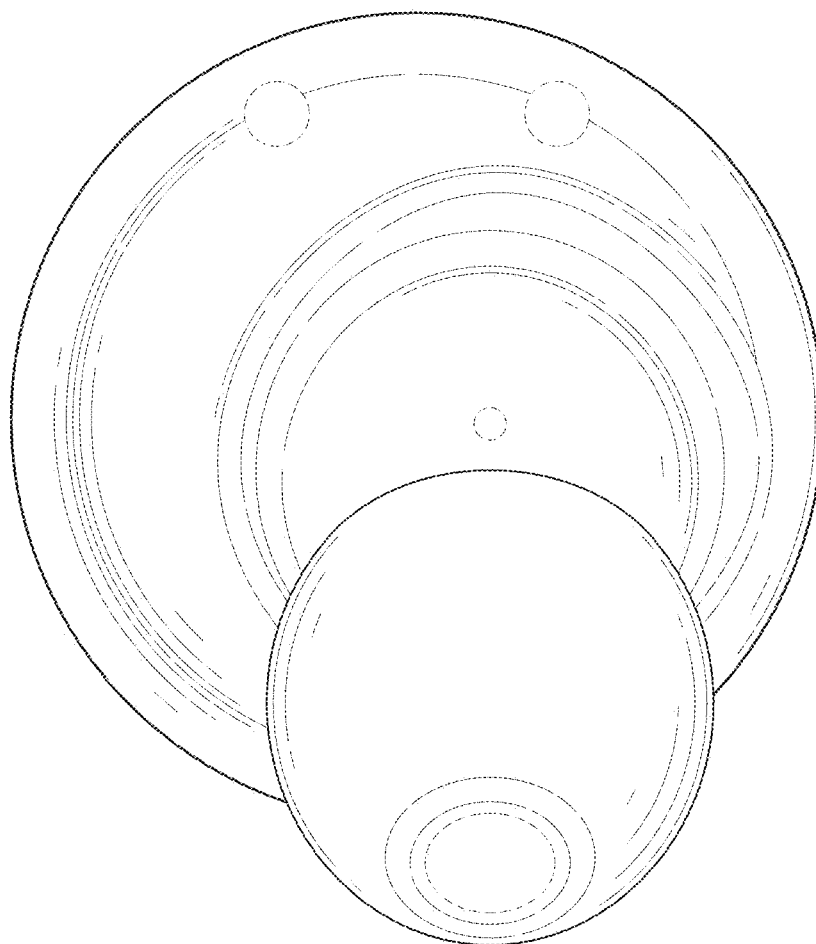

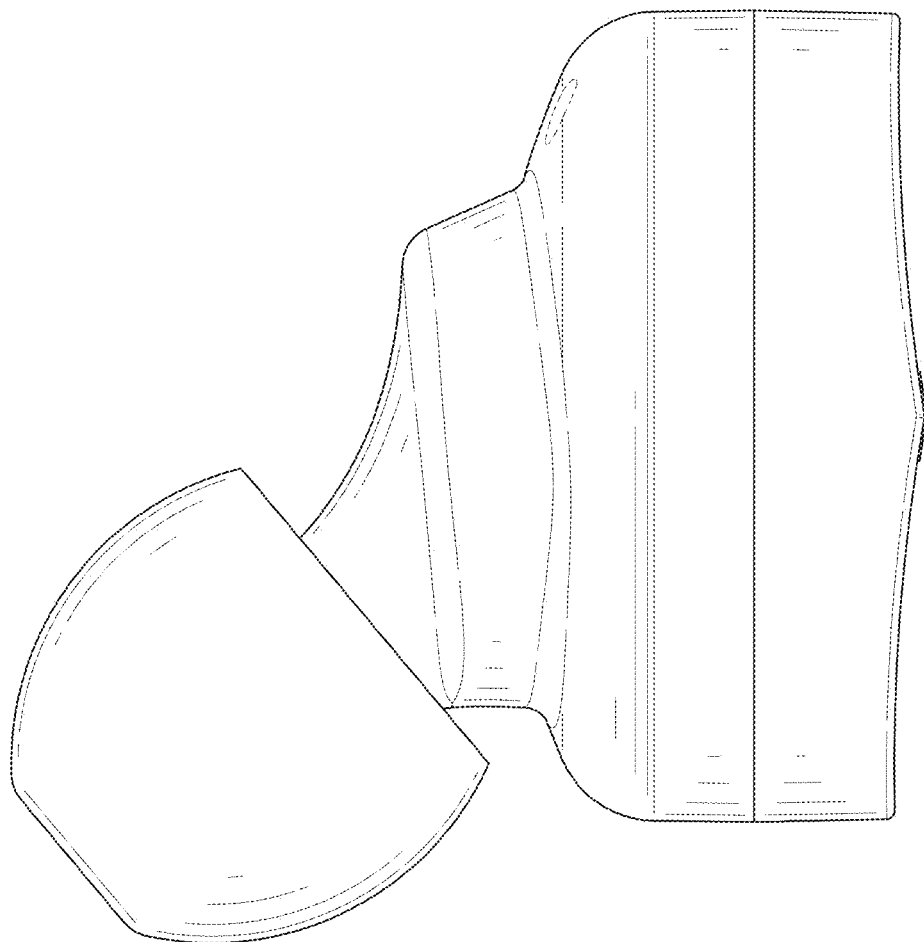

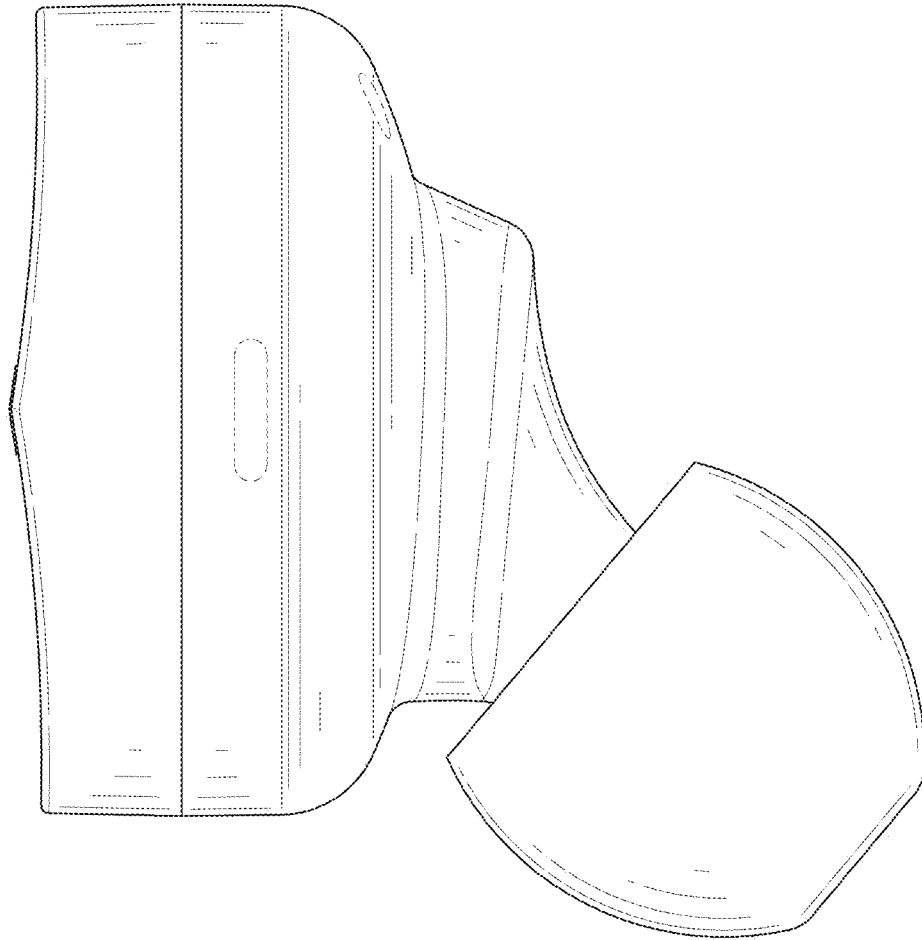

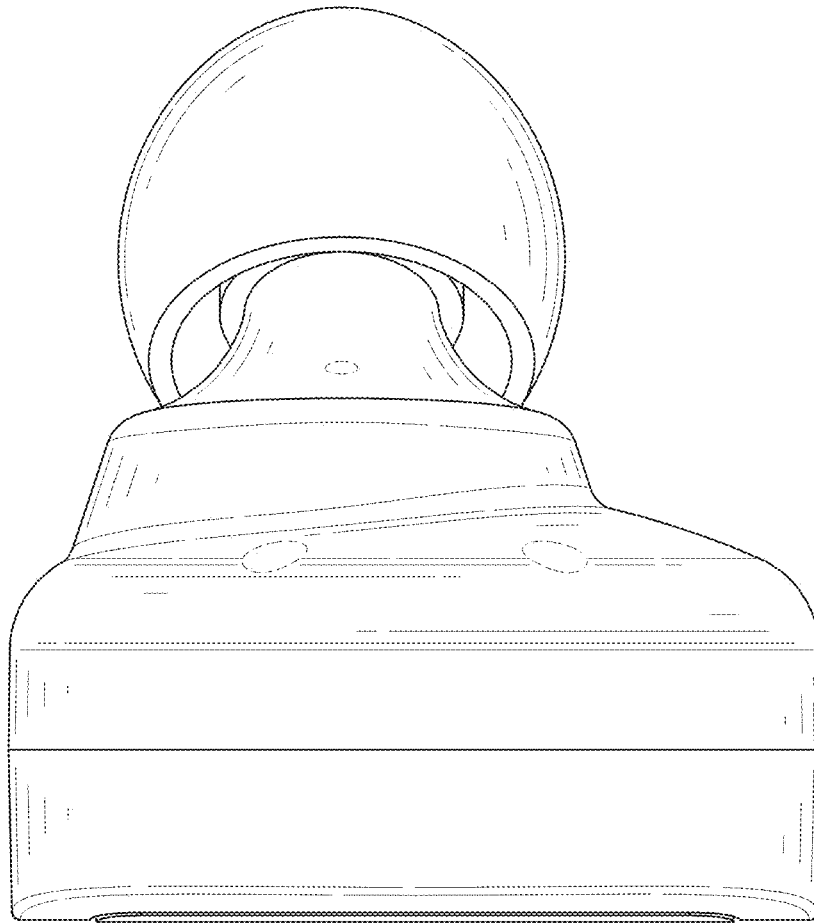

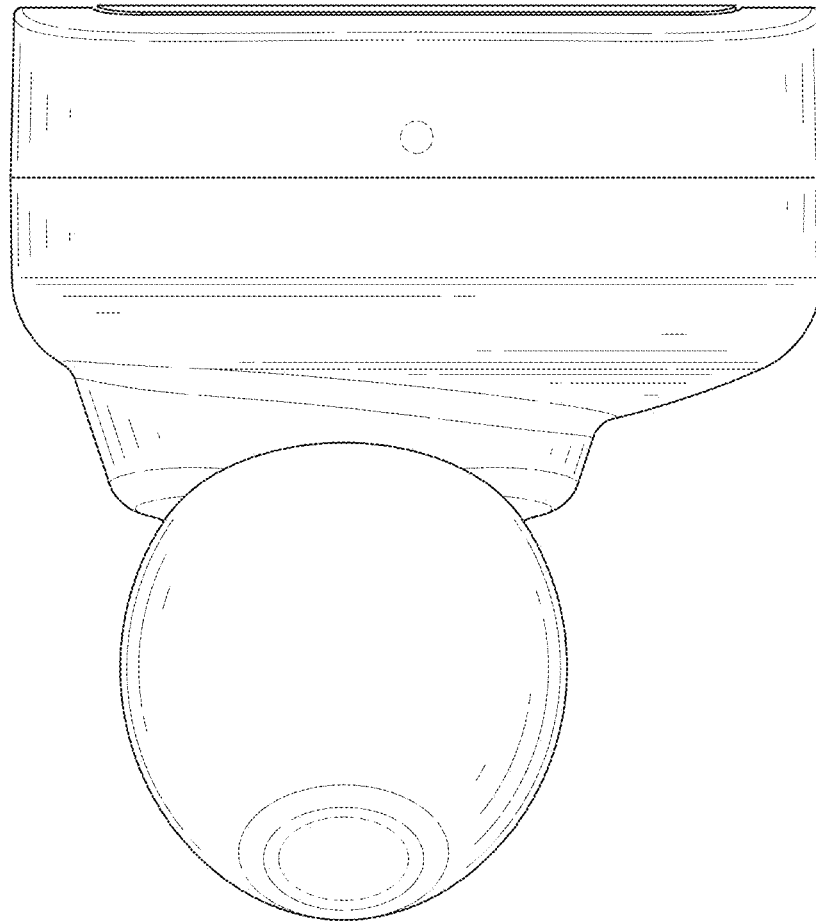
