[57] **CLAIM**

The ornamental design for a boot footbed, described and shown.

**DESCRIPTION**

FIG. 1 is an elevational view of the medial (right) side of the footbed showing my new design and according to the present invention;

FIG. 2 is an elevational view of the lateral (left) side of the footbed shown in FIG. 1;

FIG. 3 is a top plan view of the footbed shown in FIG. 1;

FIG. 4 is a bottom plan view of the footbed shown in FIG. 1;

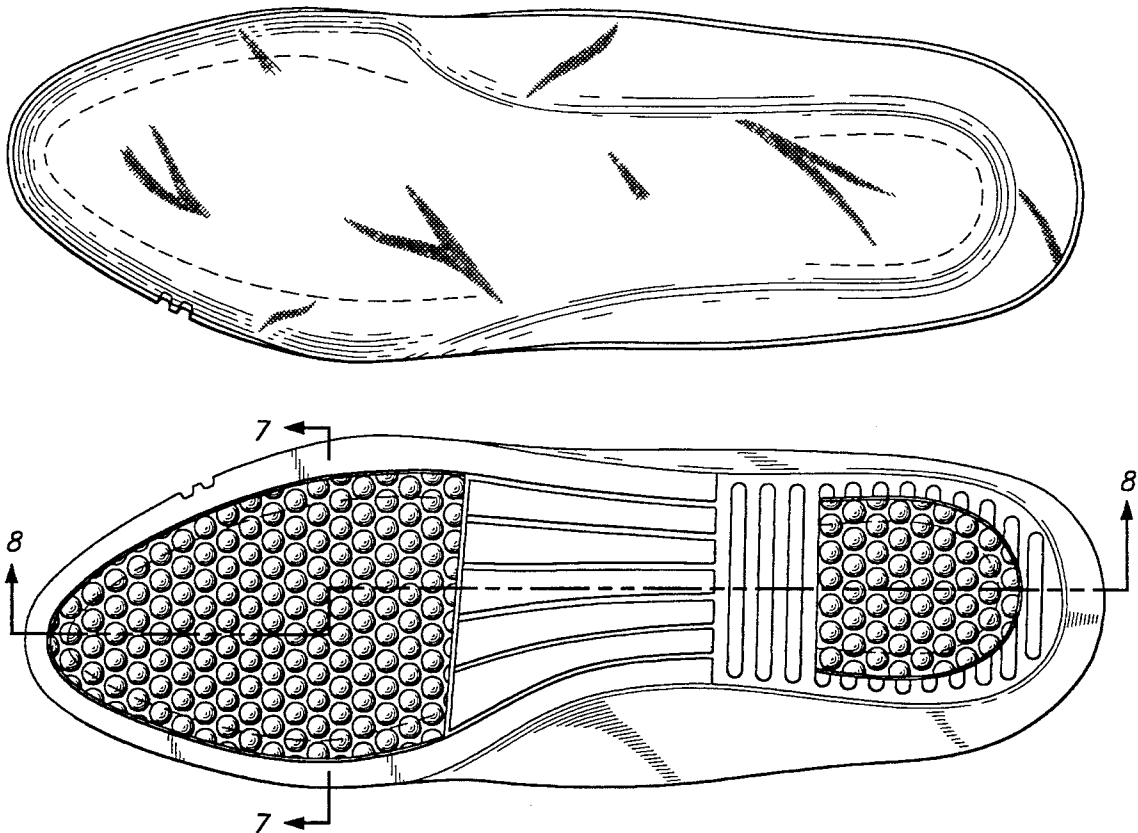
FIG. 5 is an front elevational view of the footbed shown in FIG. 1;

FIG. 6 is a back side elevational view of the footbed shown in FIG. 1;

FIG. 7 is a sectional view of the footbed bottom taken along line 7—7 of FIG. 1; and,

FIG. 8 is a sectional view of the footbed bottom taken along line 8—8 of FIG. 1.

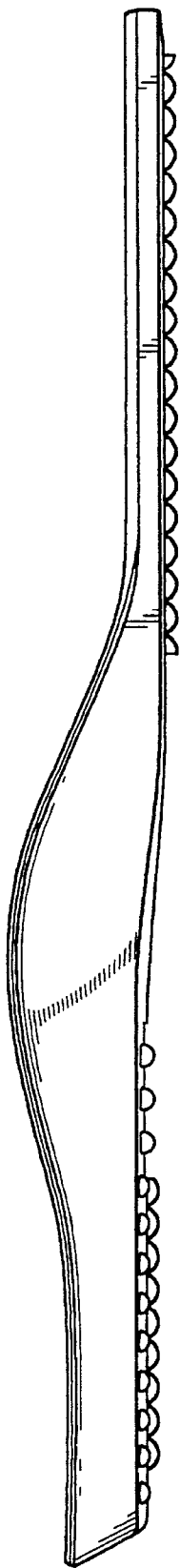

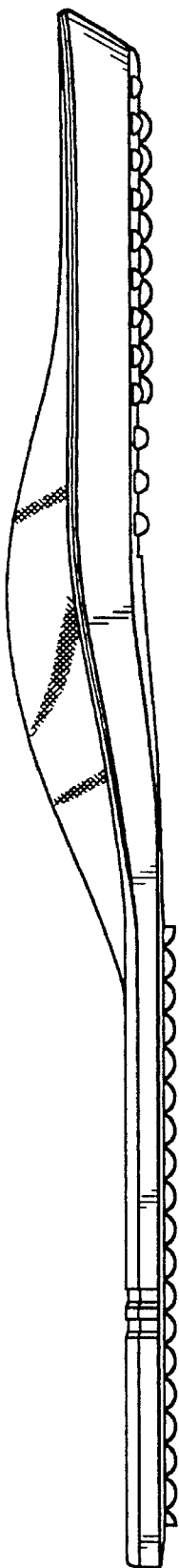

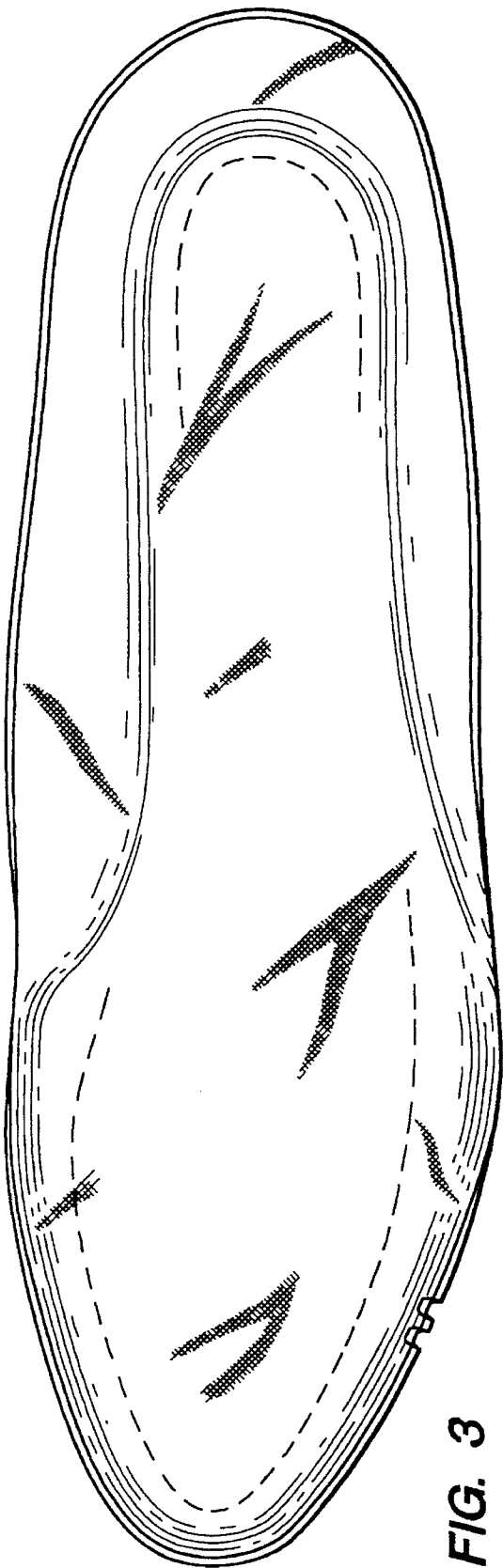

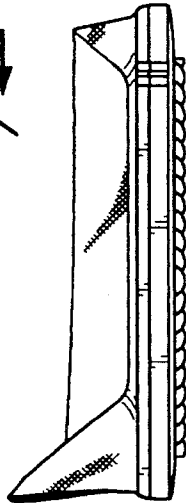
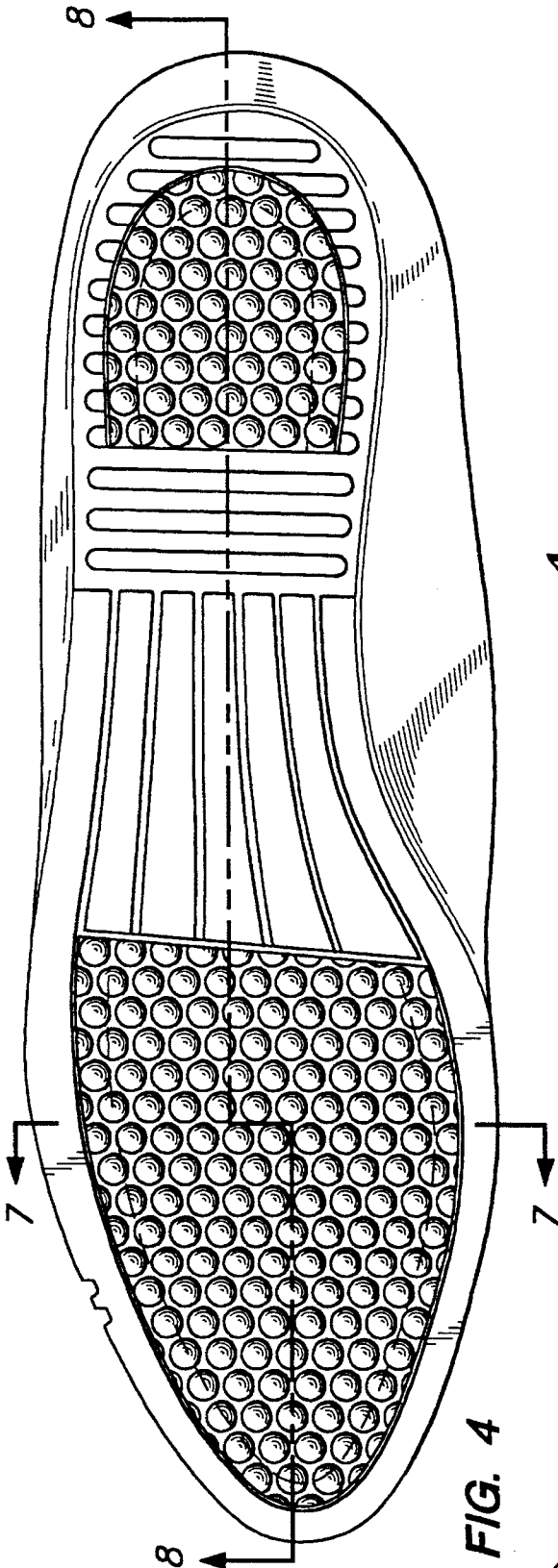

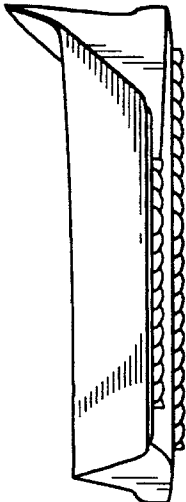

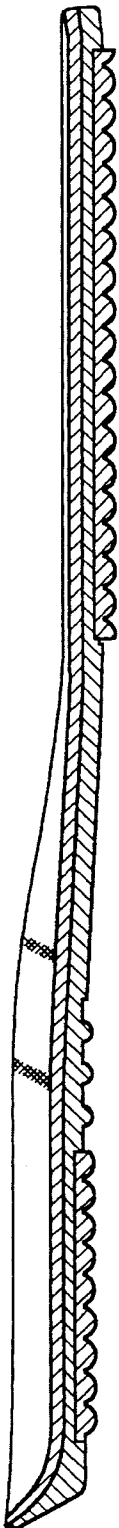
