(57) **CLAIM**

The ornamental design for a watercraft lift beam as shown and described.

**DESCRIPTION**

FIG. 1 is a top rear perspective view of a watercraft lift beam showing our new design.  
FIG. 2 is a bottom front perspective view thereof.  
FIG. 3 is a left side elevational view thereof.  
FIG. 4 is a right side elevational view thereof.  
FIG. 5 is a rear elevational view thereof.  
FIG. 6 is a front elevational view thereof.  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
The broken lines depict portions of the watercraft lift beam that form no part of the claimed design.








