(57) **CLAIM**


The ornamental design for a communication equipment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a communication equipment with antennas in a first position; FIG. 2 is a front view of the communication equipment of FIG. 1 with antennas in a second position; FIG. 3 is a rear view thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a top view thereof; FIG. 6 is a right side view thereof; and, FIG. 7 is a left side view thereof.














