(57) **CLAIM**

The ornamental design for a mug handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mug handle showing the design, with a mug illustrated in dashed lines to illustrate one example of the mug handle in context;

FIG. 2 is a side view of the mug handle illustrated in FIG. 1, again showing a mug in dashed lines to illustrate one example of the mug handle in context;

FIG. 3 is an opposite side view of the mug handle thereof;


FIG. 4 is a rear view of the mug handle thereof;












