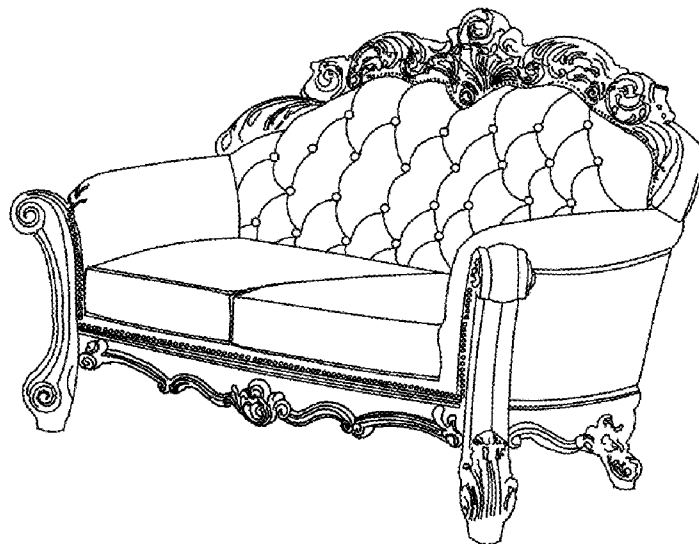
CLAIM

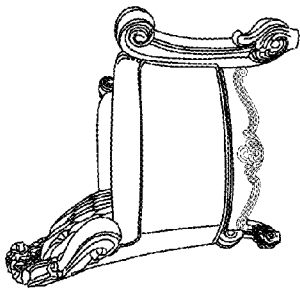

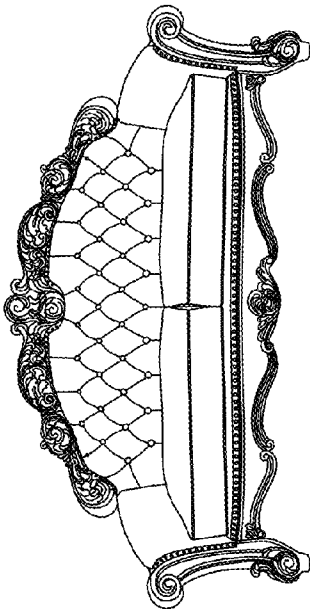

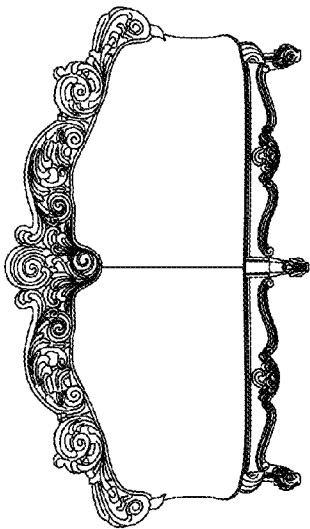

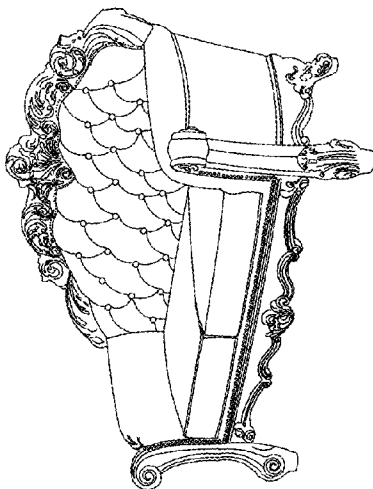
