(57) **CLAIM**

The ornamental design for the cover for hair clippers, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of the cover for hair clippers showing our new design.

FIG. 2 is a front end view of the cover for hair clippers shown in FIG. 1;

FIG. 3 is a back end view of the cover for hair clippers shown in FIG. 1;

FIG. 4 is a left side view of the cover for hair clippers shown in FIG. 1;

FIG. 5 is a right side view of the cover for hair clippers shown in FIG. 1;

FIG. 6 is a top view of the cover for hair clippers shown in FIG. 1; and

FIG. 7 is a bottom view of the cover for hair clippers shown in FIG. 1.

FIG. 11 is a left side view of the cover for hair clippers shown in FIG. 8;


FIG. 12 is a right side view of the cover for hair clippers shown in FIG. 8;




























