DESCRIPTION

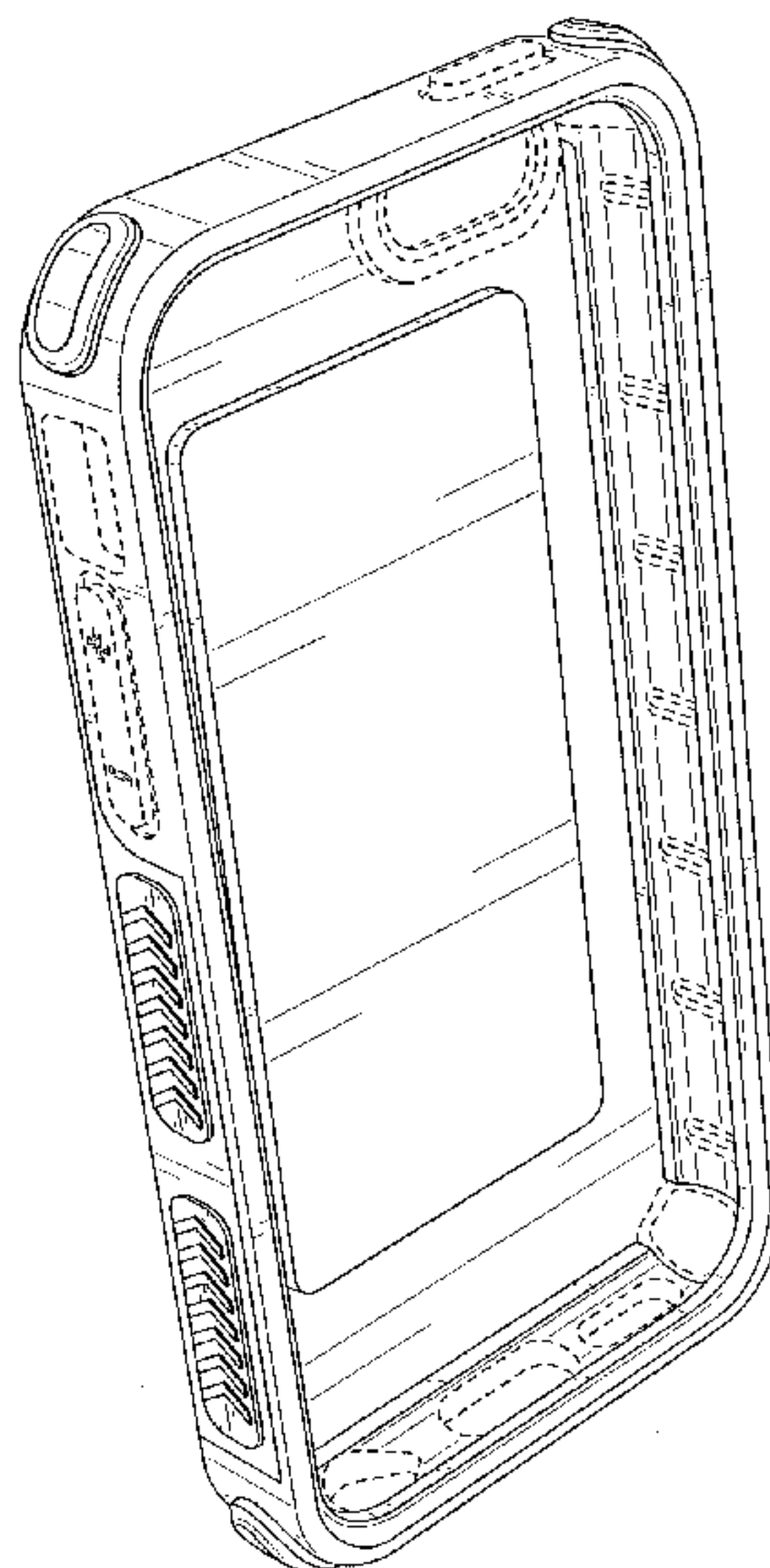
FIG. 1 is a front perspective view of a case for mobile phone

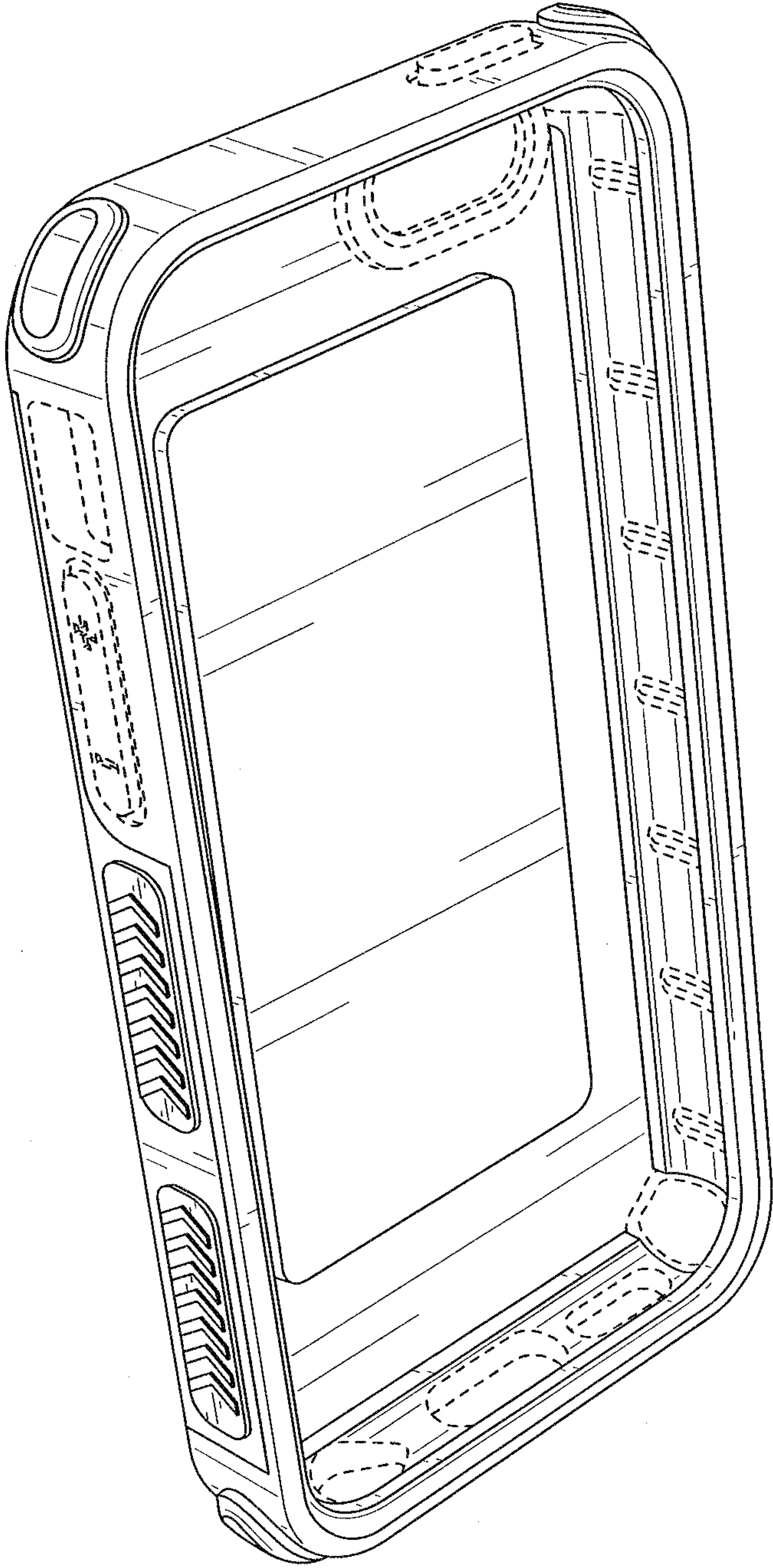

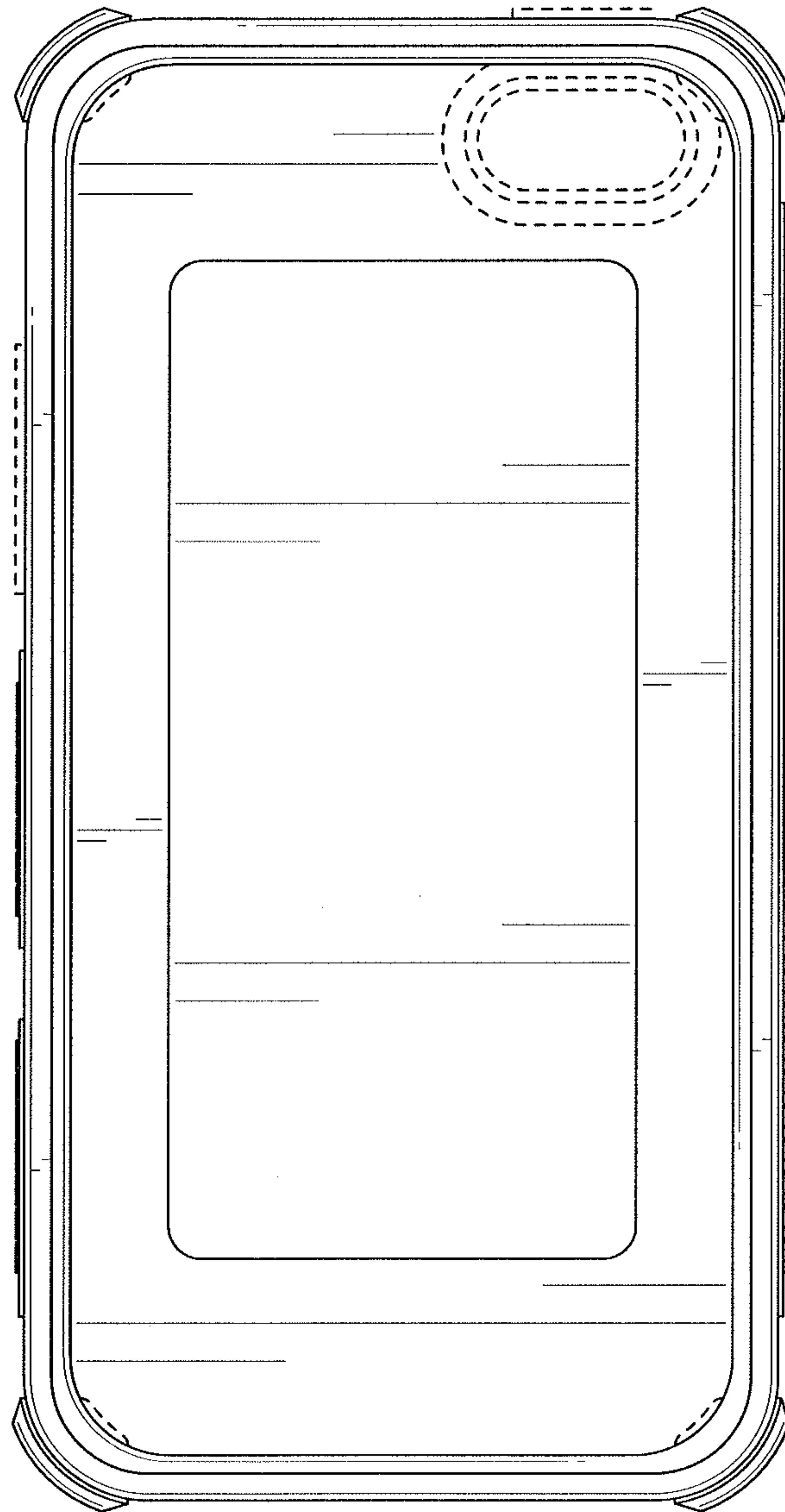

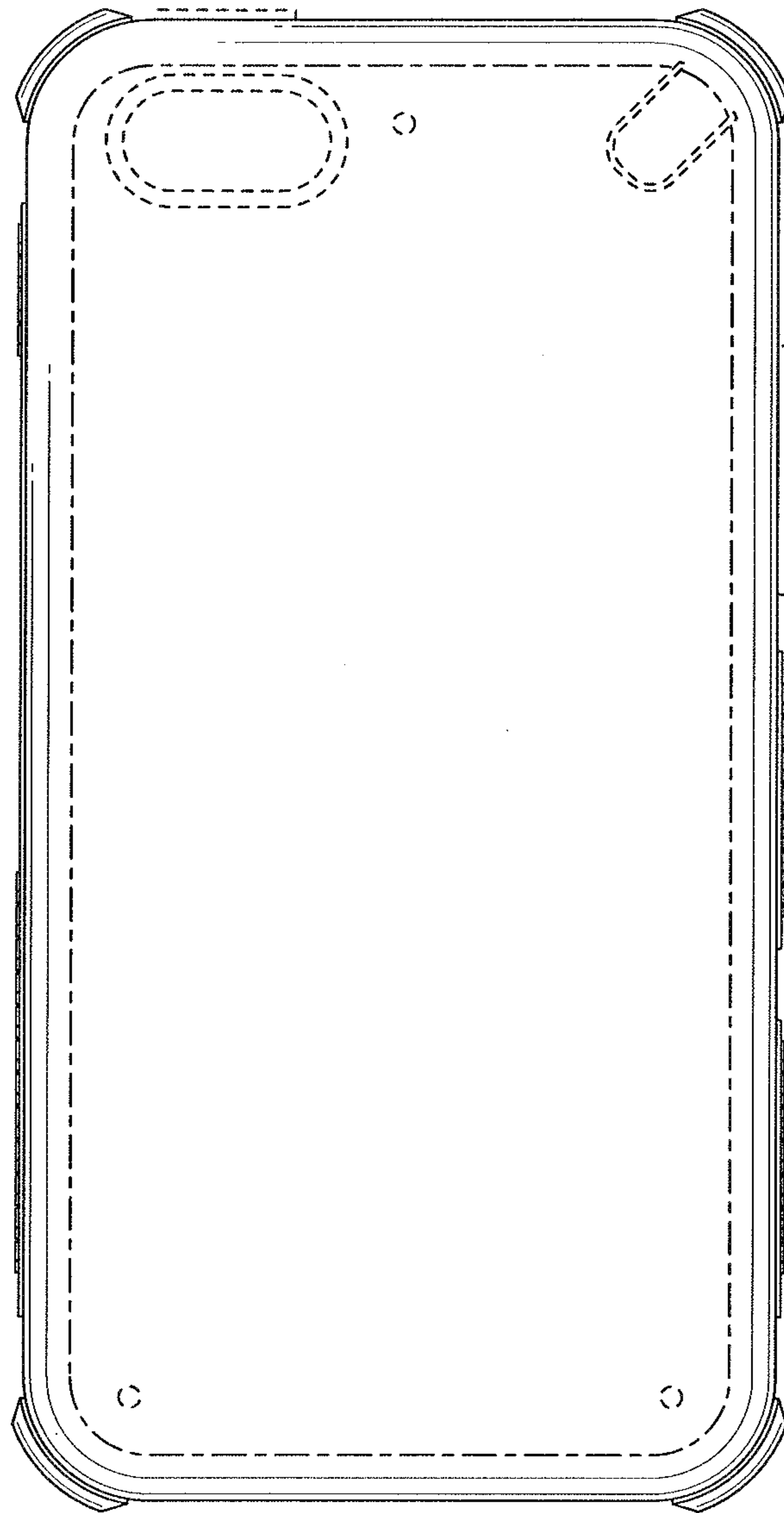

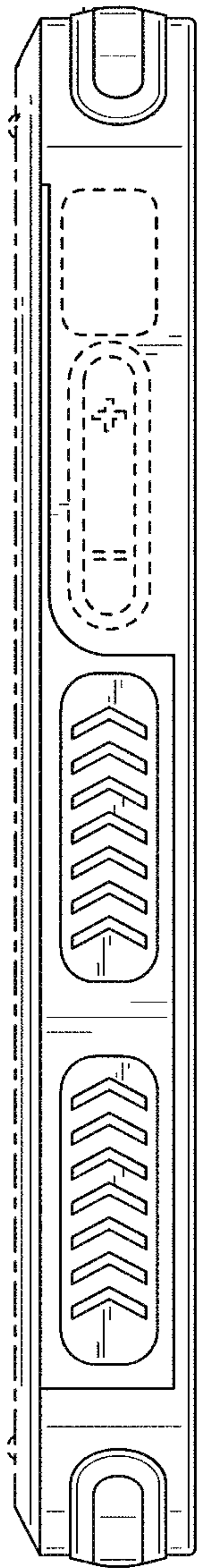

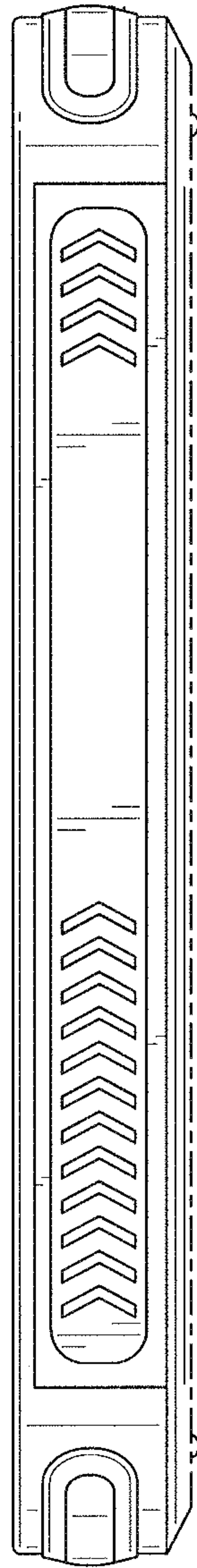

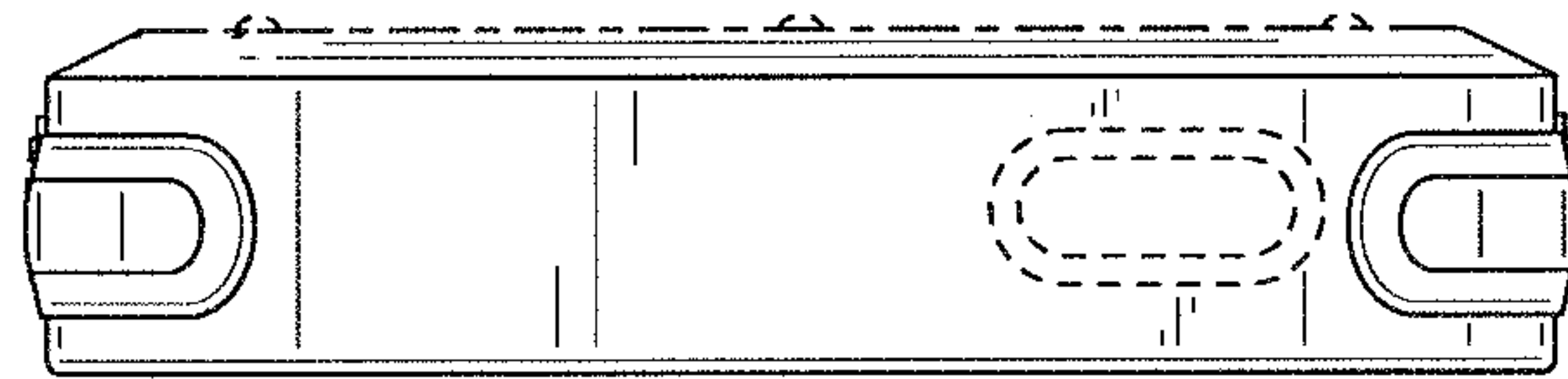

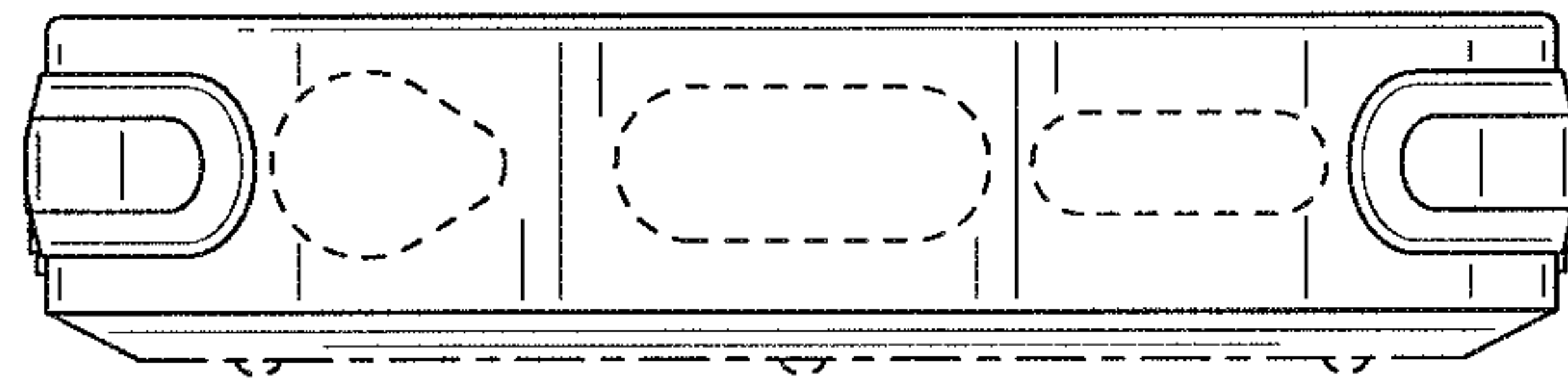
