FIG. 1 is an exploded perspective view of a clear rain boot with interchangeable liner, showing my new design;

FIG. 2 is a front elevational view of the clear rain boot;

FIG. 3 is a rear elevational view thereof, illustrated with the interchangeable liner inserted therein, the interchangeable liner in a folded position;

FIG. 4 is a left-side elevational view thereof, the interchangeable liner in the folded position;

FIG. 5 is a right-side elevational view thereof, the interchangeable liner in a straightened position;

FIG. 6 is a top plan view thereof, the interchangeable liner in the folded position;

FIG. 7 is a bottom plan view thereof, the interchangeable liner in the folded position;

FIG. 8 is a bottom plan view of the interchangeable liner; and, FIG. 9 is an exploded rear elevational view of the design.

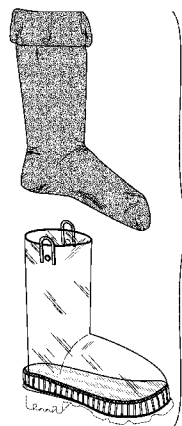
The broken lines representing a boot sole in the figures are for environmental purposes only and form no part of the claimed design.

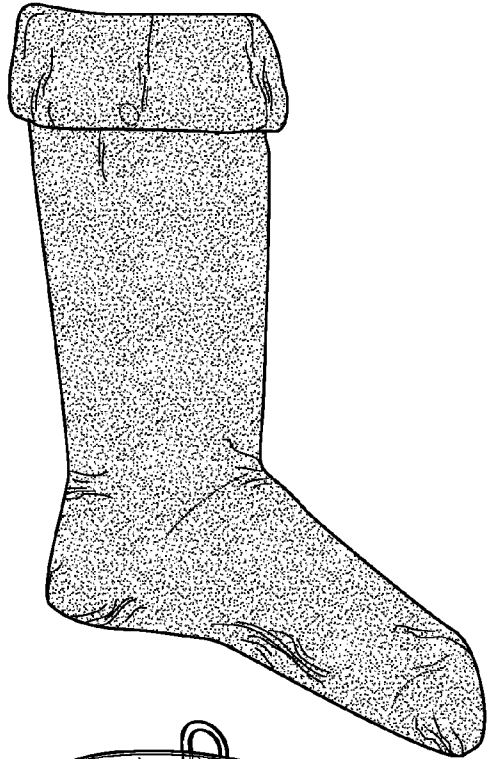

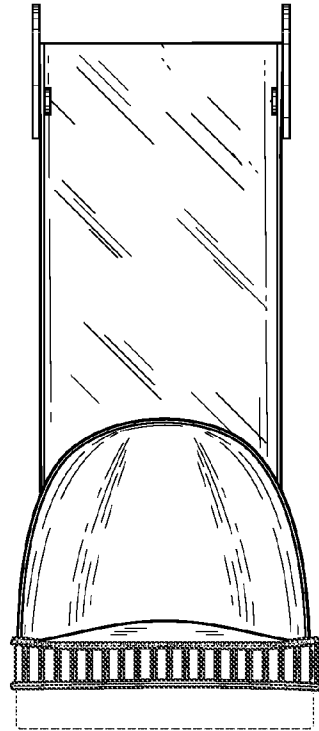

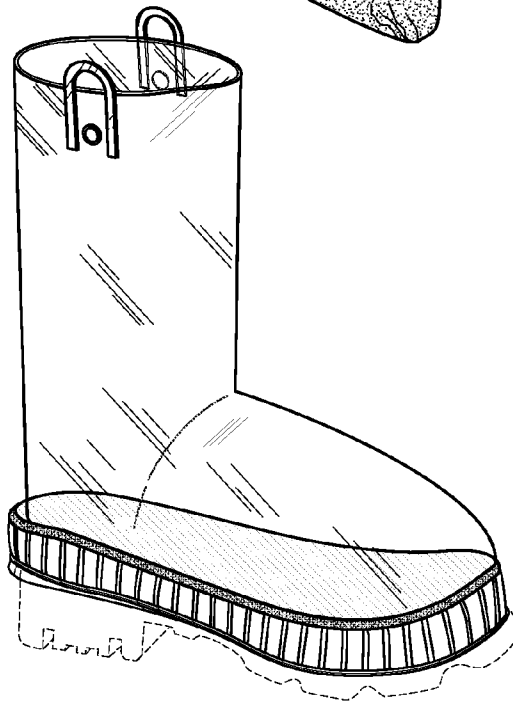

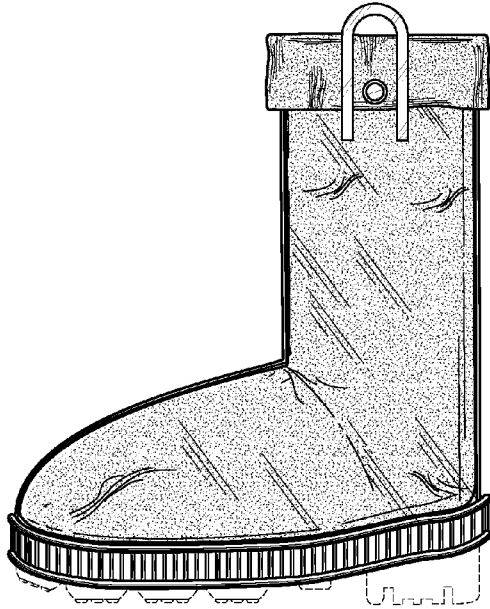

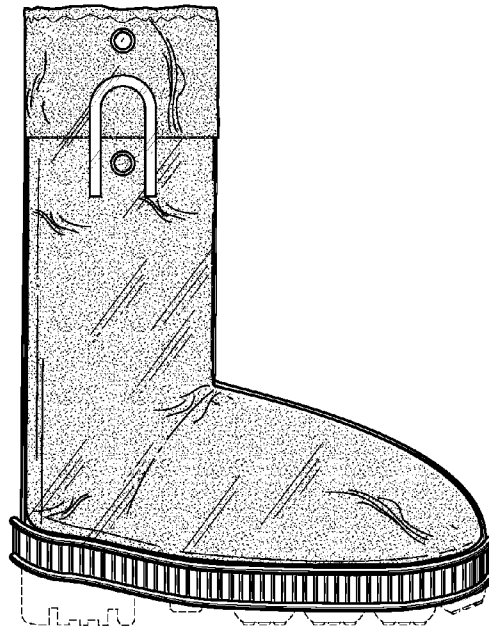

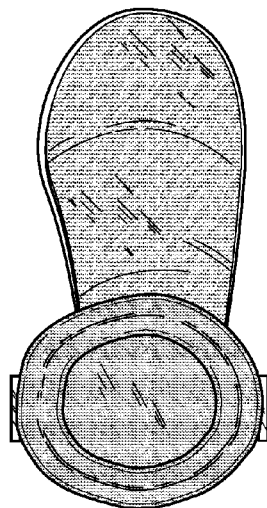

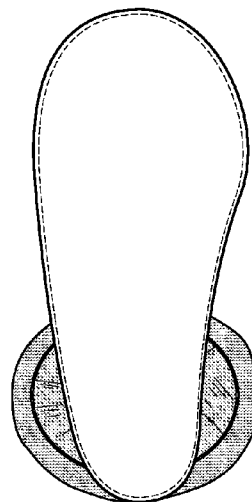

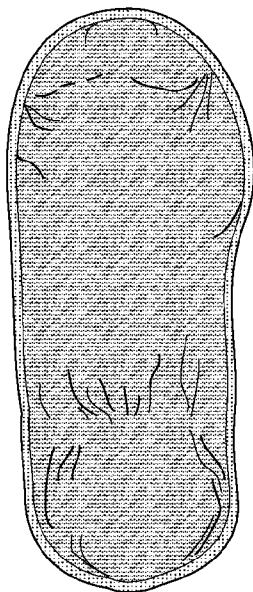

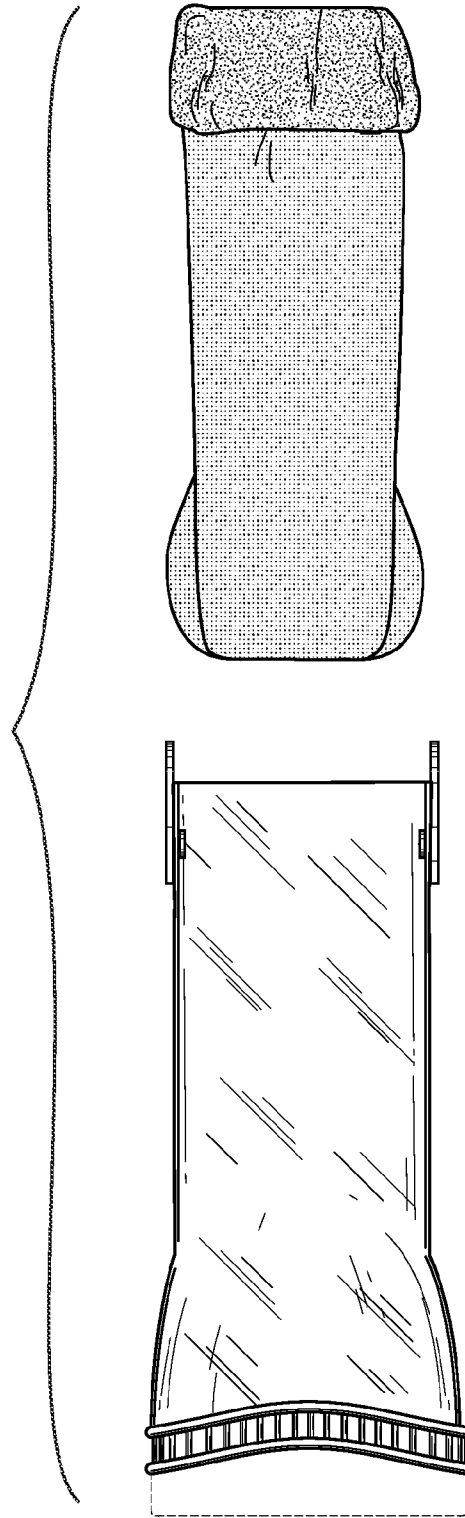
