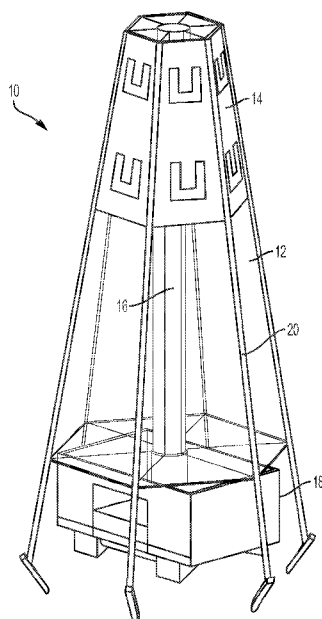

(57) Abstract: A portable radar system is disclosed including a mast, a fabric enclosure being sized and dimensioned to be extendable in a covering relation with at least part of the mast; and an antenna comprising at least one element, wherein said antenna is arranged on the fabric enclosure and is positioned to illuminate or receive reflections from a target when the fabric enclosure is in a covering relation with the mast and the mast is deployed.

## LIGHT WEIGHT SYSTEM TO LOCATE ENEMY ARTILLERY, MORTAR, AND ROCKET FIRE

### CROSS-REFERENCE TO RELATED APPLICATIONS

[0001] The present application claims priority to and the benefit of U.S. Provisional Patent Application Number 62/354260, filed on June 24, 2016, the entire contents of which are hereby incorporated by reference.

### GOVERNMENT FUNDING

[0002] This invention was made with Government support under US Government RFI # N0016413SNB02. The United States Government has certain rights in the invention.

### FIELD OF INVENTION

[0003] The present invention is directed to radar systems and, more particularly, to portable radar systems.

### BACKGROUND

[0004] Counter-mortar radar systems are widely used in combat situations to immediately locate and return fire on sites from which mortars are being fired. To protect sites that must be deployed as well as moved quickly, counter-mortar radar systems must be lightweight, easily transportable, and easily configured. Many of the current systems are heavy, vehicle-mounted, or require a prolonged assembly period. Accordingly, there is a need in the art for lightweight, quickly-deployed counter mortar radar that may be transported, deployed, operated by a single user.

### SUMMARY

[0005] This need in the art is addressed by a lightweight portable radar system including a collapsible fabric enclosure including at least one antenna element. In an embodiment, the portable radar system may further include a collapsible mast to which the fabric enclosure may be attached.

[0006] According to an aspect, a portable radar system includes a fabric enclosure being sized and dimensioned to be extendable in a covering relation with at least

part of the mast; and an antenna comprising at least one element, wherein said antenna is arranged on the fabric enclosure and is positioned to illuminate or receive reflections from a target when the fabric enclosure is in a covering relation with the mast and the mast is deployed.

[0007] According to an embodiment, the mast is collapsible.

[0008] According to an embodiment, the mast is collapsible by rolling.

[0009] According to an embodiment, the portable radar system further includes a plurality of tethers, each tether being configured to be mounted at a first end to the mast and at a second end to a surface lower than the first end.

[0010] According to an embodiment, the fabric enclosure defines a plurality of channels, each being sized to receive a respective tether of the plurality of tethers.

[0011] According to an embodiment, a plurality of poles, each pole being configured to be mounted at a first end to the mast and at a second end to a surface lower than the first end, such that the poles form a frame about the mast.

[0012] According to an embodiment, the portable radar system further includes a plurality of outriggers, each of the plurality of outriggers extending radially from the mast.

[0013] According to an embodiment, the plurality of outriggers each provide a surface for mounting a respective second end of each tether of the plurality of tethers.

[0014] According to an embodiment, the fabric enclosure is configured to form a plurality of planes, each plane including at least one antenna element.

[0015] According to an embodiment, each plane of the plurality of planes is substantially trapezoidal.

[0016] According to an embodiment, the fabric enclosure is substantially conical when in a covering relation with said mast.

[0017] According to an embodiment, the portable radar system further includes a base configured to retain the mast in a substantially upright position.

[0018] According to an embodiment, the at least one antenna element is arranged on the fabric enclosure as an eTextile.

[0019] According to an embodiment, the portable radar system further includes a processor (24) configured to receive signals received by the at least one antenna element.

[0020] A portable radar system, comprising: a mast; and a fabric substrate being mounted to the mast, the fabric substrate including an antenna comprising at least one element, wherein said antenna is arranged on the fabric substrate and is positioned to illuminate or receive reflections from a target when the fabric substrate is mounted to the mast.

#### BRIEF DESCRIPTION OF THE DRAWINGS

[0021] The present invention will be more fully understood and appreciated by reading the following Detailed Description in conjunction with the accompanying drawings, in which:

[0022] FIG. 1 shows a perspective view of a portable radar system, according to an embodiment.

[0023] FIG. 2 shows a top view of a portable radar system, according to an embodiment.

[0024] FIG. 3 shows a top view of a portable radar system, according to an embodiment.

[0025] FIG. 4 shows a perspective view of non-deployed portable radar system, according to an embodiment.

[0026] FIG. 5 shows a radar architecture, according an embodiment.

[0027] FIG. 6 shows a side view of a portable radar system, according to an embodiment.

#### DETAILED DESCRIPTION

[0028] Referring now to the drawings, there is shown in FIGs. 1 and 2 a schematic of a portable radar system 10 according to an embodiment. As shown, portable radar system 10 may include a fabric enclosure 12 that may comprise one or more antenna elements 14 configured to transmit and/or receive radar signals. The antenna elements 14 may be arranged on fabric enclosure 12 such that fabric enclosure 12 may be folded in one or more places to allow for easy storage and transportation. Fabric enclosure 12 may be erected about a frame such that the antenna elements 14 of fabric enclosure 12 are advantageously positioned to illuminate, and receive reflections from, an airborne or ground-based target.

[0029] Antenna elements 14 may be comprised of any type of elements as are known in the art and suitable for attaching to fabric enclosure 12 and for transmitting and

receiving. For example, antenna elements 14 may each be formed from a dipole (as shown in FIG. 6), or, as shown in FIGs. 1 and 2, a patch element. Antenna elements 14 may be integrated directly into the fabric as an eTextile or may be sewn, laminated, glued, or otherwise applied to the surface of fabric enclosure 12. In an embodiment, radar system 10 may include only a single antenna element.

**[0030]** Frame may be configured to collapse, disassemble, or otherwise break down for easy storage and assembly. In an embodiment, as shown in FIG. 1, frame comprises a mast 16. Mast 16 may be stood substantially upright, and may be extendable between various heights. As shown in FIGs 1 and 2, in an embodiment, mast 16 may extend from a base 18. Base 18 may be a backpack (or other portable container) which can store the collapsed or disassembled parts of portable radar system 10, when radar system 10 is being transported, stored, or is otherwise non-deployed. In an alternate embodiment, base 18 may be a separate base that may itself be collapsed or otherwise detached from mast 16 and stored in a backpack or elsewhere. Mast 16 may be collapsible so that it may be easily stored and transported. For example, mast 16 may be made from Rolatube—available from Rolatube Technology—with, a 2” diameter (although other diameters may be used), such that a user may roll up mast 16 when system 10 is not deployed.

**[0031]** Mast 16 may also include a plurality of tethers (e.g. nylon ropes, wire ropes, etc.) that extend radially outward from mast 16. Tethers 20 may be connected to ground or another surface. For example, tethers 20 may extend from mast 16 down to ground, where each may be attached with stakes or another fastening implement suitable for attaching tethers 20 to the ground or another surface or feature (e.g., a hook or ring fastened to the ground or floor). In an alternate embodiment, a plurality of outriggers 22 may extend radially outward from mast 16, to which tethers 20 may be fastened. For example, a plurality of outriggers 22 may extend from or near the bottom of mast 16, while a plurality of tethers 20 may extend from a point above the outriggers (e.g. near or at the top of mast 16) and may extend radially out and down from mast 16, attaching to outriggers instead of the ground. In an alternate embodiment, frame may include poles that are rigid or semi-rigid. Such poles may be collapsible or may be disassembled (e.g., like tent poles) for ease of storage and transportation. Poles may be attached like tethers 20 to mast 16, extending radially outward and downward to form a conical frame.

**[0032]** Fabric enclosure 12 may be sized and dimensioned to at least partially fit over frame when deployed. For example, as shown in FIG. 1, fabric enclosure 12 may be

sized and dimensioned to fit over collapsible mast and tethers 20 (or poles) to form a generally conical shape. For example, as shown, fabric enclosure 12 may be sized to stretch over collapsible mast 16 and tethers 20 such that enclosure 12 forms a plurality of flat, trapezoidal, planes, with each antenna element embedded in one of the flat planes. One of ordinary skill will appreciate that enclosure 12 may be sized to form any of a number of shapes, according to the shape and configuration of collapsible mast 16 and tethers 20 (or poles) and according to the desired shape of deployed radar system 10. In an embodiment, tethers 20 may not be connected to mast 16, but instead may be interconnected with enclosure 12 (e.g., via channels formed in enclosure 12), and may be deployed and broken down as a single unit. In another embodiment, tethers 20 may be both interconnected with enclosure 12 and connected to mast 16.

**[0033]** To set up system 10, in an embodiment, mast 16 may be erected such that it is substantially upright. Mast 16 may be supported by a base 18. Enclosure 12 may thereafter be slid over mast 16 and tied down using stakes or other fasteners. If tethers 20 are not interconnected with enclosure 12, tethers 20 may first be connected to mast 16 and tied down, whereupon enclosure 12 may be slide over mast 16 and tethers 20 and secured.

**[0034]** System 10 may further comprise a processor 24 that is configured to execute program code to transmit, receive, and/or process signals via antenna elements 14. System 10 may also be configured to consume sufficiently low power to be powered by a battery 26 (e.g. less than or equal to 200W of total power). System 10 may further include any cables 28 necessary to connect battery 26 to processor 24, processor 24 to antenna elements 14, or any other connections necessary to operate system 10 as will be understood by a person of ordinary skill in the art in conjunction with a review of this disclosure. Processor 24, in an embodiment, may be configured to receive commands from and be operated by a user via a computing device such as a mobile device, or a wrist wearable computer that is hard connected or wirelessly connected to processor 24. In an embodiment, processor may be operated via a screen and/or an input device (e.g., a mouse, keyboard, etc.) that is hard connected or wirelessly connected to processor 24.

**[0035]** As shown in FIG. 4, System 10 may be configured to break down such that it may fit into a backpack or similar, small space. As described above, each element may be collapsed or disassembled into smaller parts that are easy to pack and store. For example, enclosure 12 may be folded like fabric into a smaller volume shape. Mast 16 may be collapsed and coiled into a small roll. Tethers 20, if separate from enclosure 12, may be

rolled and stored. Each may be placed into a backpack, crate, or other container that may be easily transported, such that portable radar system 10 may be quickly moved and deployed. In an embodiment, radar system 10, when stored, may weigh less than 45 lbs. In an embodiment, base 18 may form the backpack itself and may be comprised of a carbon fiber frame with canvas covers.

**[0036]** As shown in FIG. 5, in an embodiment, system 10 may operate in the UHF band (420-450 MHz) such that the radar can meet power-aperture requirements with very few radiating elements. In an embodiment, six columns may be operating (two per dwell) such that system 10 directly samples RF, thus eliminating beamforming and frequency conversion components. FIG. 5 shows an embodiment of radar electronics as may be implemented in system 10. In an embodiment, radar system 10 may be configured to provide a 5km range on a 81mm mortar, although in alternate embodiments, or in the same embodiment, radar system 10 may be configured to detect other objects such as aircraft, dismounts, and vehicles.

**[0037]** The above-described embodiments of the described subject matter can be implemented in any of numerous ways. For example, some embodiments may be implemented using hardware, software or a combination thereof. When any aspect of an embodiment is implemented at least in part in software, the software code can be executed on any suitable processor or collection of processors, whether provided in a single device or computer or distributed among multiple devices/computers.

## CLAIMS

1. A portable radar system, comprising:  
a mast (16);  
a fabric enclosure (12) being sized and dimensioned to be extendable in a covering relation with at least part of the mast (16); and  
an antenna comprising at least one element, wherein said antenna is arranged on the fabric enclosure (12) and is positioned to illuminate or receive reflections from a target when the fabric enclosure (12) is in a covering relation with the mast (16) and the mast (16) is deployed.
2. The portable radar system of claim 1, wherein the mast (16) is collapsible.
3. The portable radar system of claim 2, wherein the mast (16) is collapsible by rolling.
4. The portable radar system of claim 1, further comprising a plurality of tethers (20), each tether (20) being configured to be mounted at a first end to the mast (16) and at a second end to a surface lower than the first end.
5. The portable radar system of claim 4, wherein the fabric enclosure (12) defines a plurality of channels, each being sized to receive a respective tether (20) of the plurality of tethers (20).
6. The portable radar system of claim 1, further comprising a plurality of poles, each pole being configured to be mounted at a first end to the mast (16) and at a second end to a surface lower than the first end, such that the poles form a frame about the mast (16).
7. The portable radar system of claim 1, further comprising a plurality of outriggers (22), each of the plurality of outriggers (22) extending radially from the mast (16).
8. The portable radar system of claim 7, wherein the plurality of outriggers (22) each provide a surface for mounting a respective second end of each tether (20) of the plurality of tethers (20).
9. The portable radar system of claim 1, wherein the fabric enclosure (12) is configured to form a plurality of planes, each plane including at least one antenna element.

10. The portable radar system of claim 1, wherein each plane of the plurality of planes is substantially trapezoidal.
11. The portable radar system of claim 1, wherein the fabric enclosure (12) is substantially conical when in a covering relation with said mast (16).
12. The portable radar system of claim 1, further comprising a base (18) configured to retain the mast (16) in a substantially upright position.
13. The portable radar system of claim 1, wherein the at least one antenna element is arranged on the fabric enclosure (12) as an eTextile.
14. The portable radar system of claim 1, further comprising a processor (24) configured to receive signals received by the at least one antenna element.
15. A portable radar system, comprising:
  - a mast (16); and
  - a fabric substrate (12) being mounted to the mast (16), the fabric substrate (12) including an antenna comprising at least one element, wherein said antenna is arranged on the fabric substrate (12) and is positioned to illuminate or receive reflections from a target when the fabric substrate (12) is mounted to the mast (16).

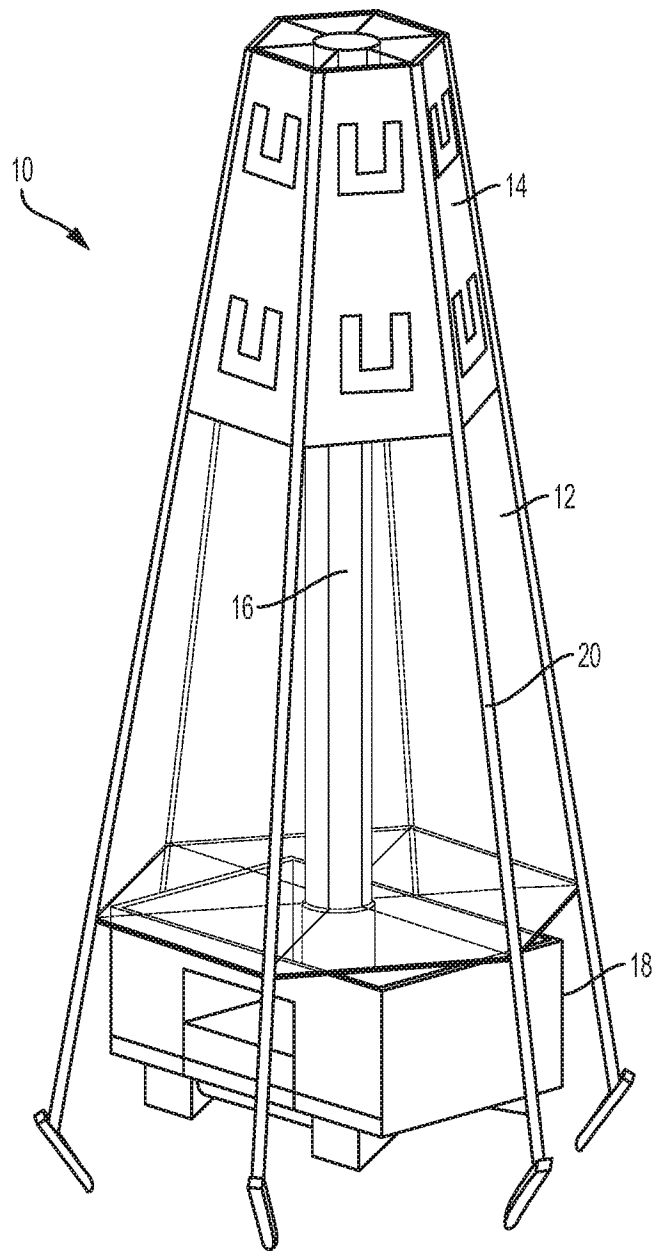

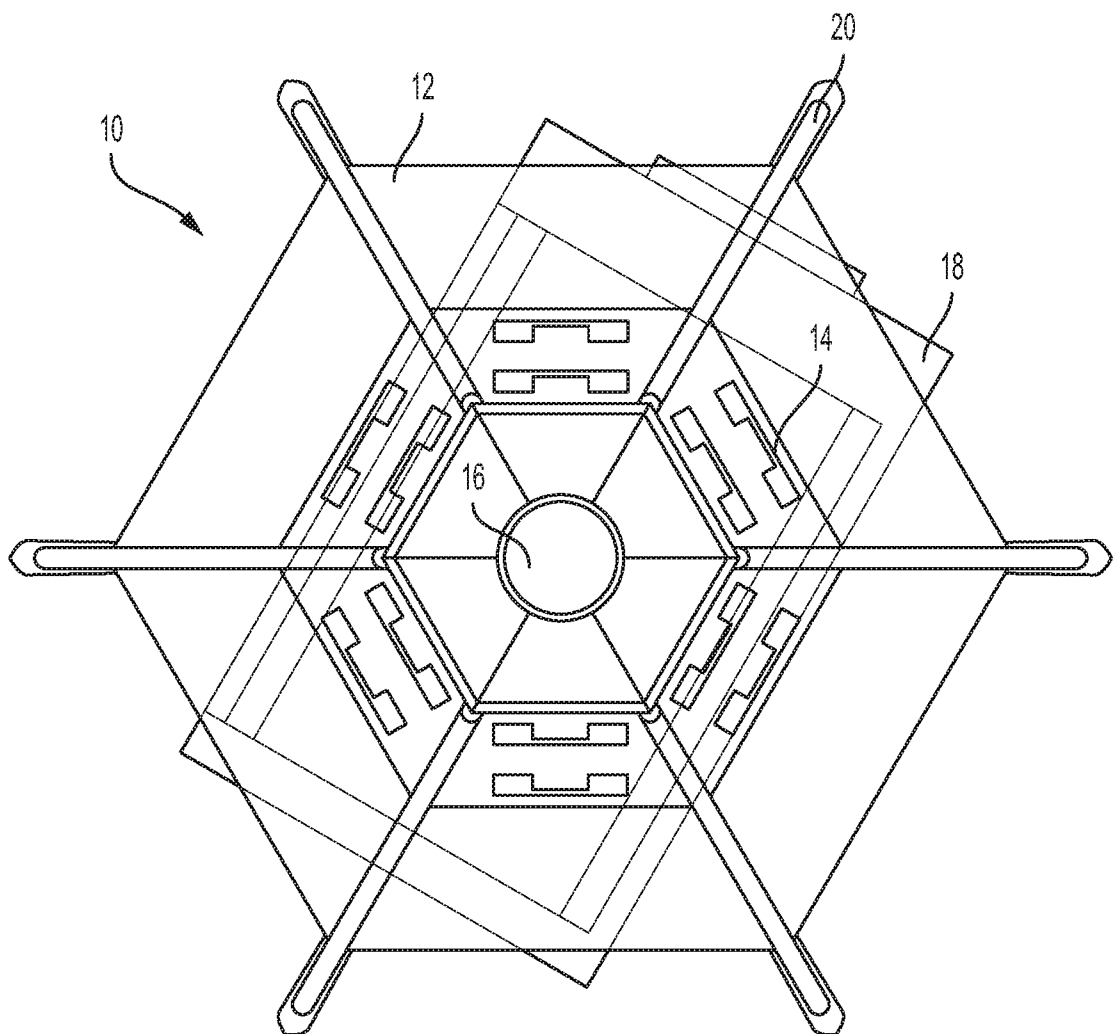

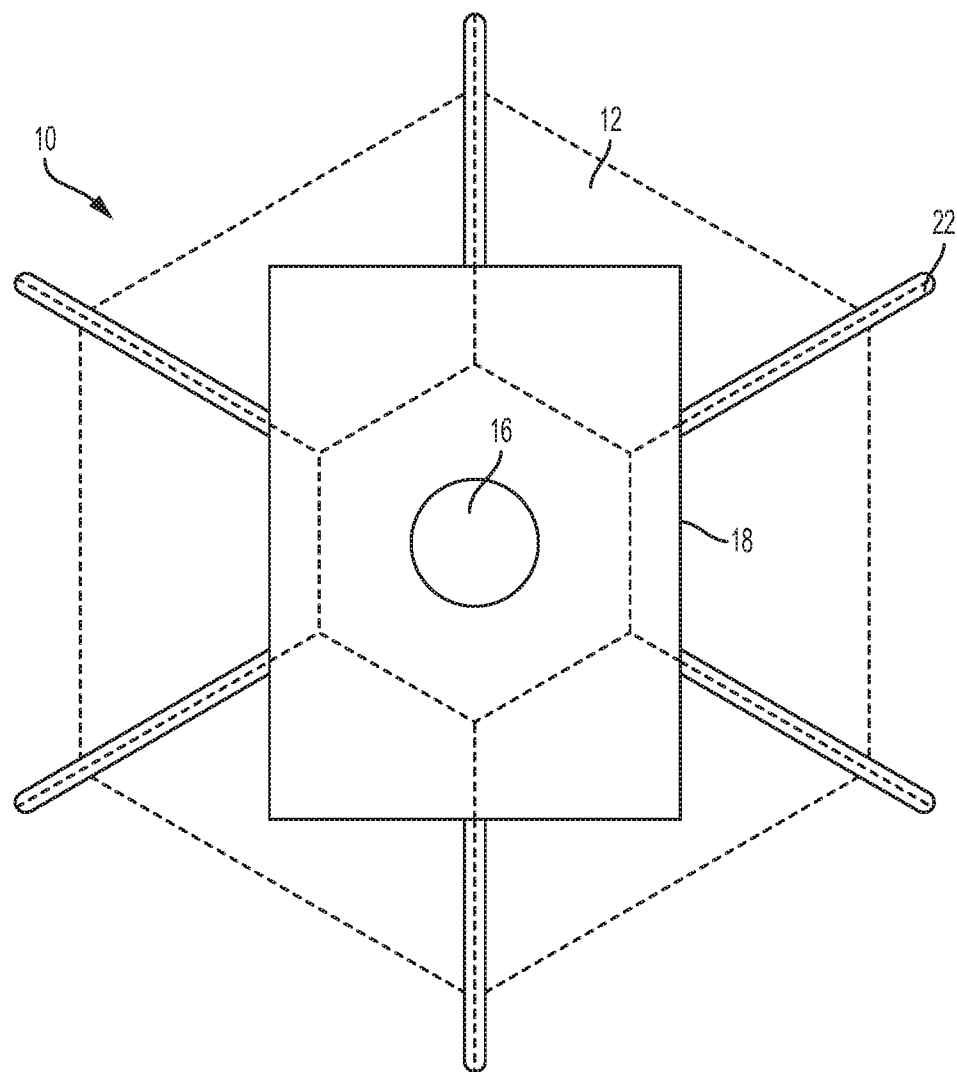

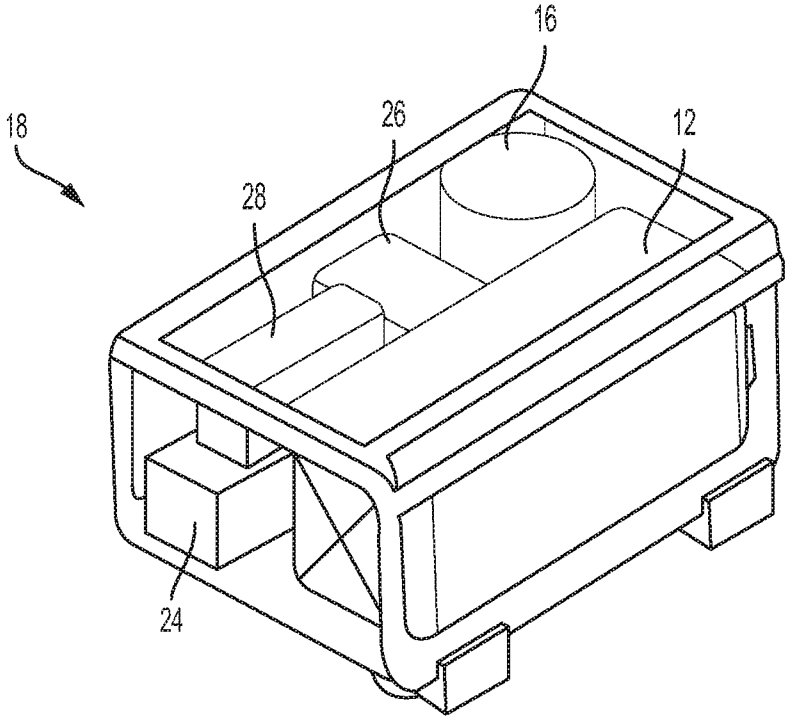

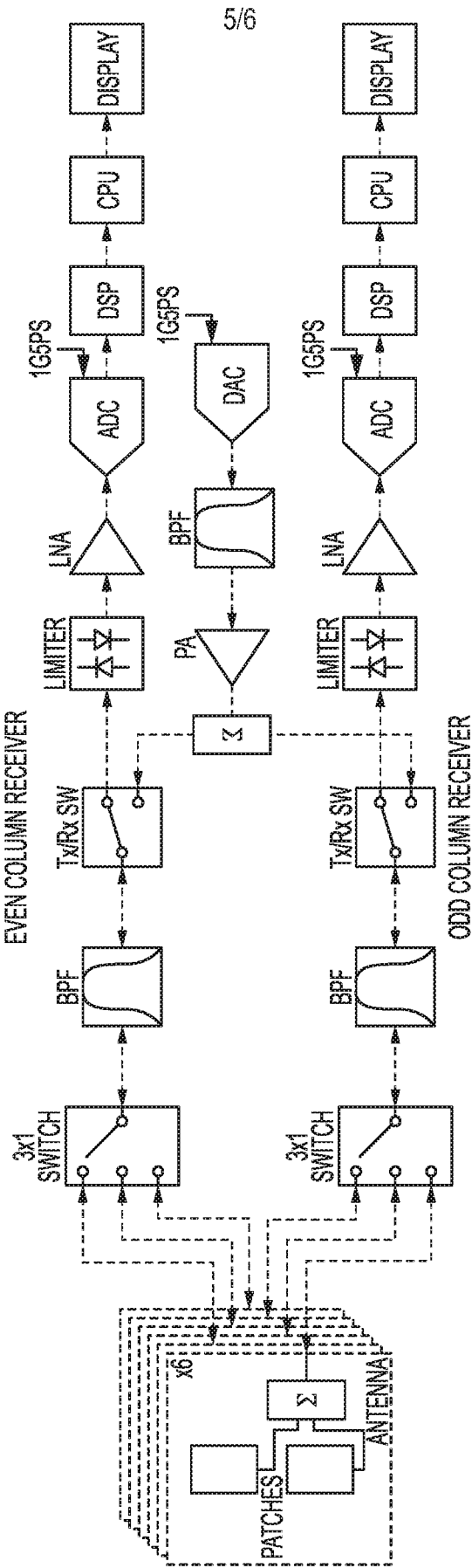

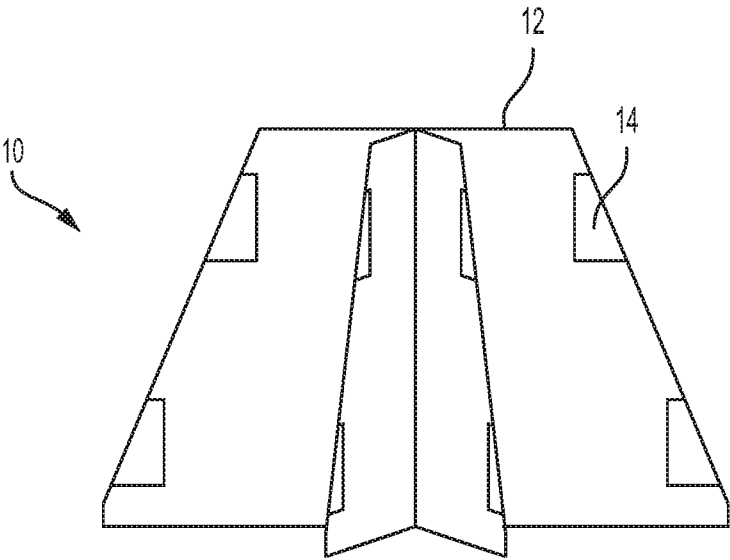
