
(57) **CLAIM**

The ornamental design for a weighted backpack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of the weighted backpack, showing my new design;
FIG. 2 is a perspective back view thereof;
FIG. 3 is a from side view thereof;
FIG. 4 is a back side view thereof;
FIG. 5 is left side view with the right side view being a mirror image thereof;
FIG. 6 is a top side view thereof;
FIG. 7 is a bottom side view thereof; and,
FIG. 8 is a perspective back view shown with the flap closed. The broken line showing of portions of the weighted backpack depicts environment and forms no part of the claim.
















