(57) **CLAIM**


The ornamental design for a blower attachment for a handheld tool, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a blower attachment for a handheld tool of the present invention;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a rear view thereof; and,
FIG. 7 is a front view thereof.














