(57) **CLAIM**

The ornamental design for a bottle and cap assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and right side perspective view of a bottle and cap assembly showing our new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a right side elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a rear elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The interior of the bottom of the bottle, as shown in FIG. 7, is shown in broken lines and forms no part of the claimed design.














