
(57) **CLAIM**

The ornamental design for an adjustable belt loop fastening device, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the new design for an adjustable belt loop fastening device;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a back view thereof;
FIG. 6 is a right side view thereof, with the left side being a mirror image of the right side;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is a perspective view thereof, shown in a closed configuration in a position of use on two belt loops.
The broken lines in the drawings depict environment that forms no part of the claimed design.














