(57) **CLAIM**

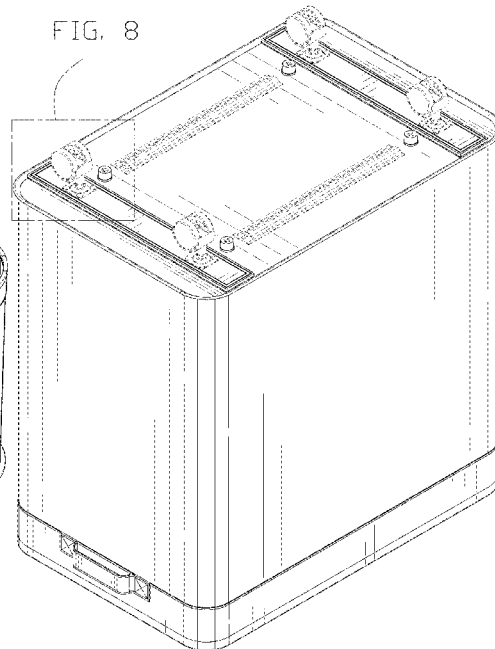
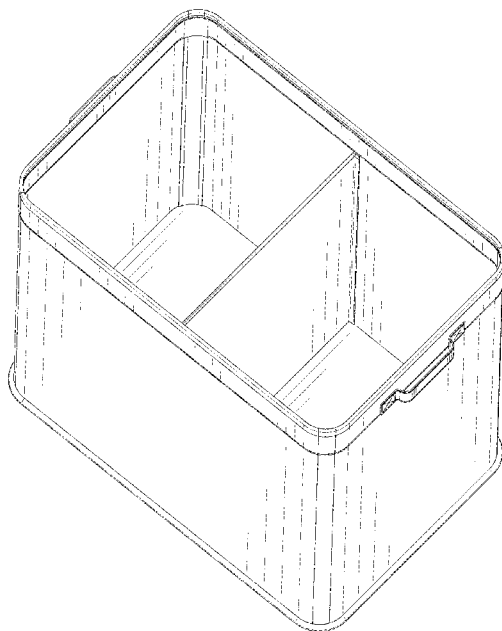
The ornamental design for a laundry hamper, as shown and described.

DESCRIPTION

FIG. 1 is a front and top perspective view of a laundry hamper, showing my new design;
FIG. 2 is a rear and bottom perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a left side elevation view thereof, right side elevation view is a mirror view of the left side view;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is an exploded view thereof; and,
FIG. 8 is an enlarged view of a portion labeled, 'FIG. 8' in FIG. 2.

The broken lines in the figures illustrate portions of the laundry hamper that form no part of the claimed design. The dash dot dash lines in FIGS. 2 and 8 are for the purpose of depicting the cut line of the enlarged view and form no part of the claim.

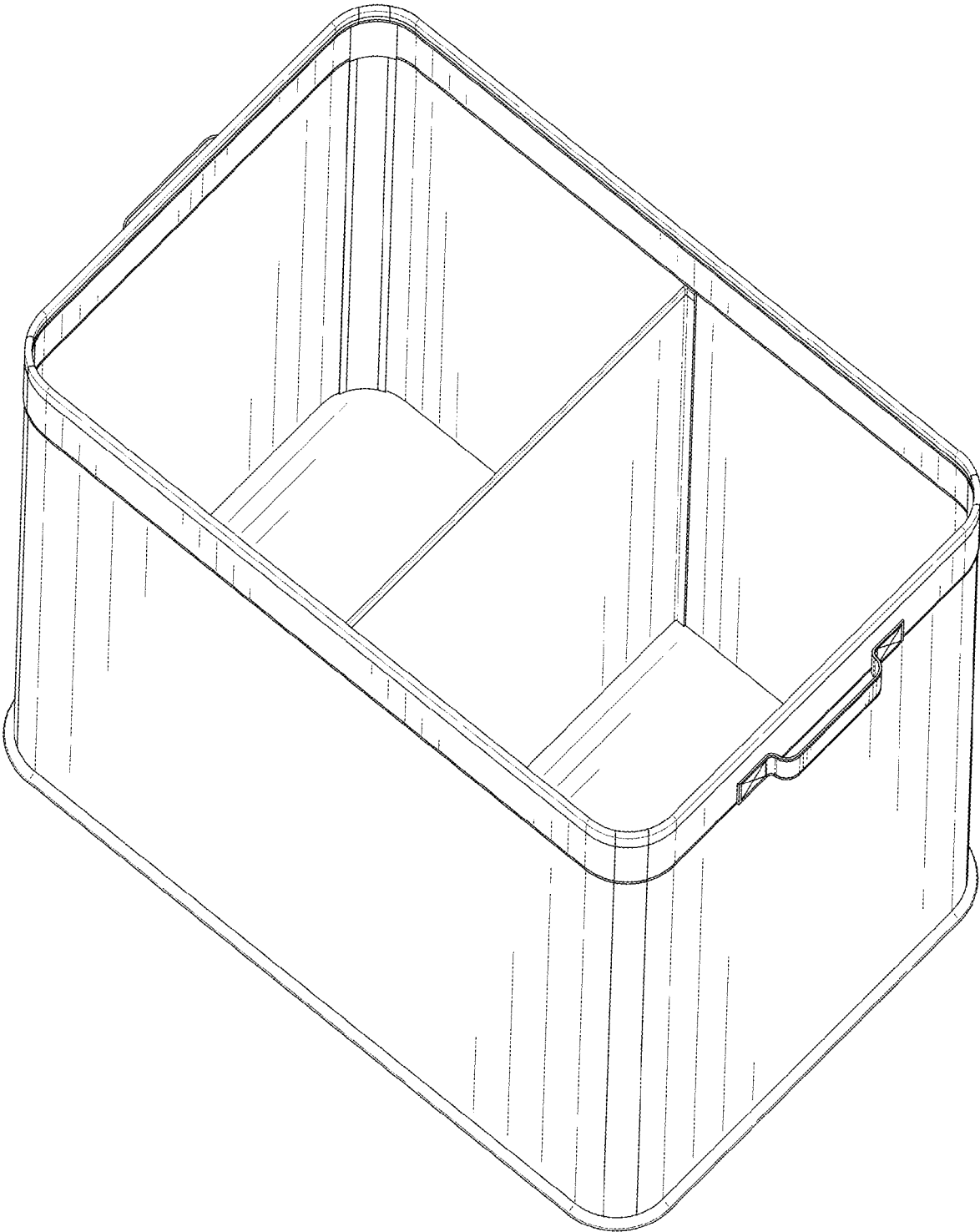

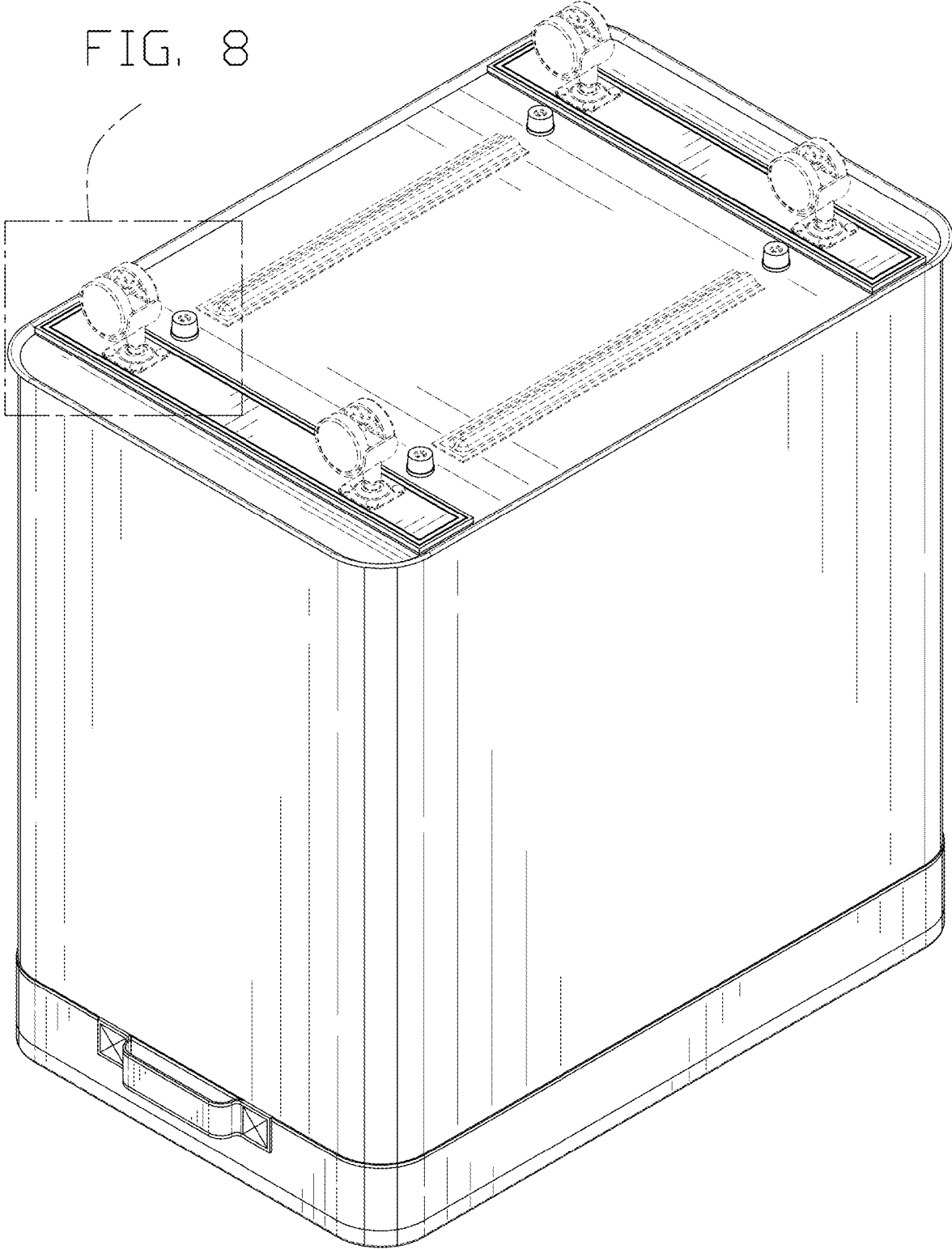

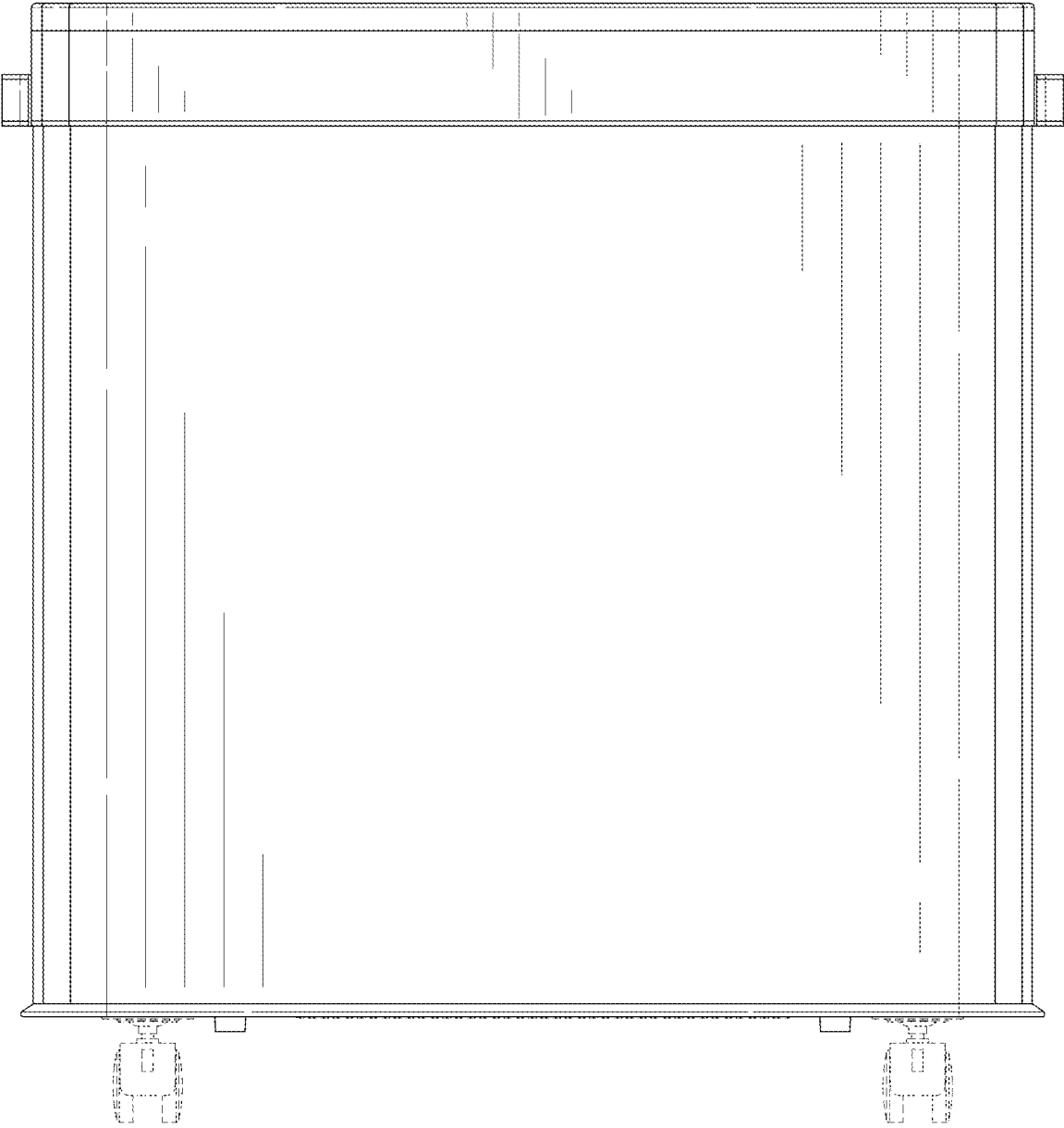

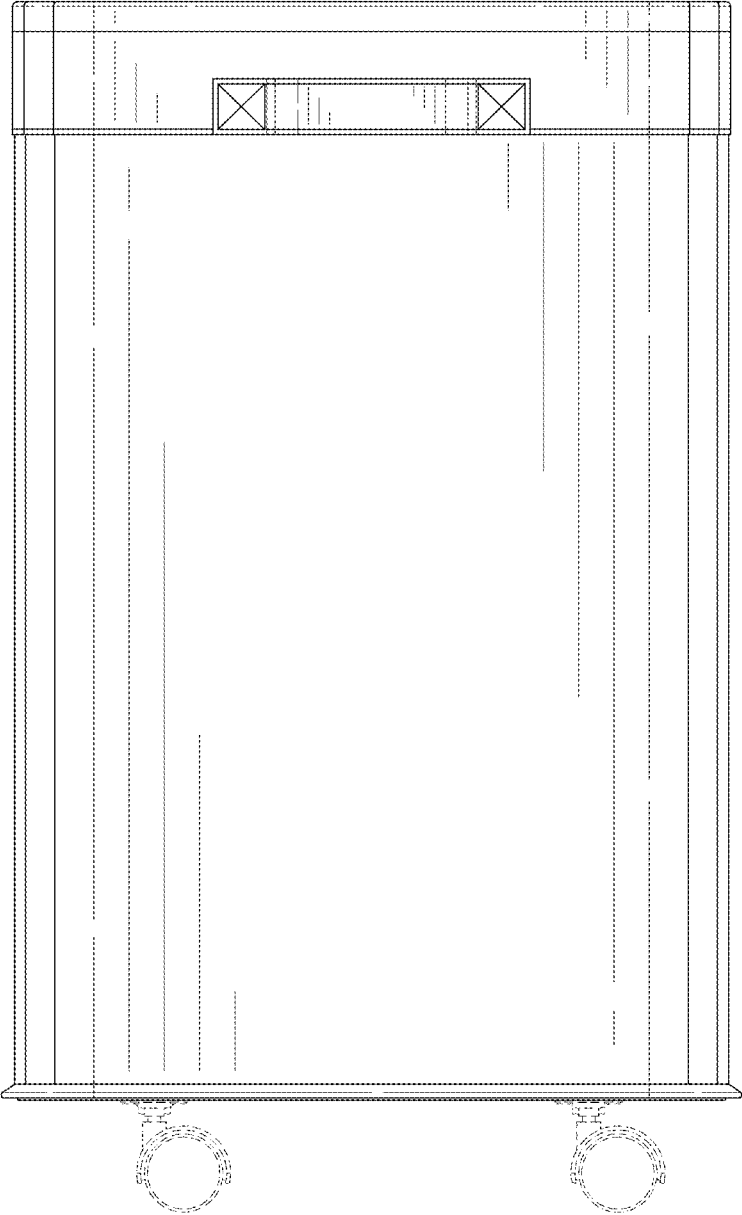

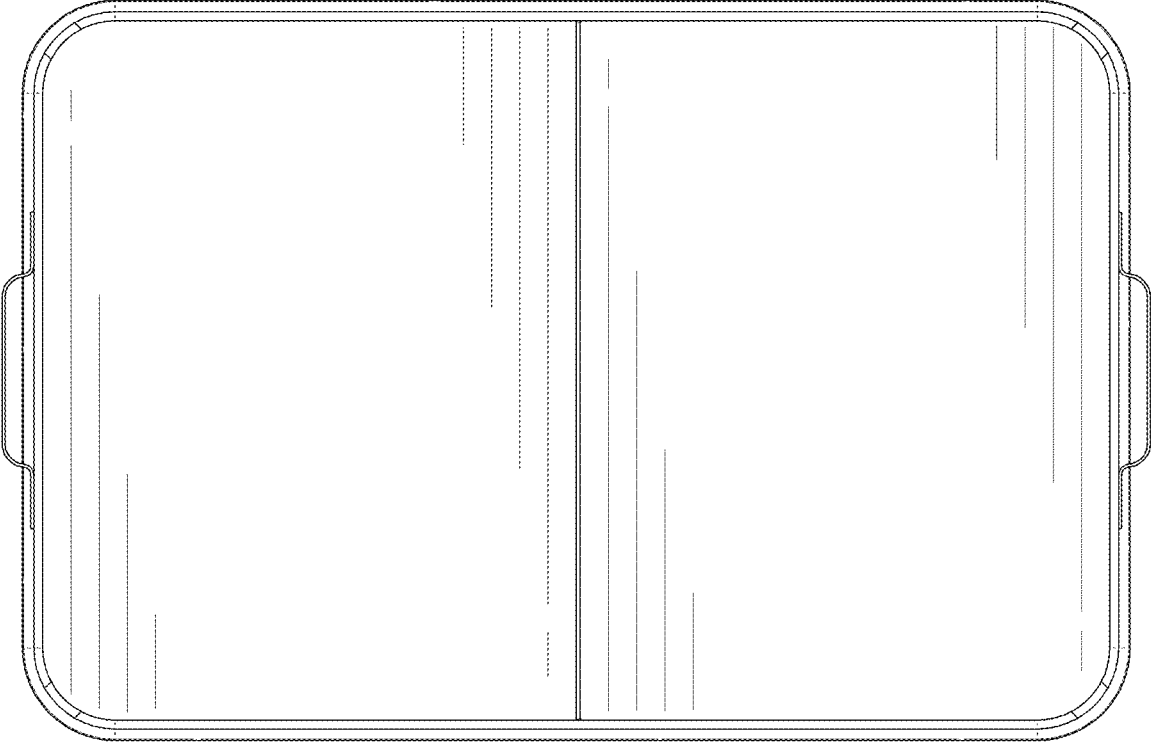

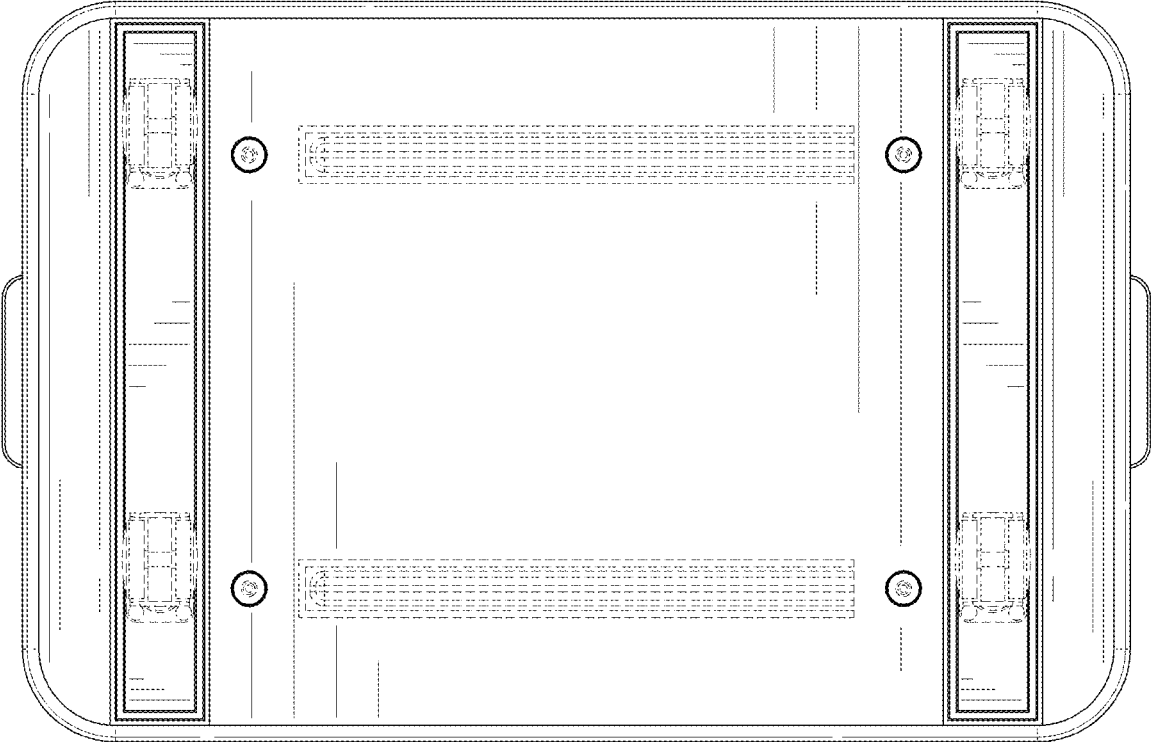

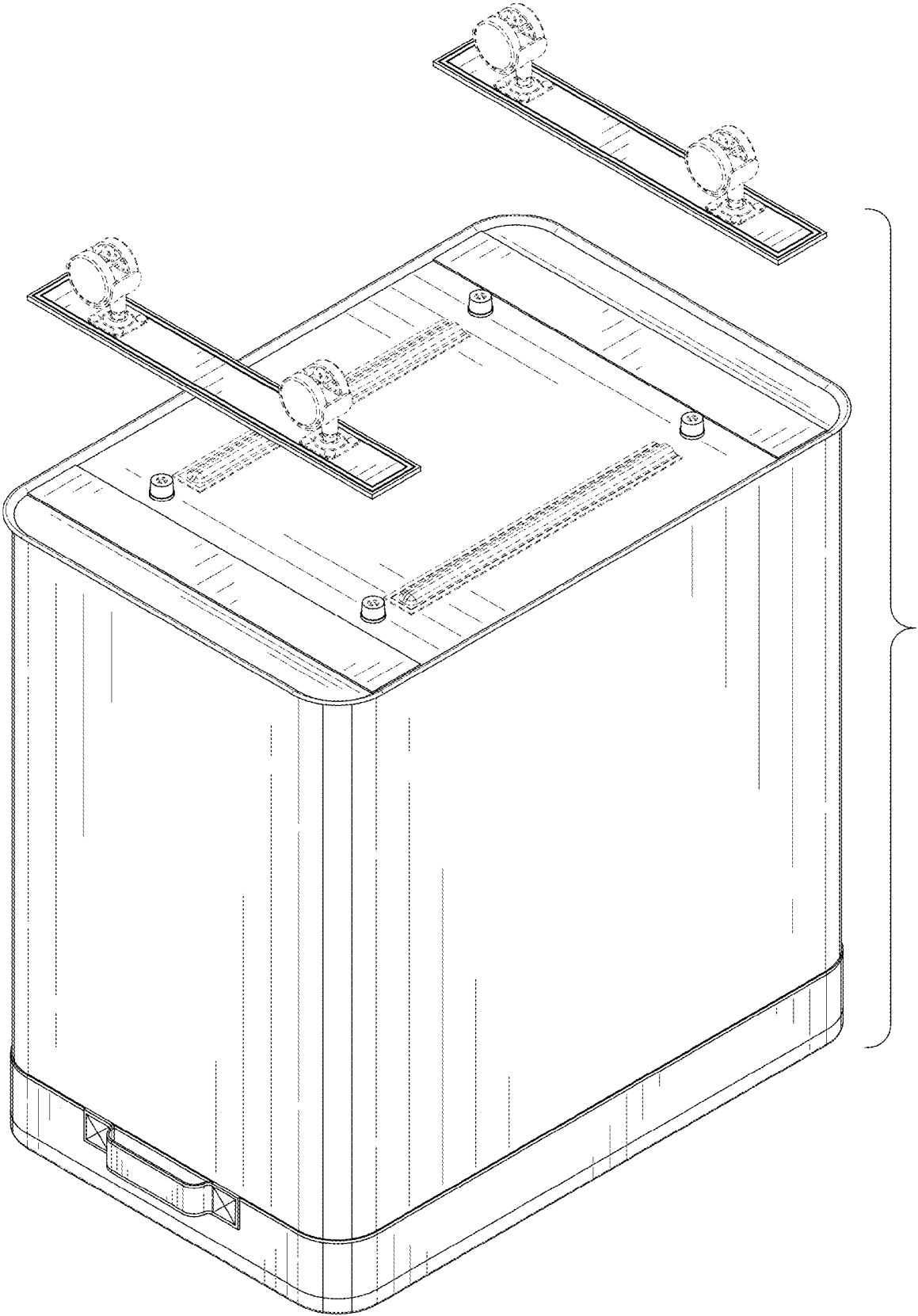

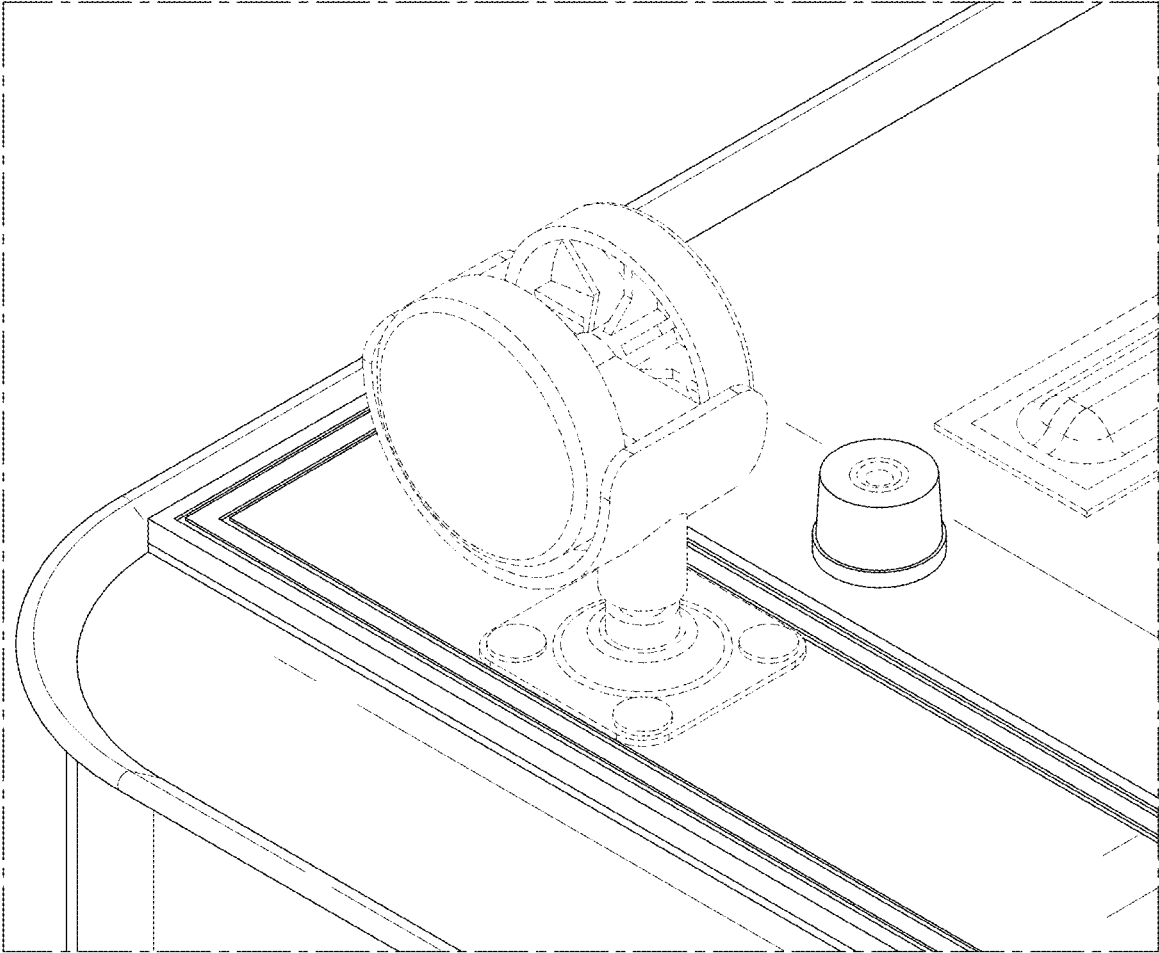
