The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, perspective view of a container showing our new design;

FIG. 2 is a front view thereof;

FIG. 5 is a left side view thereof;

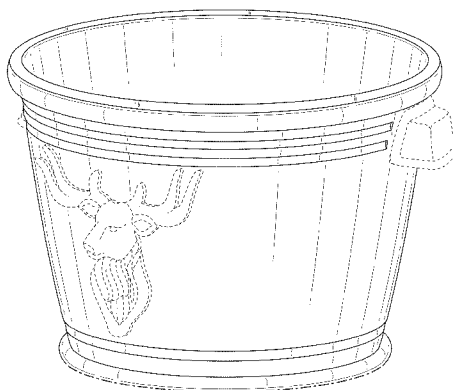
FIG. 6 is a top view thereof; and,

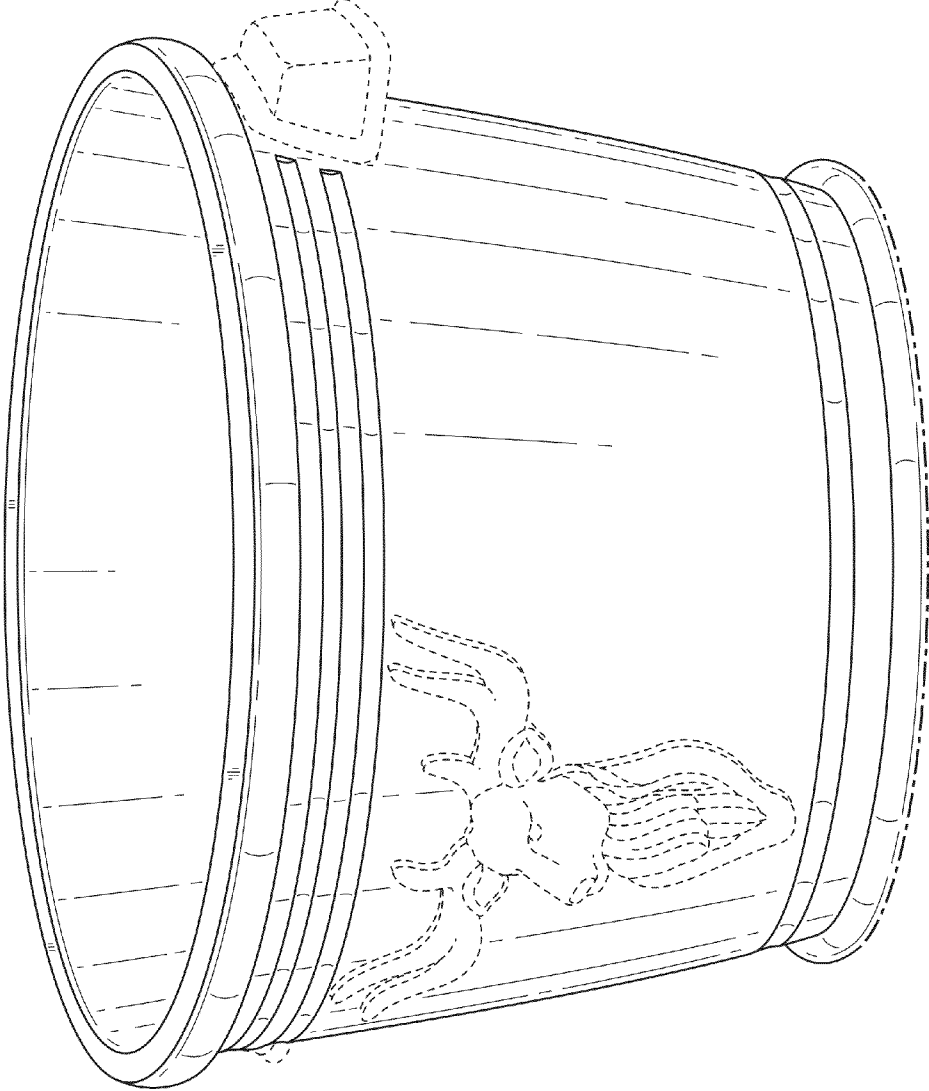

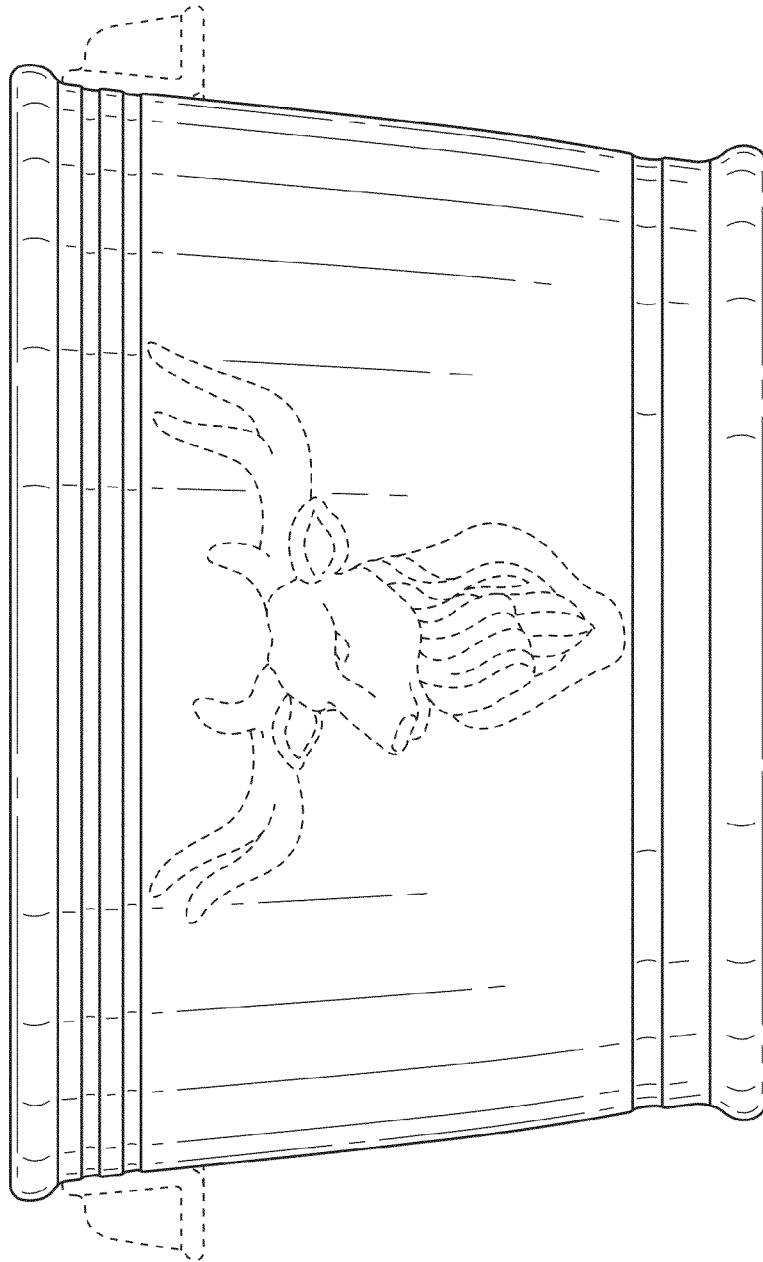

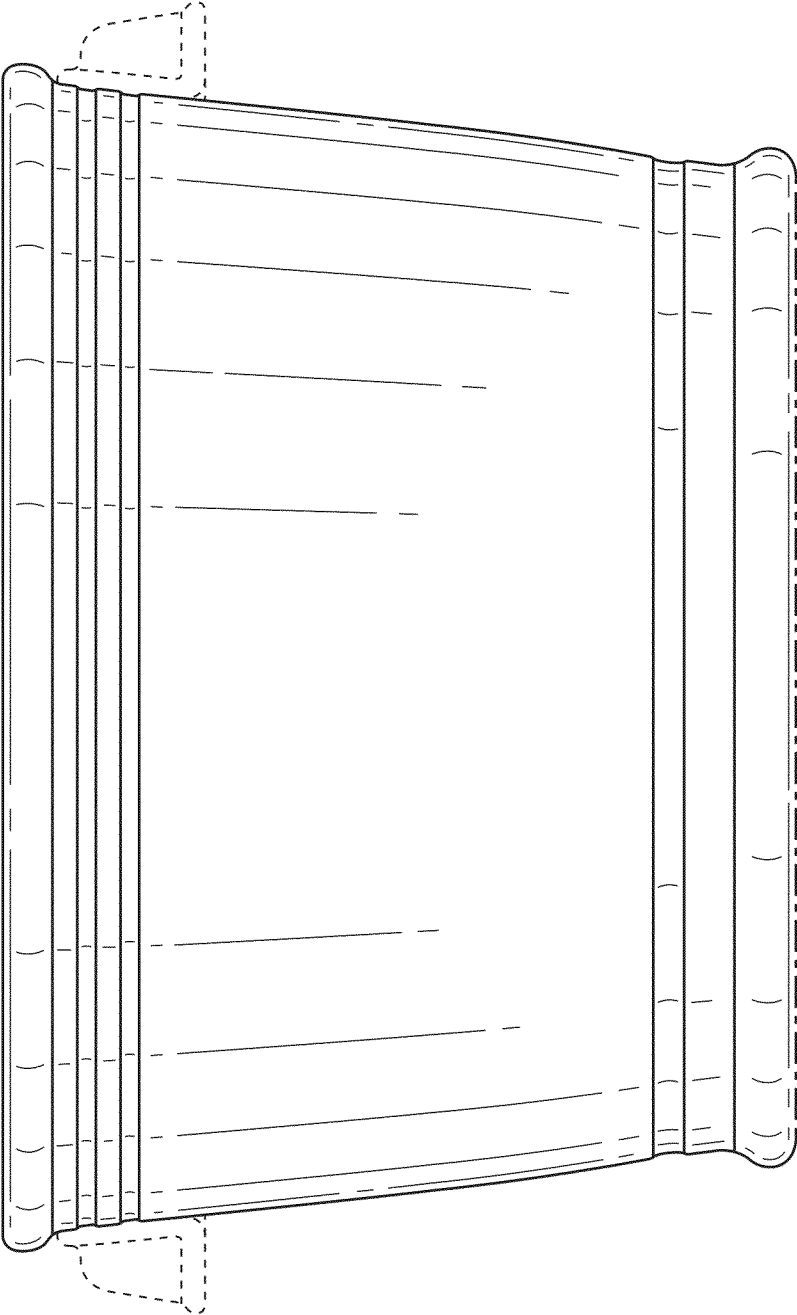

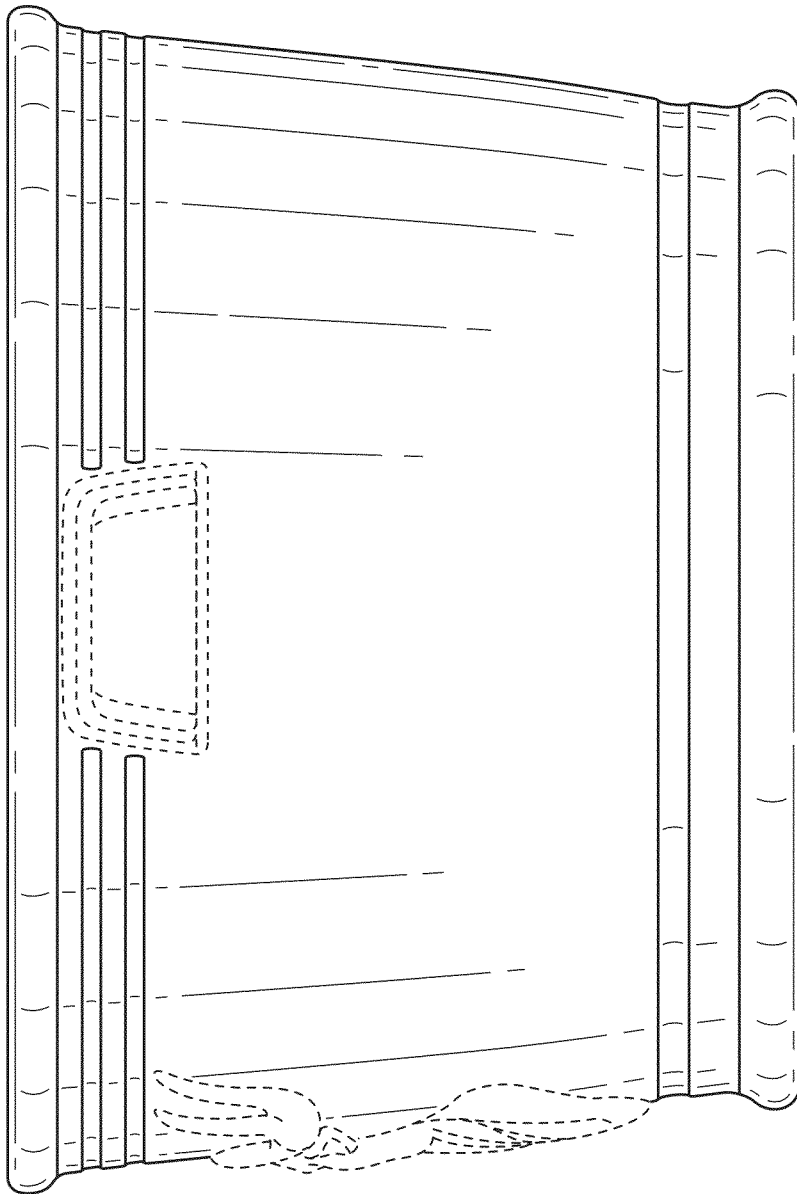

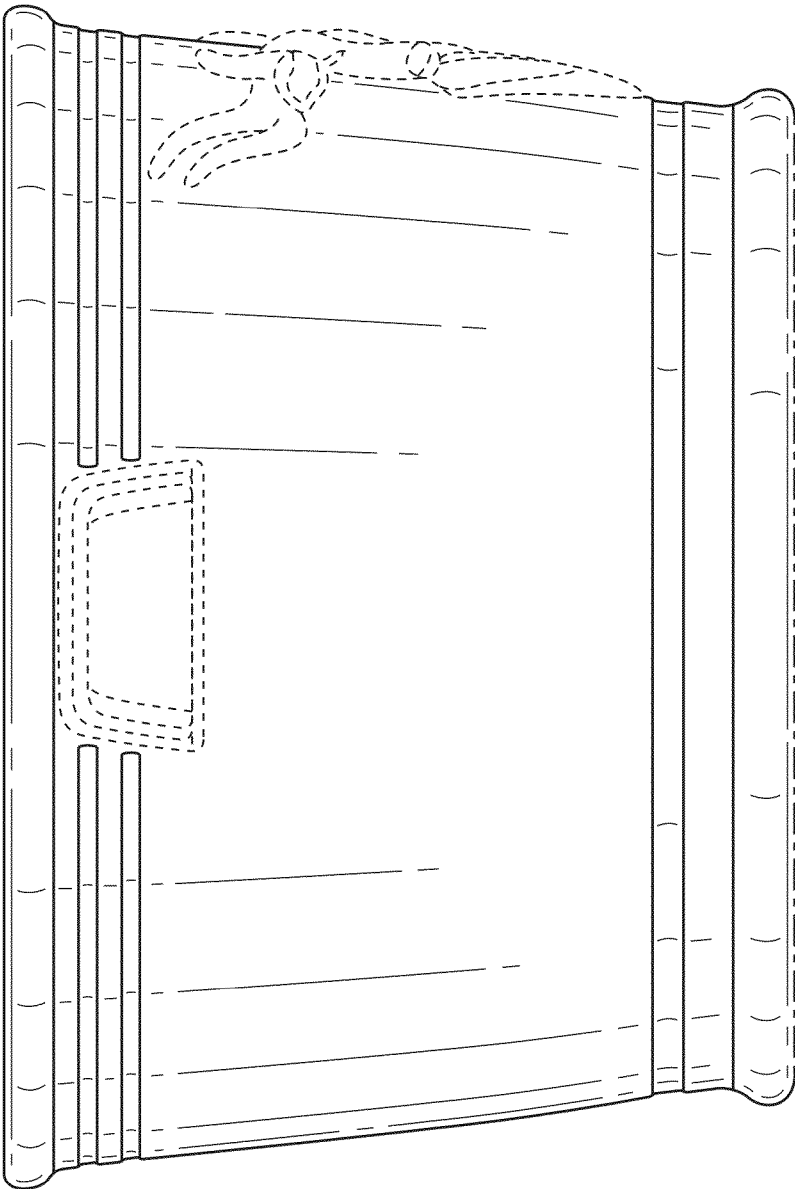

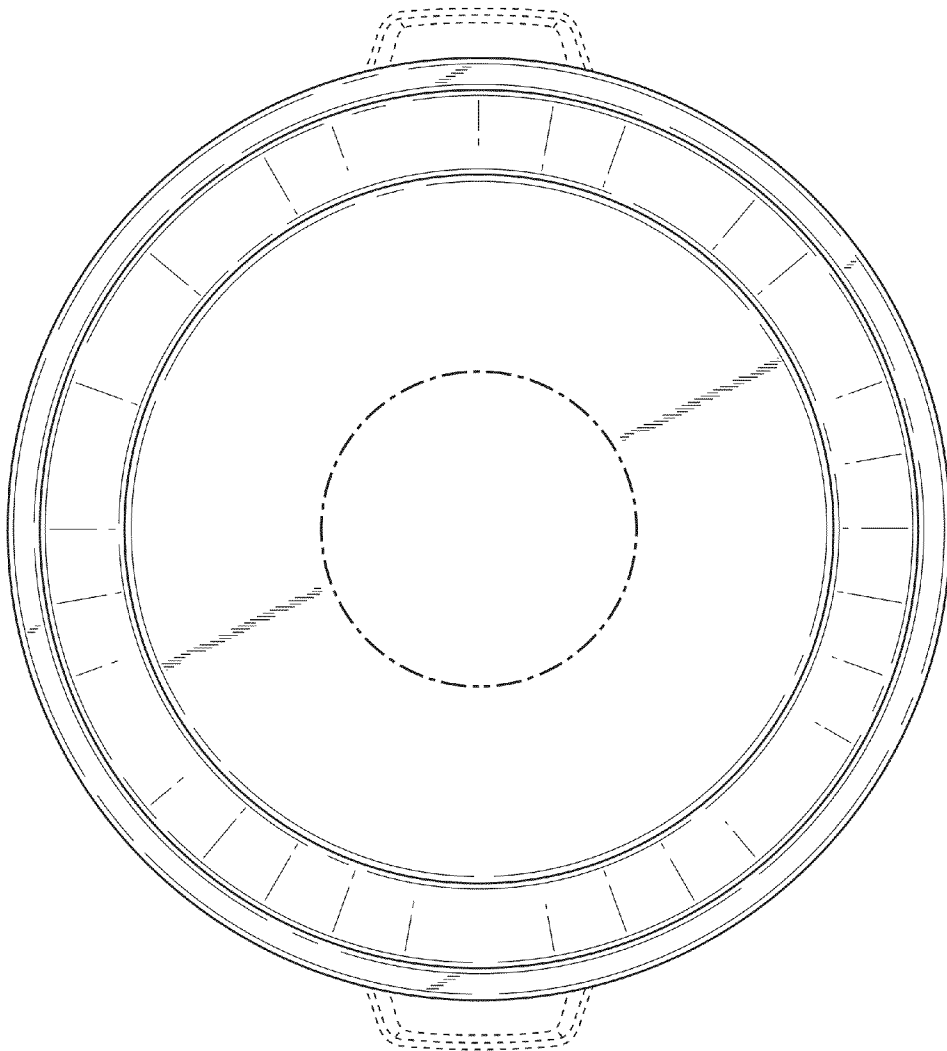

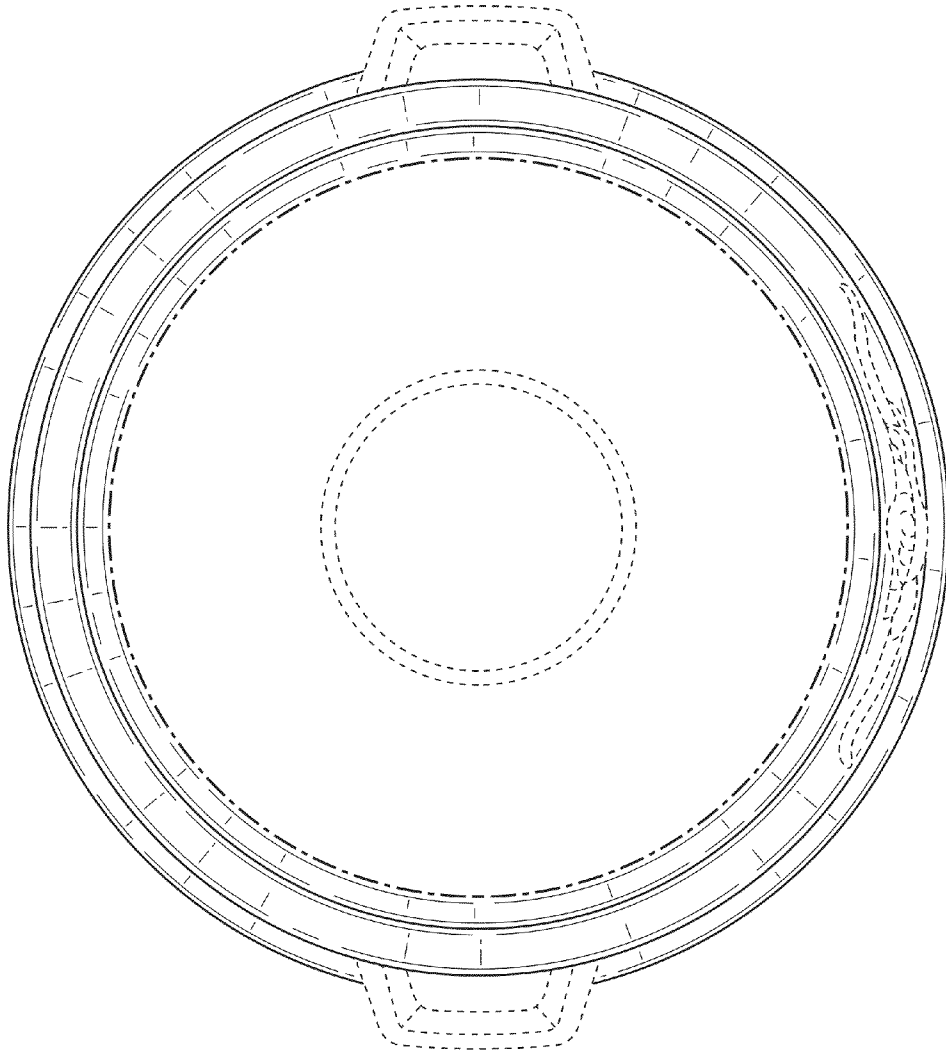
