The ornamental design for a digital camera, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a digital camera showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a left side elevational view thereof. The broken lines depict portions of the digital camera in which the design is embodied and form no part of the claimed design.














