

(57) Abstract: A multiple degree of freedom actuator can have at least one first MEMS actuator configured to move a platform in translation and at least one second MEMS actuator configured to move the platform in a different direction, e.g., tangentially. The first MEMS actuator(s) can facilitate autofocus and/or zoom, for example. The second MEMS actuator(s) can facilitate optical image stabilization (OIS), for example.
