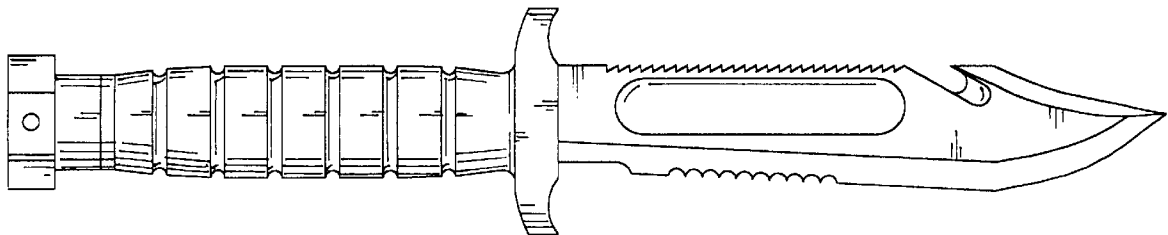
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is an elevation view of a first embodiment of the knife design;

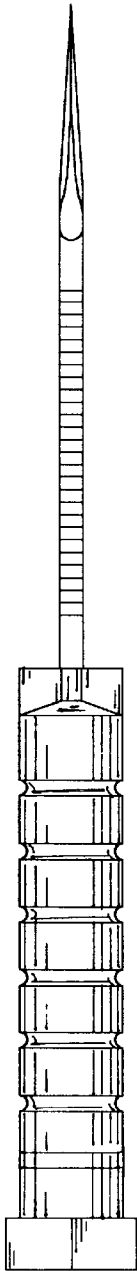

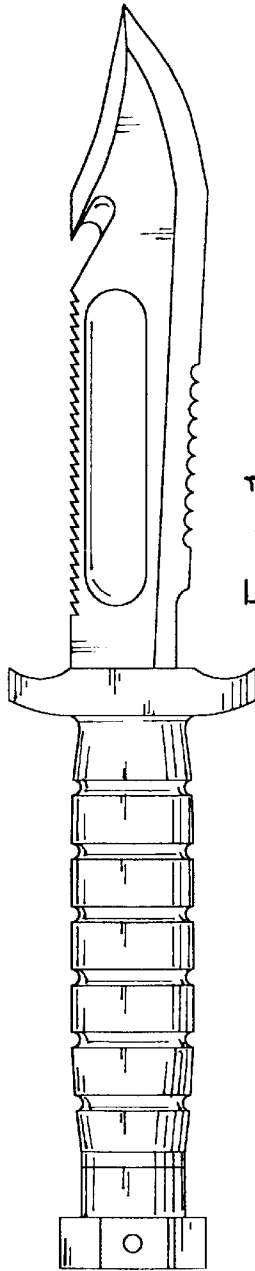

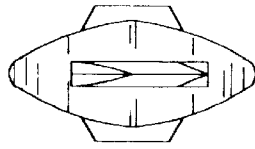

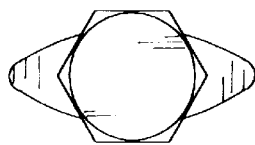

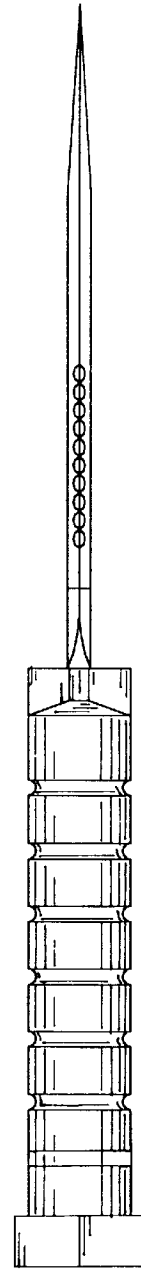

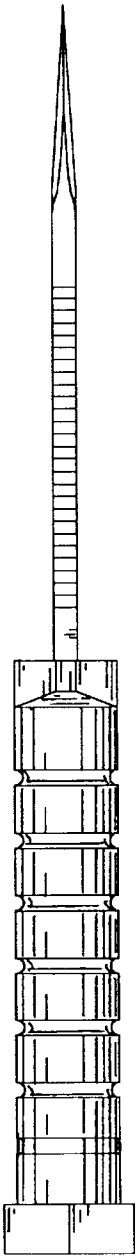

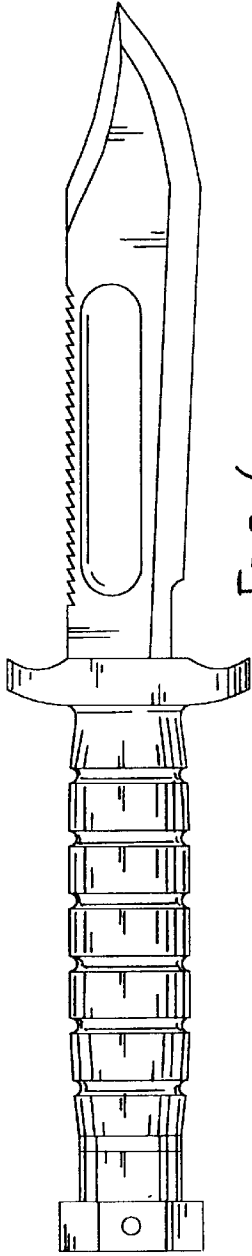

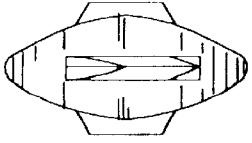

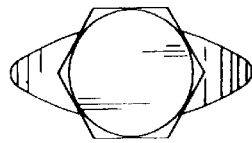

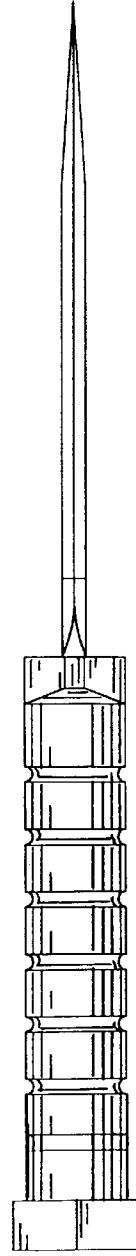

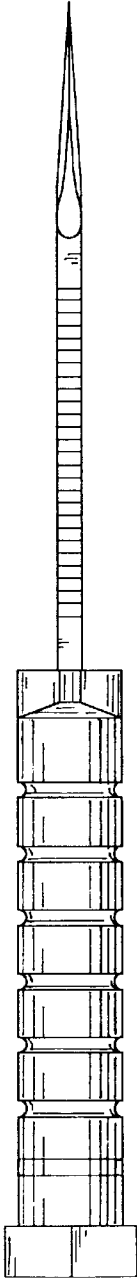

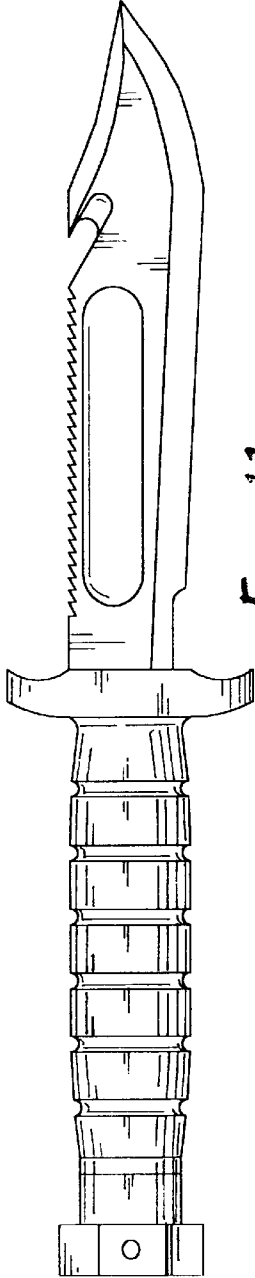

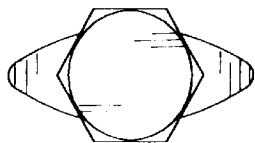

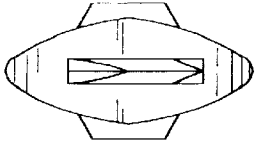

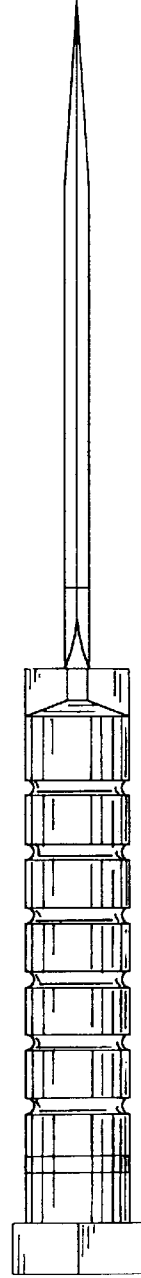

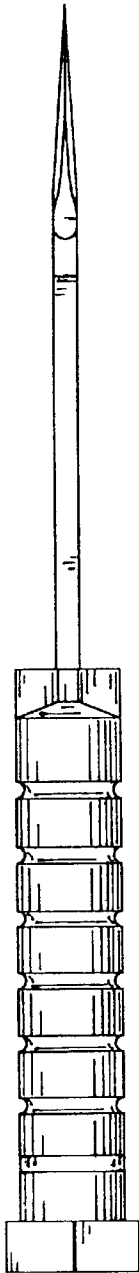

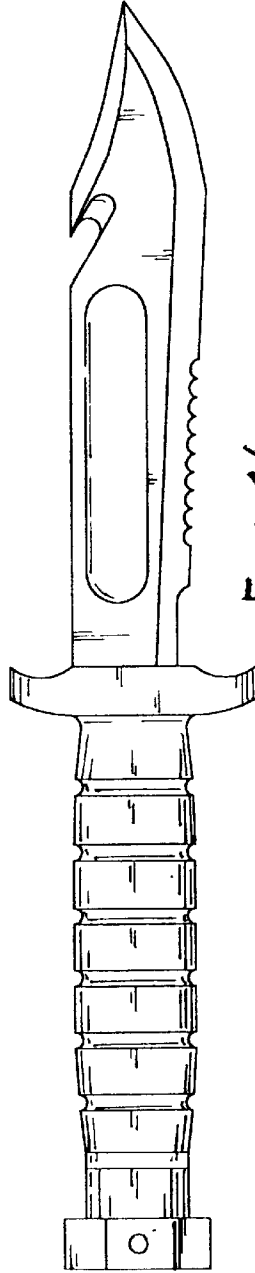

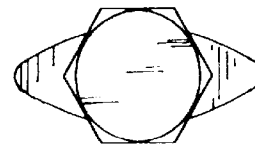

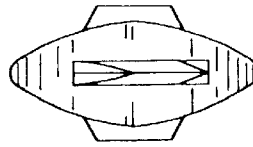

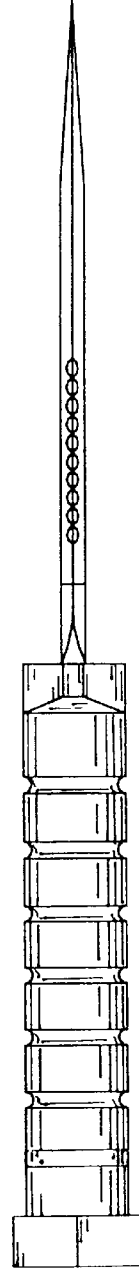
