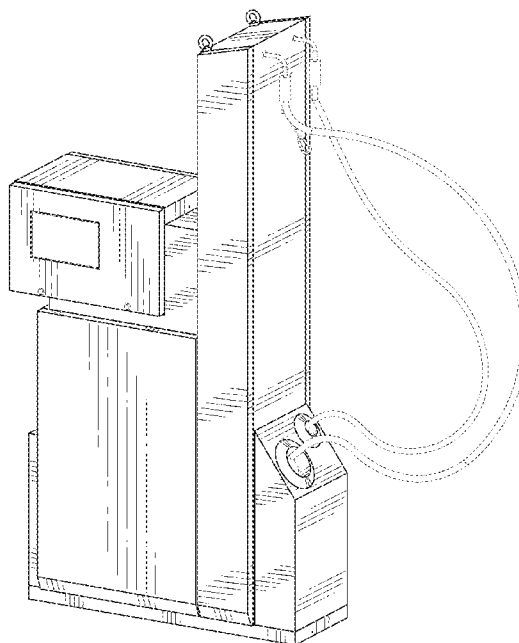
(57) **CLAIM**

The ornamental design for a liquid natural gas dispenser, as shown and described.

DESCRIPTION

FIG. 1 shows a front, perspective view of a liquid natural gas dispenser, showing my new design;
FIG. 2 shows a front, elevational view of the liquid natural gas dispenser shown in FIG. 1;
FIG. 3 shows a rear, elevational view of the liquid natural gas dispenser shown in FIG. 1;

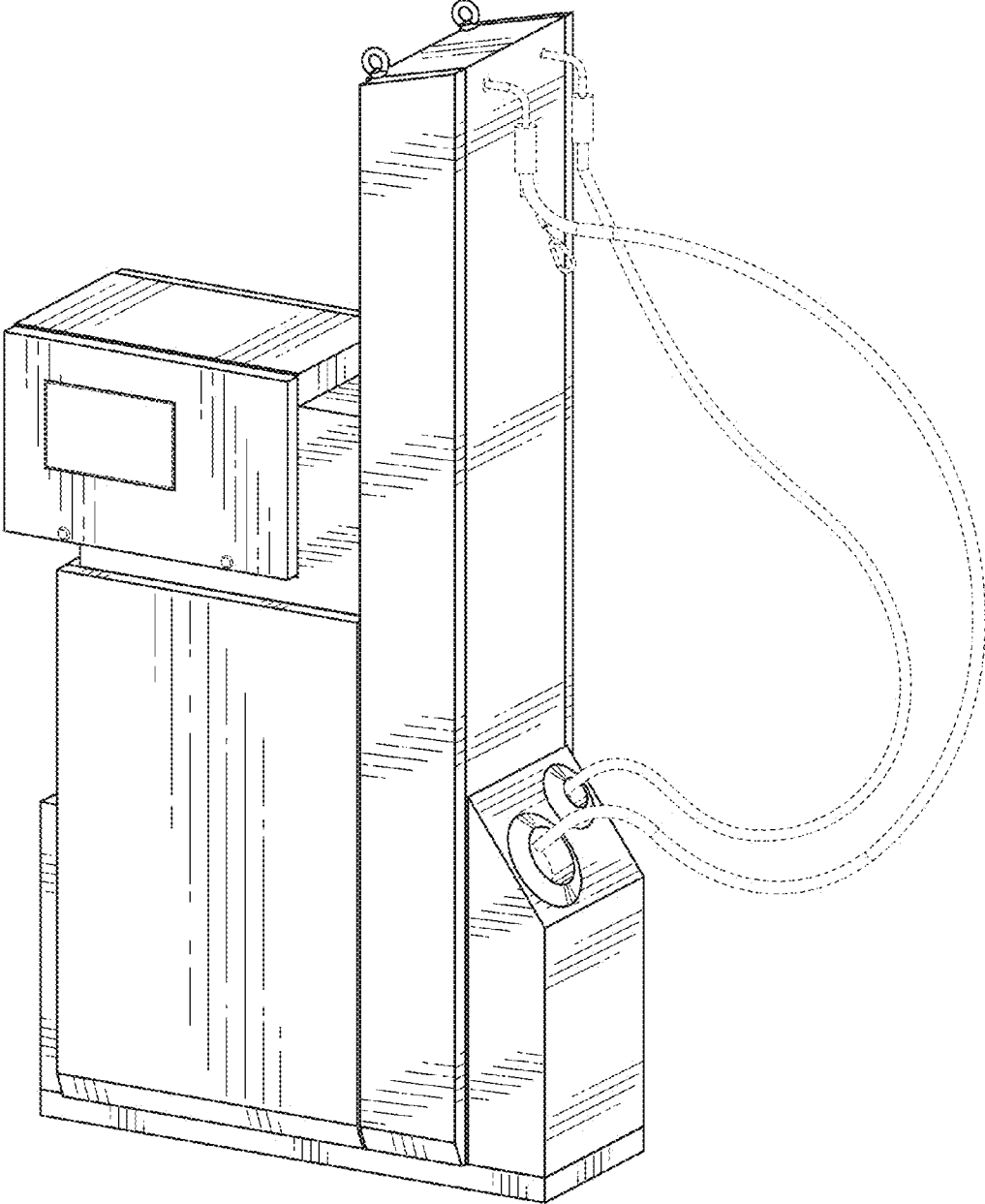

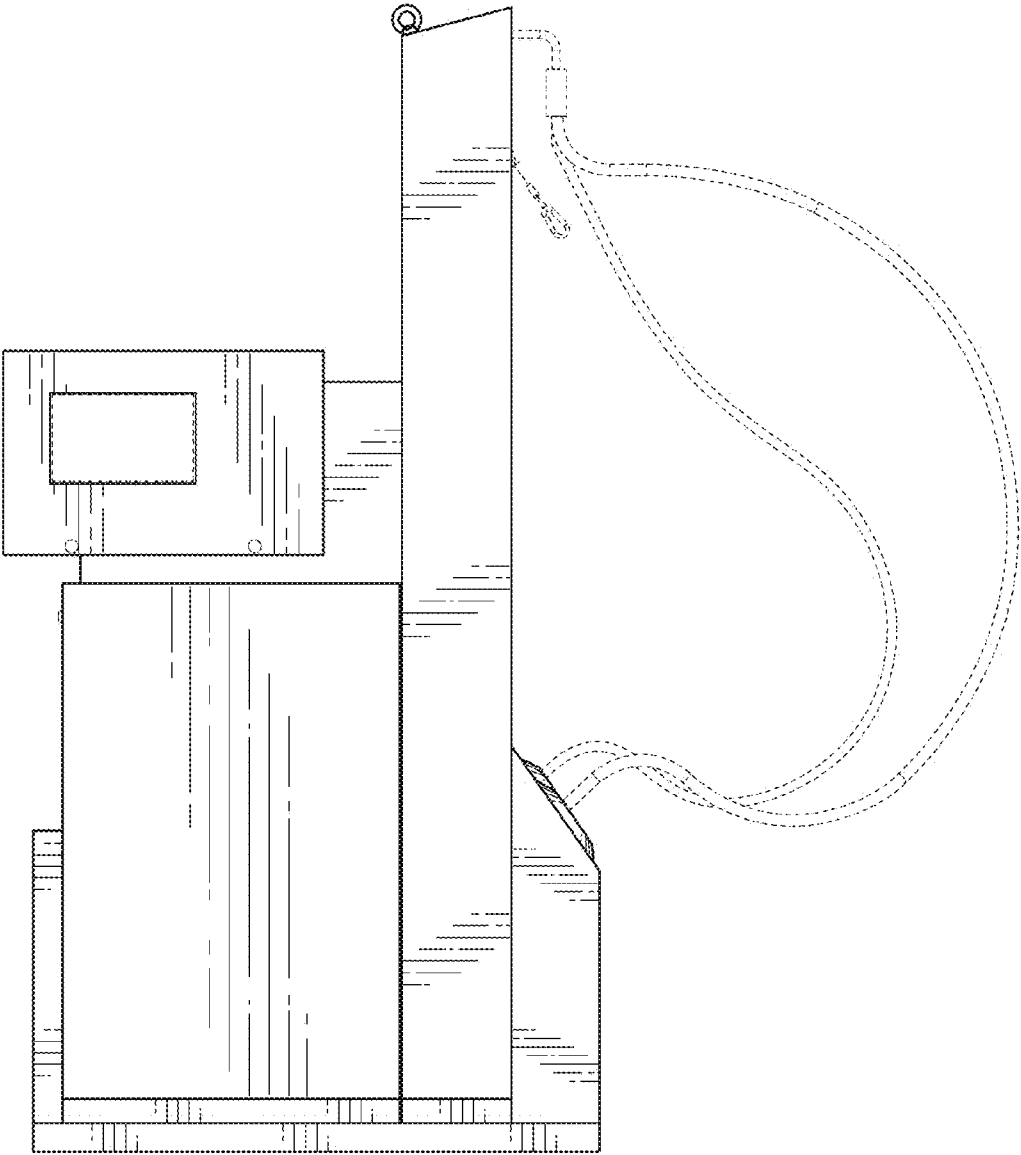

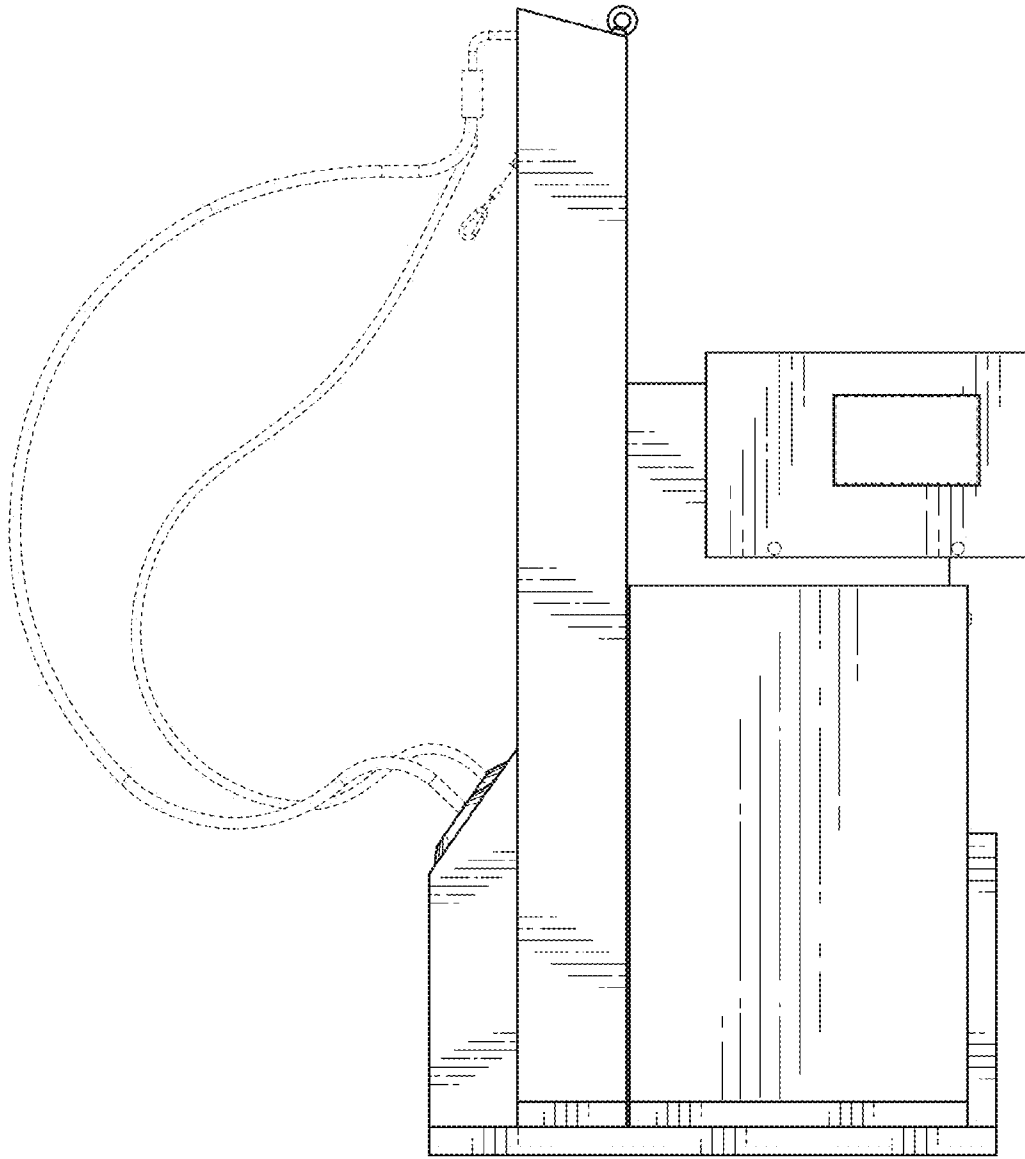

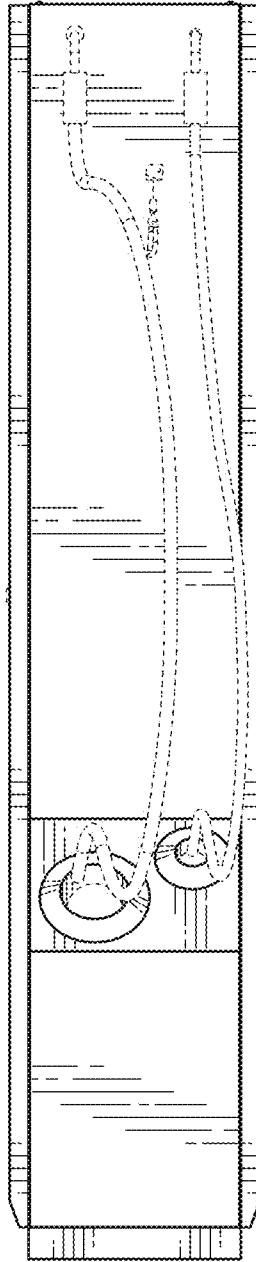

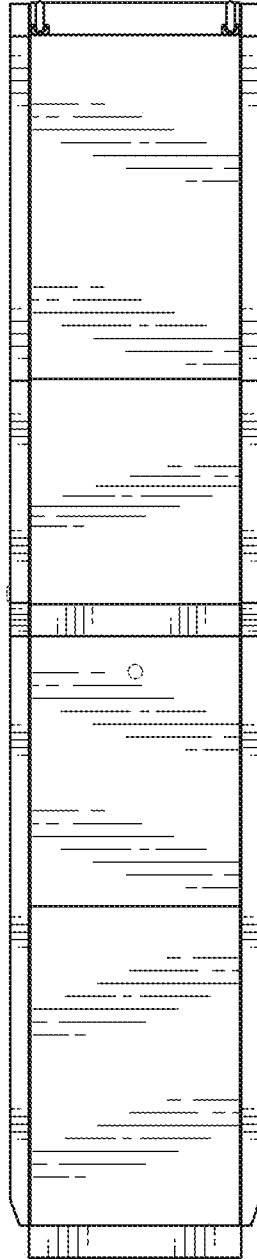

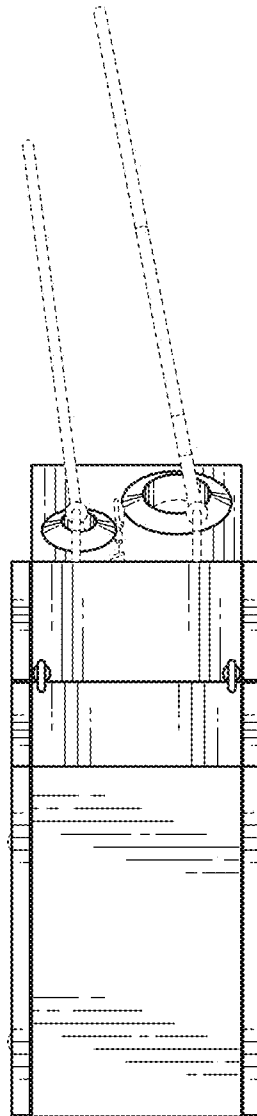

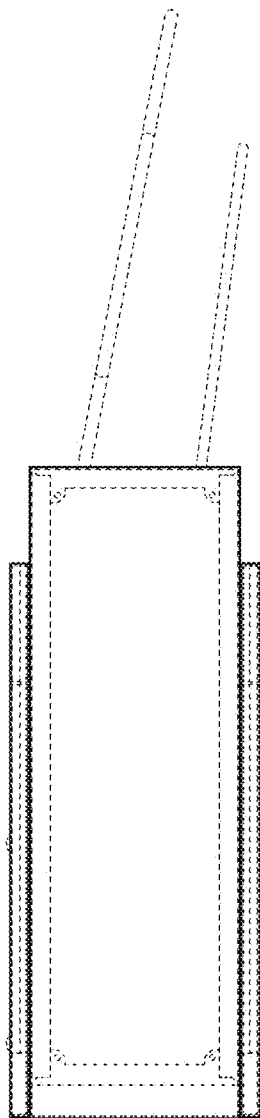
