

The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing the left side, top and front of a chair which forms my new design, the long broken lines in this and other figures representing environment and forming no part of the claim;
FIG. 2 is a perspective view showing the right side, top and rear thereof;
FIG. 3 is a front elevational view;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a right side elevational view thereof;
FIG. 7 is a top plan view thereof; and,
FIG. 8 is a bottom plan view thereof.
The short broken lines in FIGS. 1-8 are understood to represent stitching.














