6.

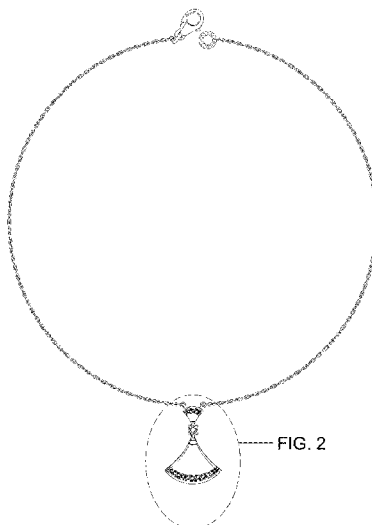
FIG. 8 is a top plan view of the necklace of FIG. 1.

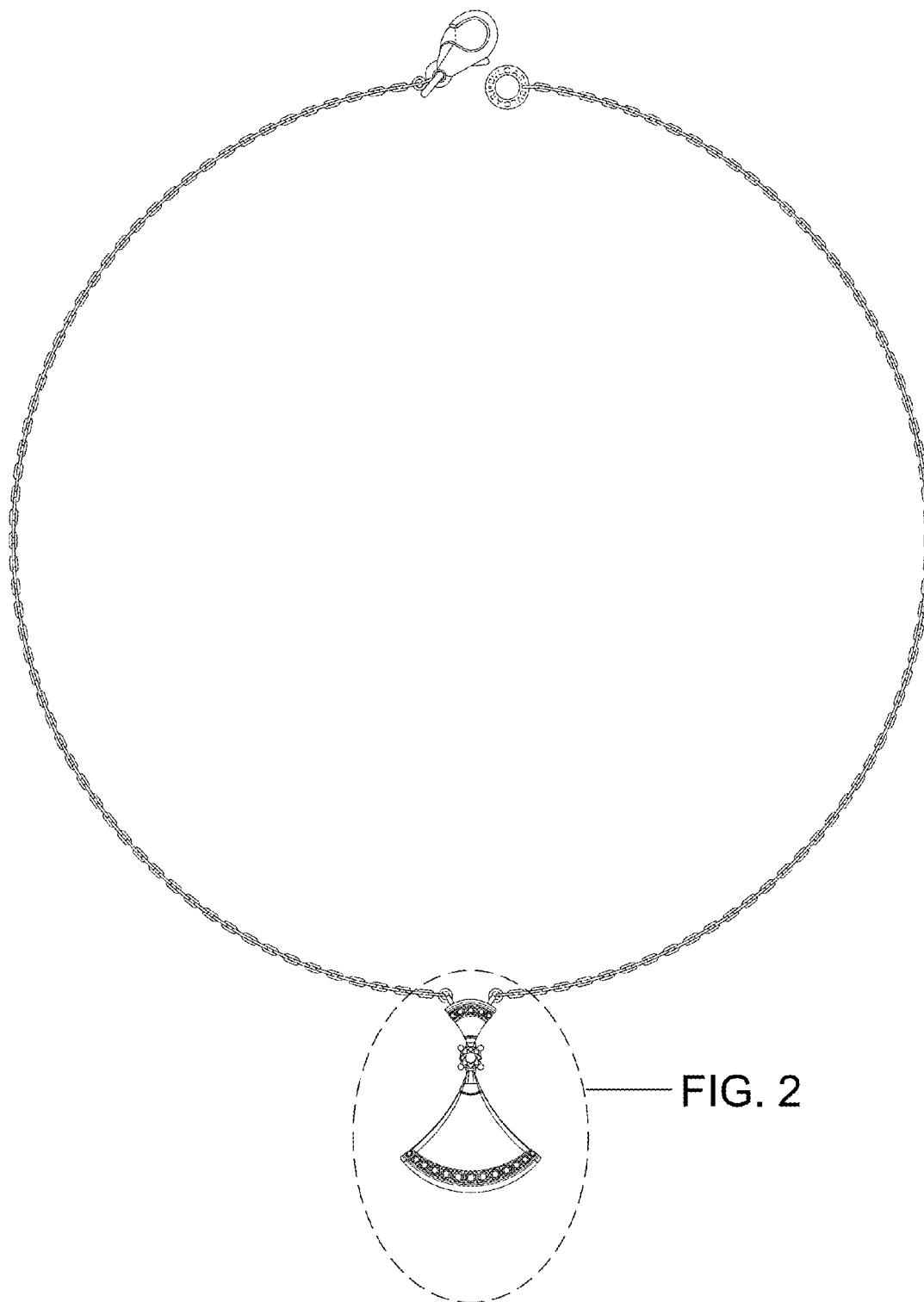

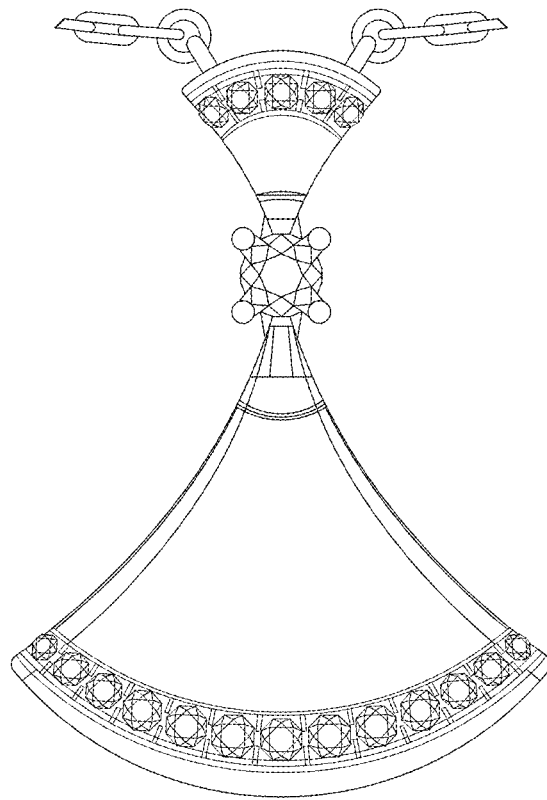

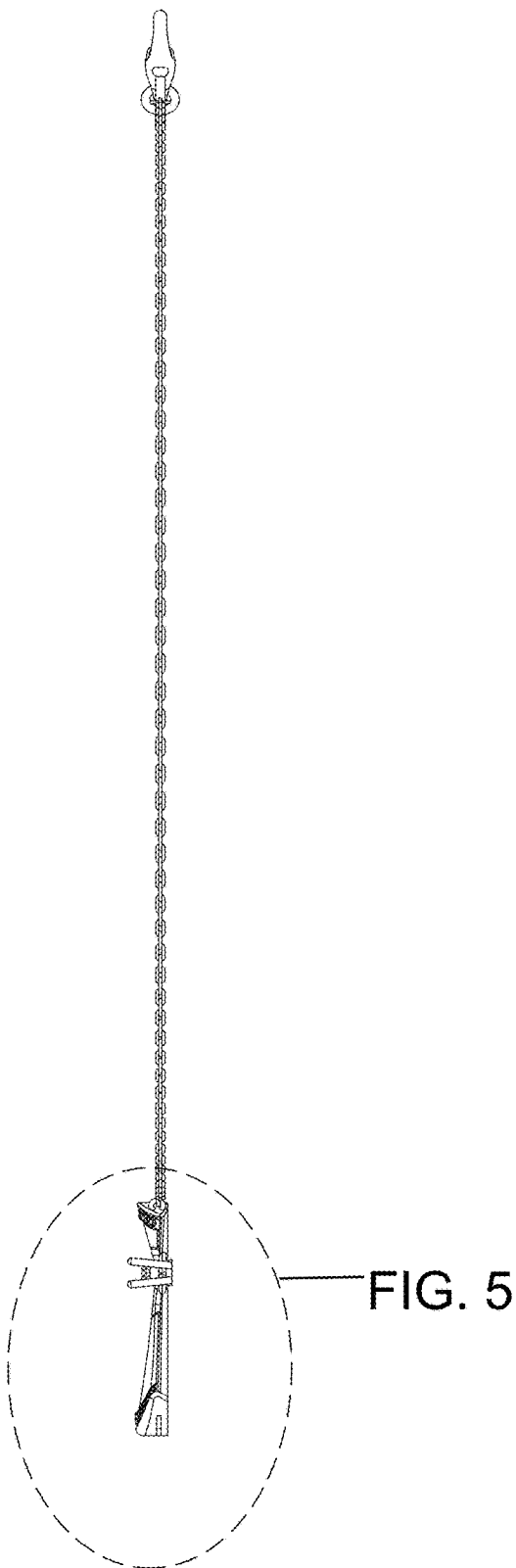

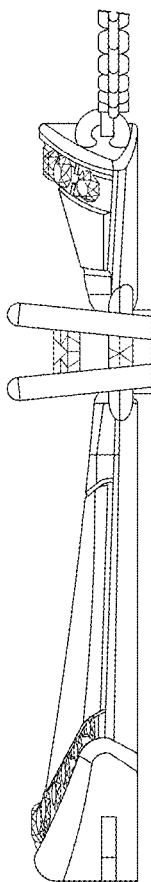

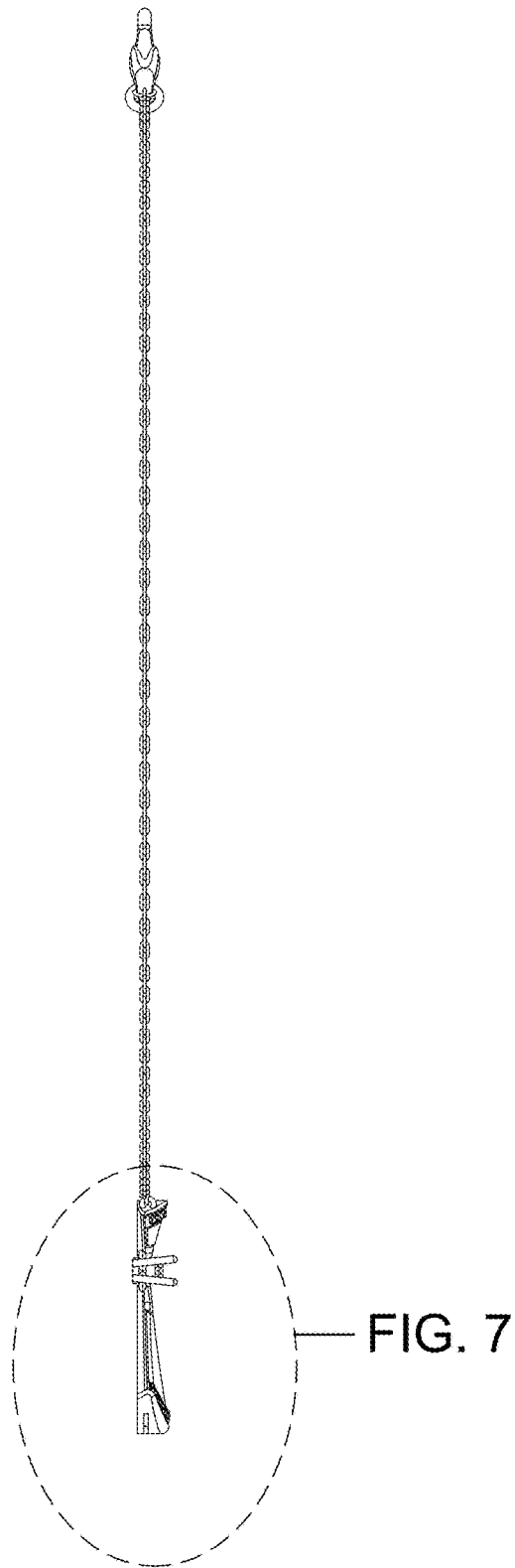

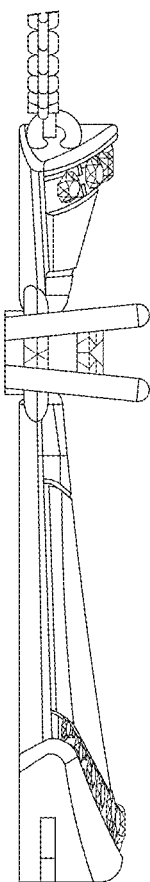

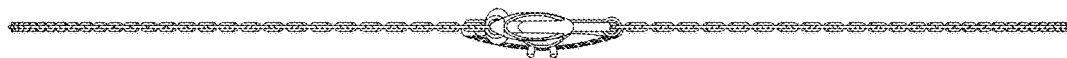

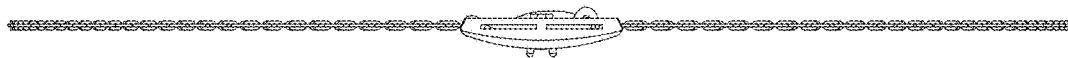

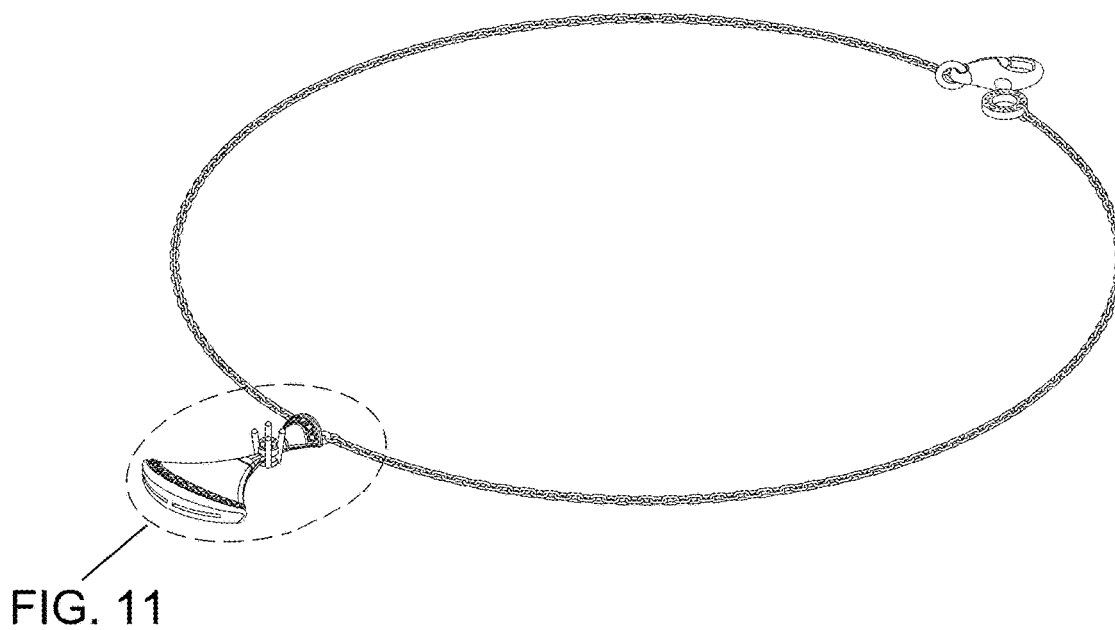

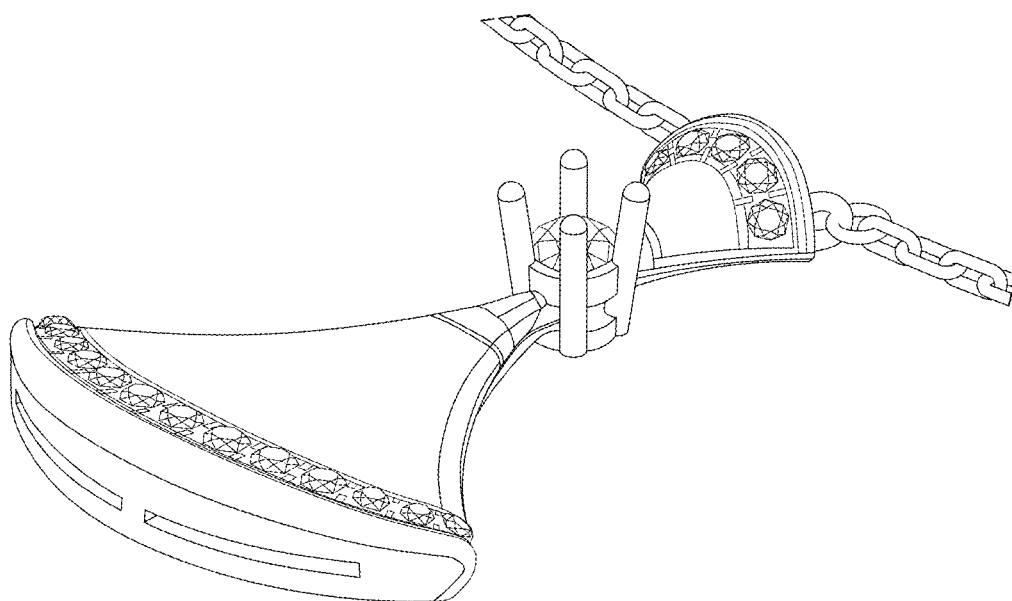
