The ornamental design for a wiring clamp, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a wiring clamp showing my new design;

FIG. 6 is a top view thereof;

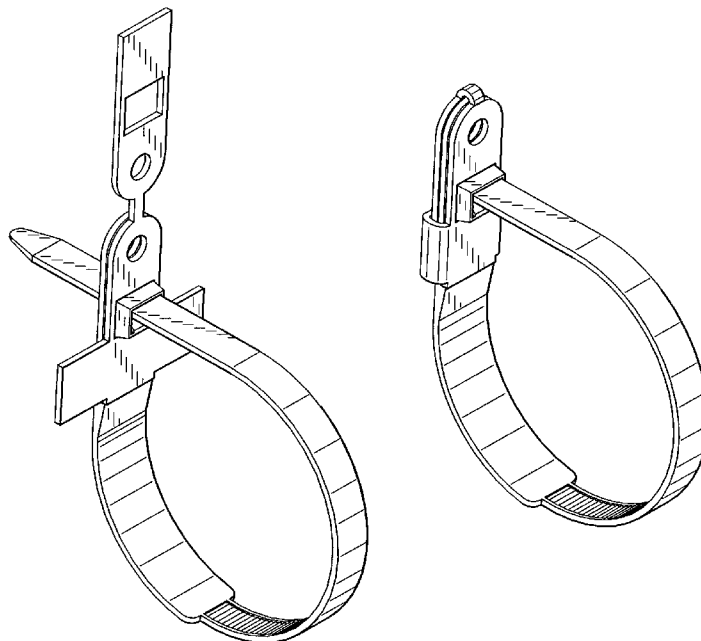
FIG. 7 is a bottom view thereof;

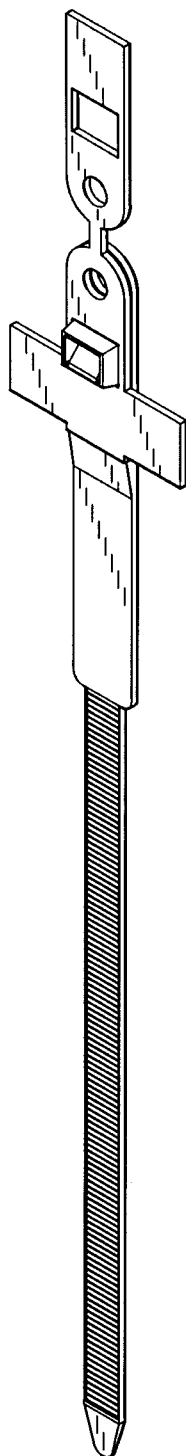

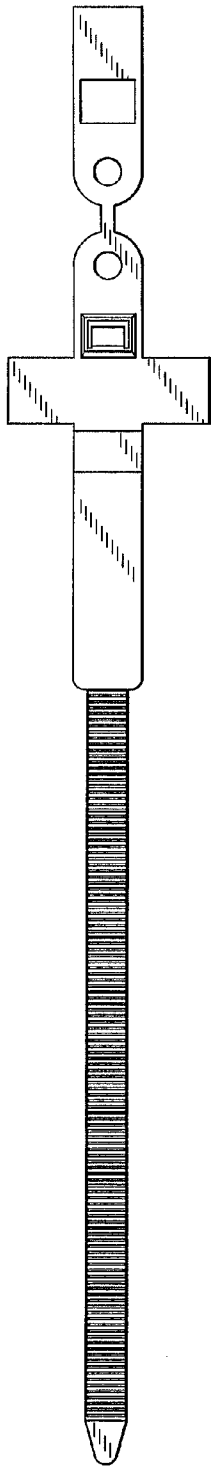

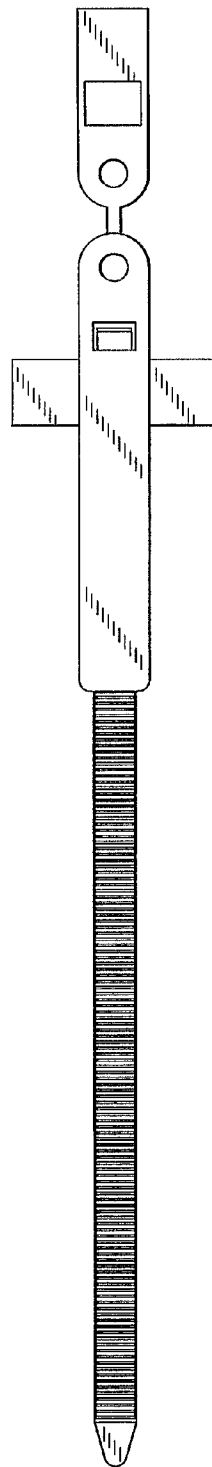

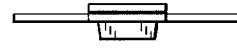

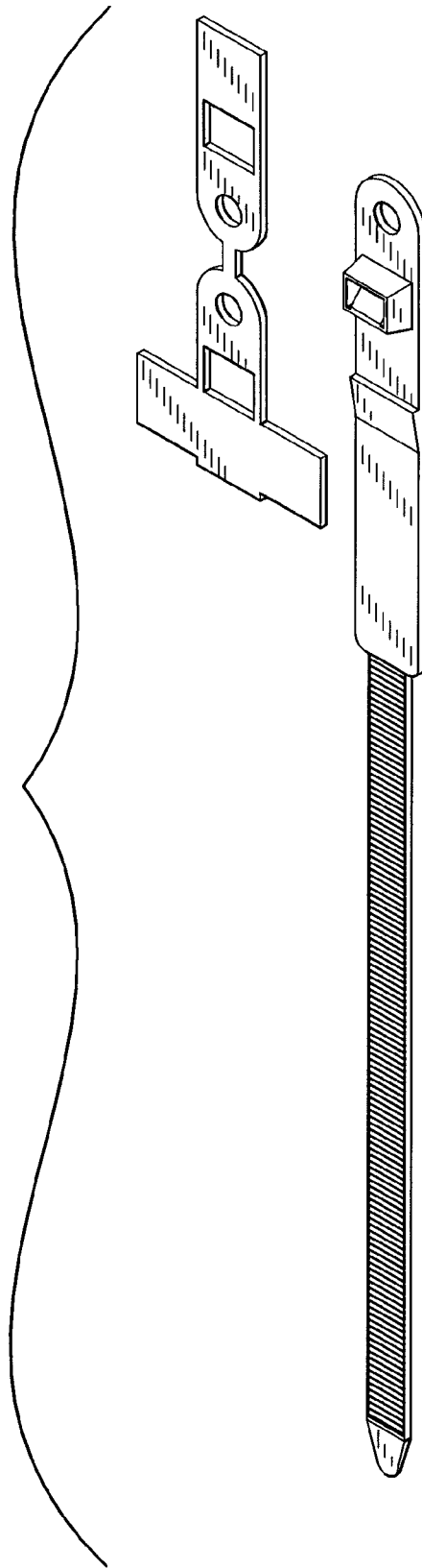

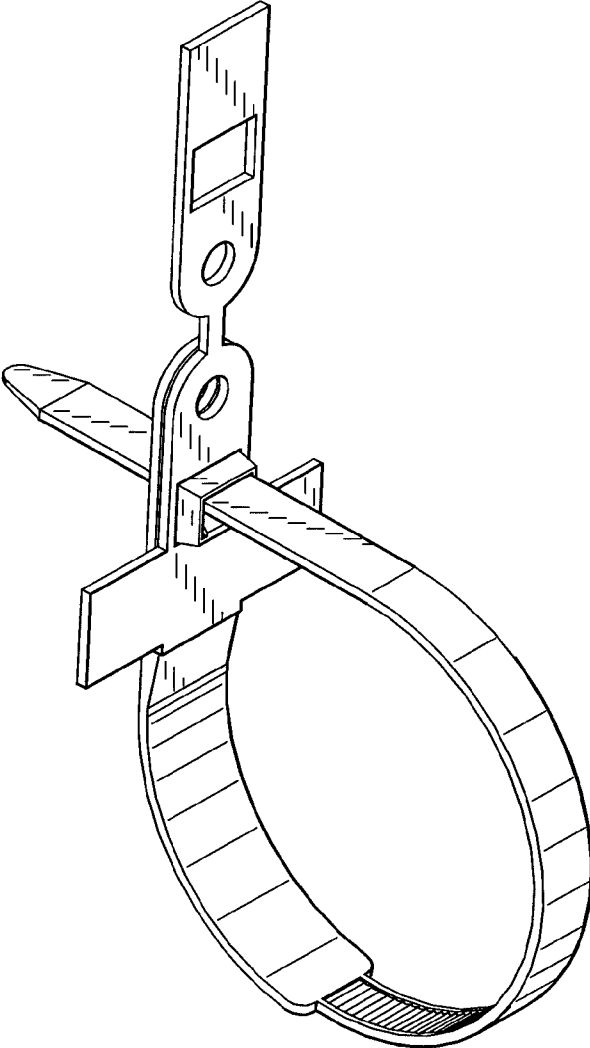

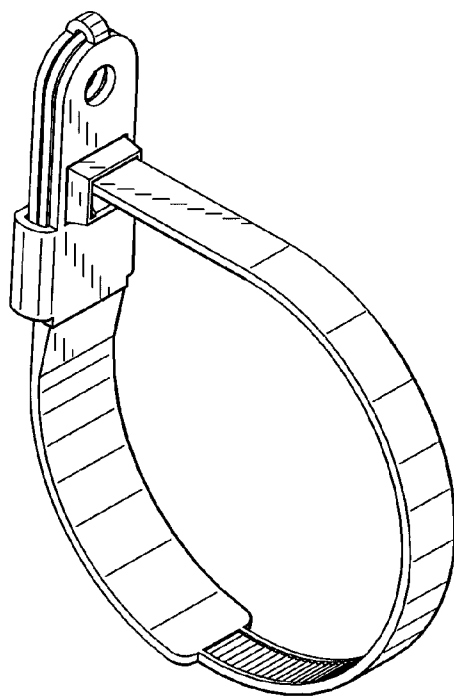
