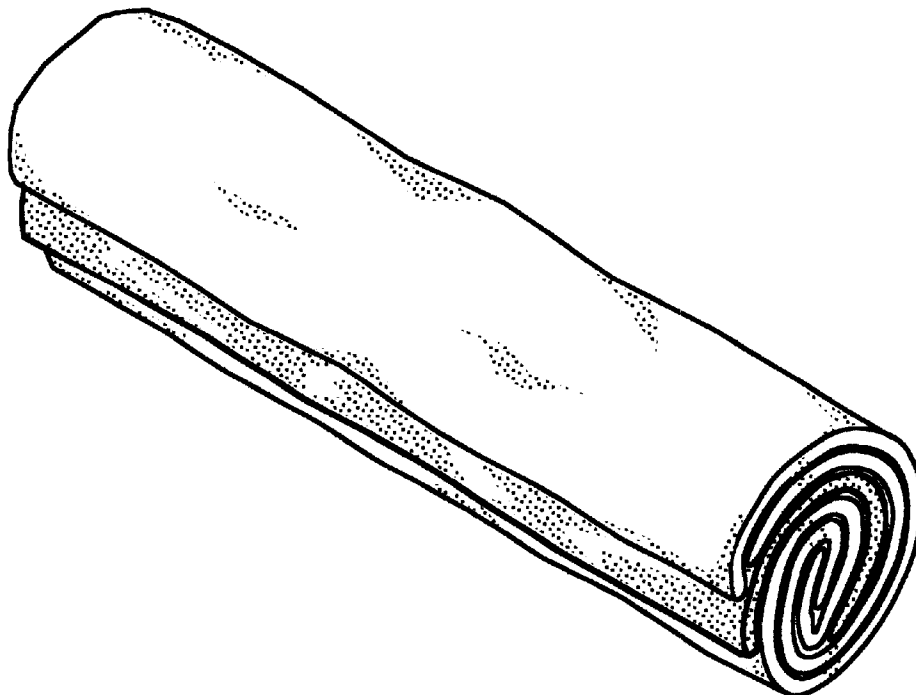

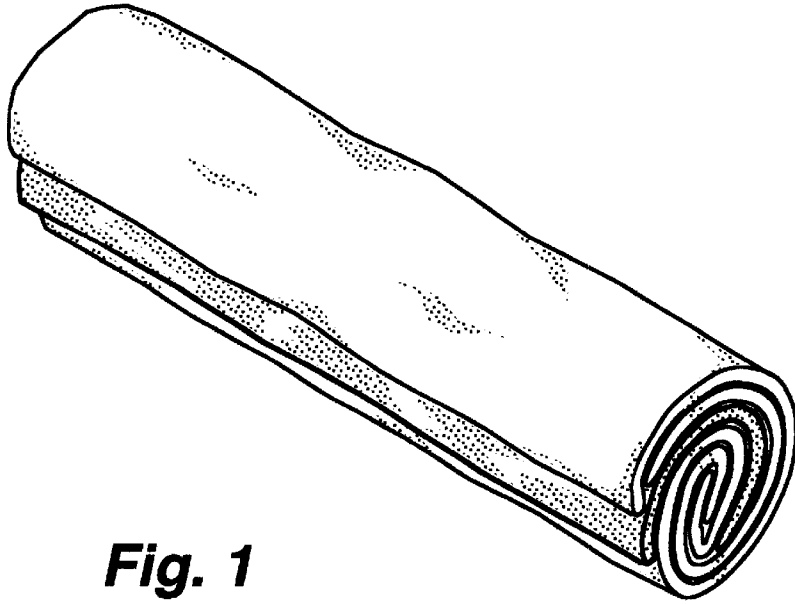
The ornamental design for a rawhide chew roll, as shown.

**DESCRIPTION**

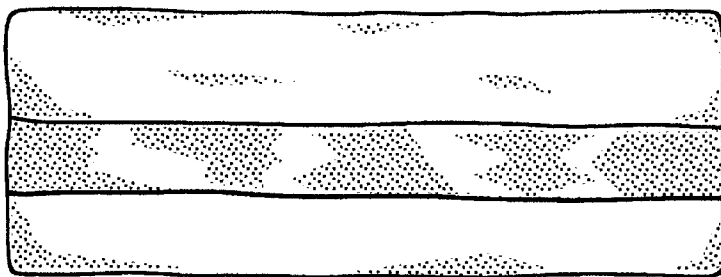
FIG. 1 is an isometric view of a rawhide chew roll;

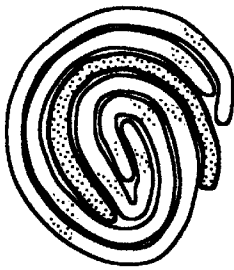

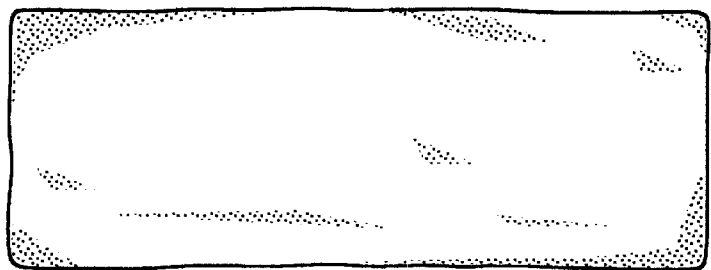
