FIG. 5 is a left side view;

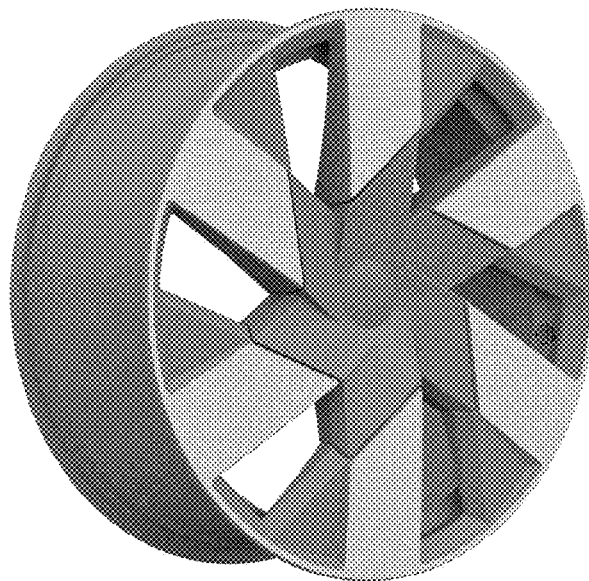
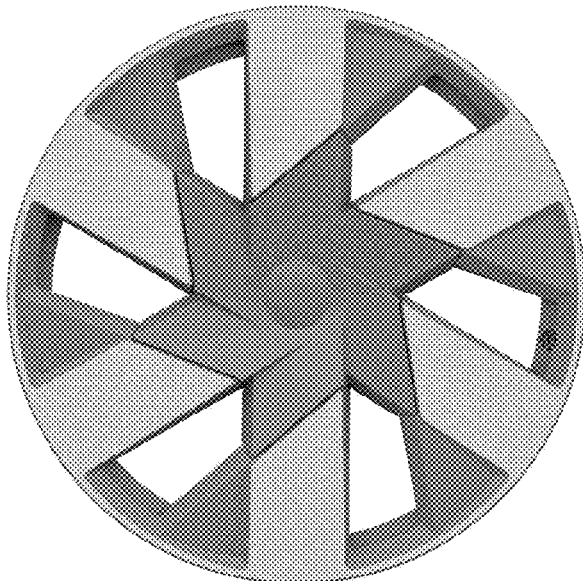
FIG. 6 is a rear view;

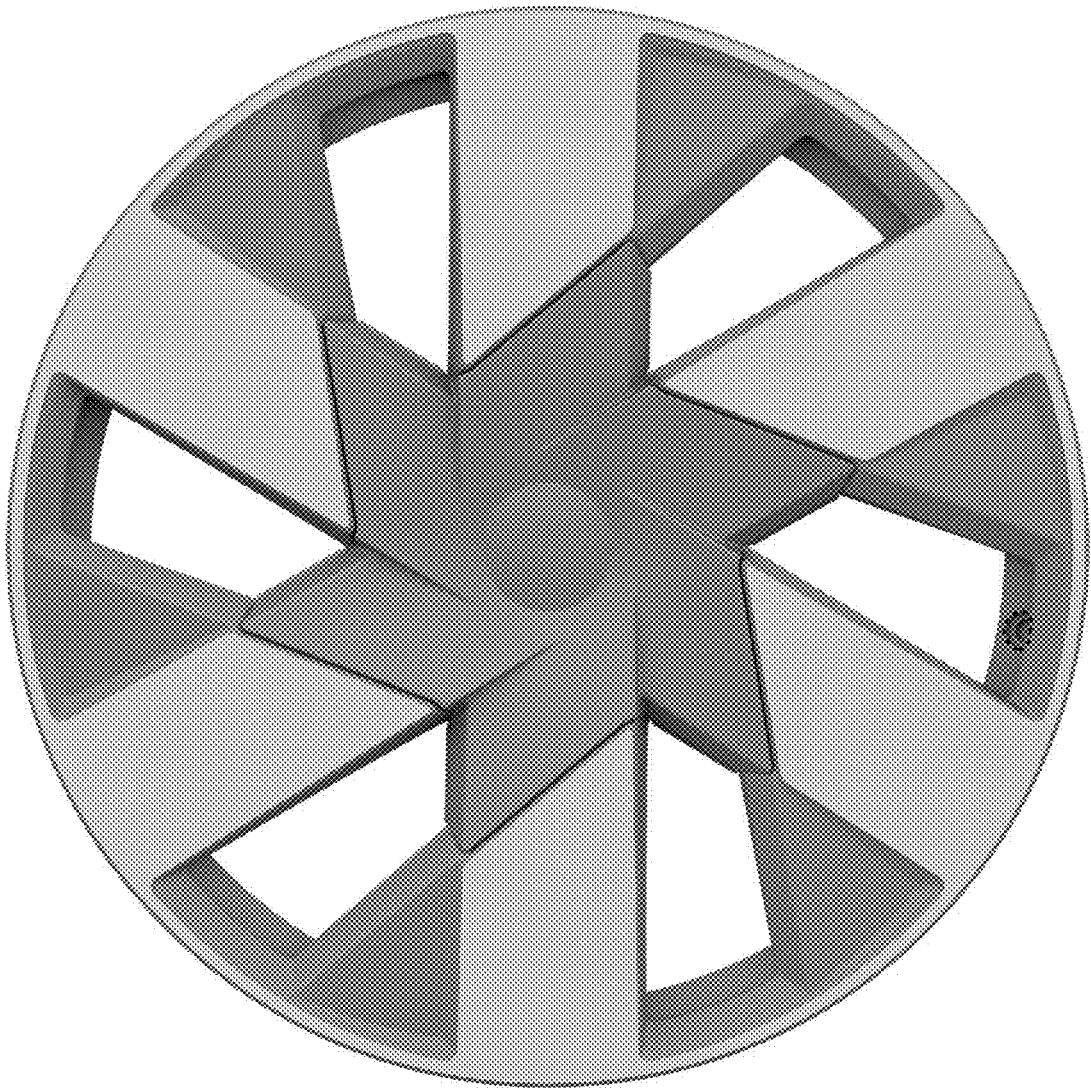

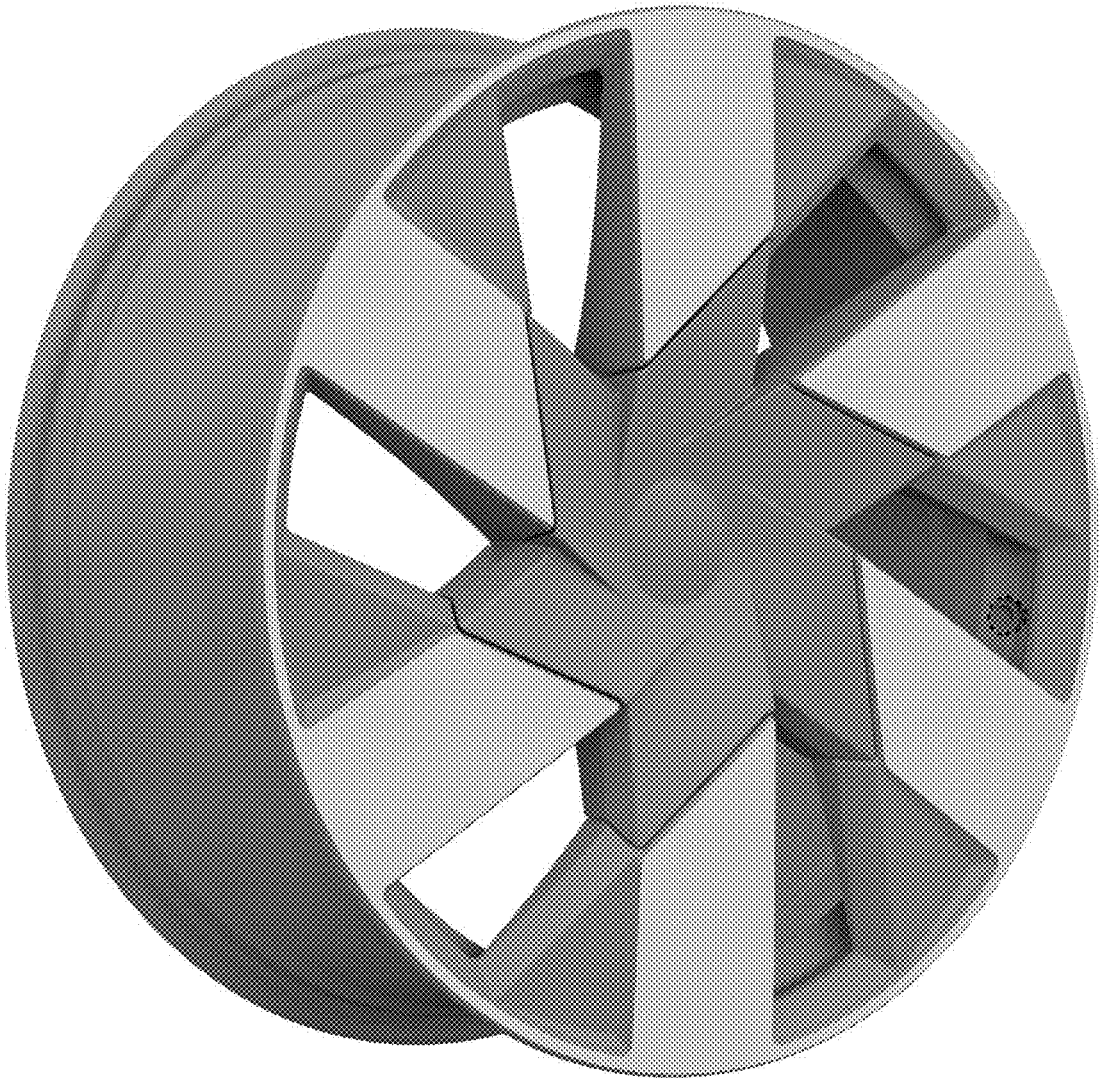

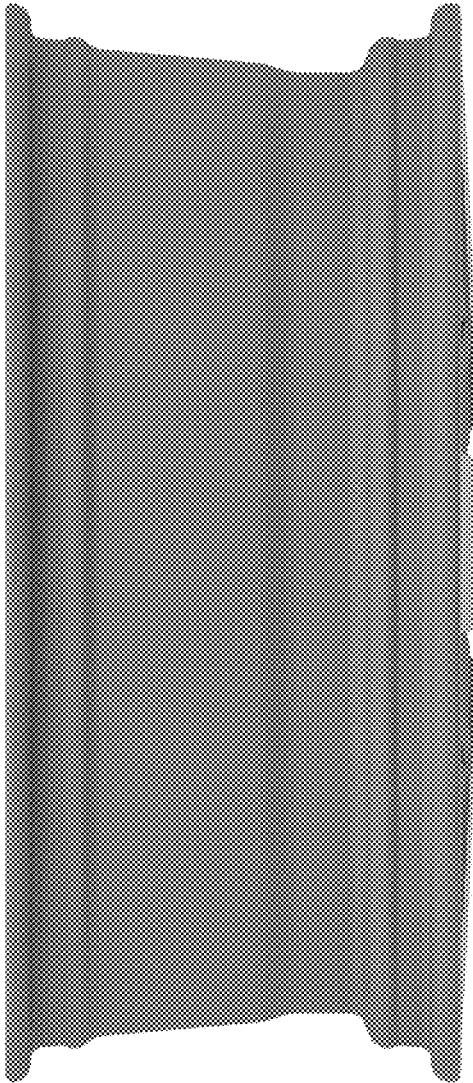

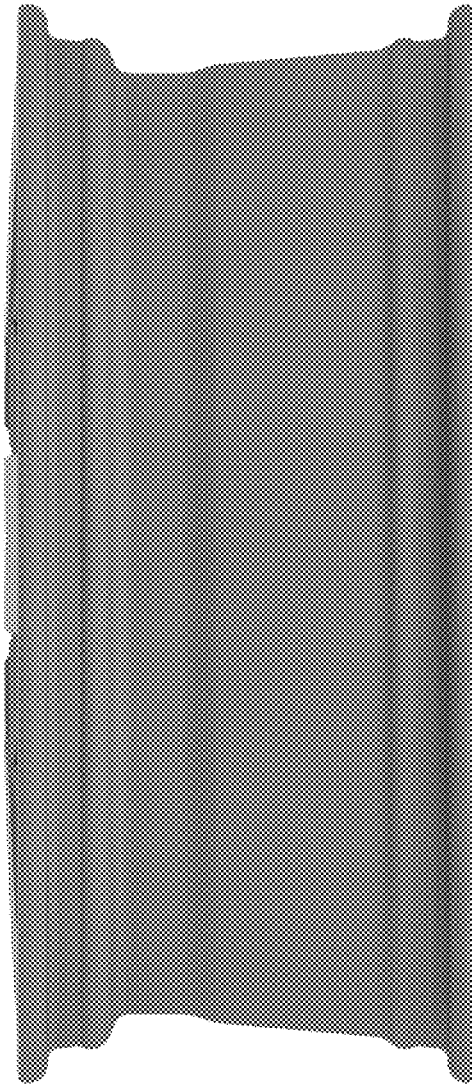

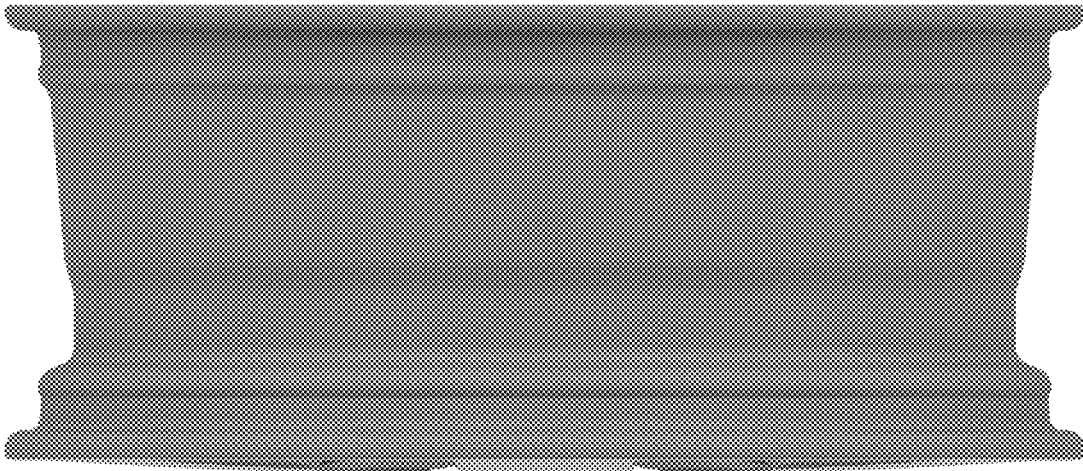

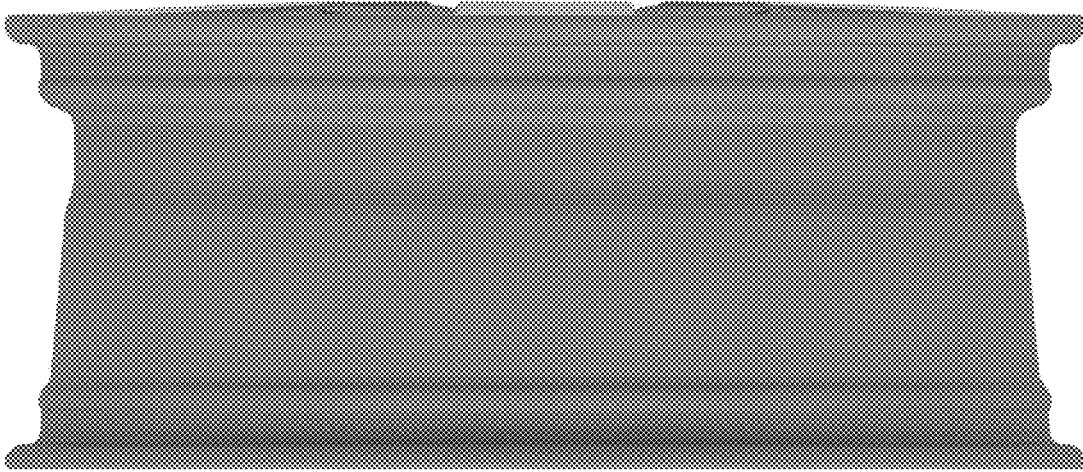
