The ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a toner cartridge showing our new design;

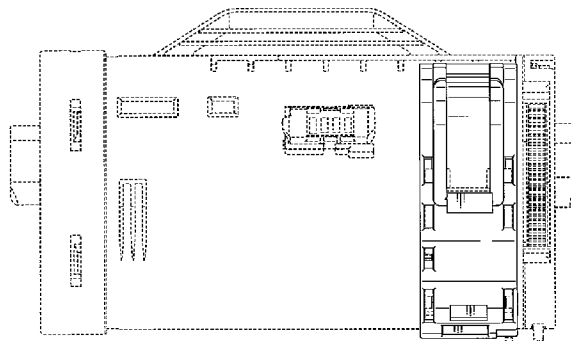
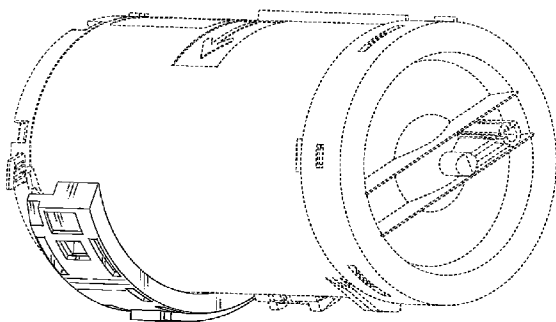

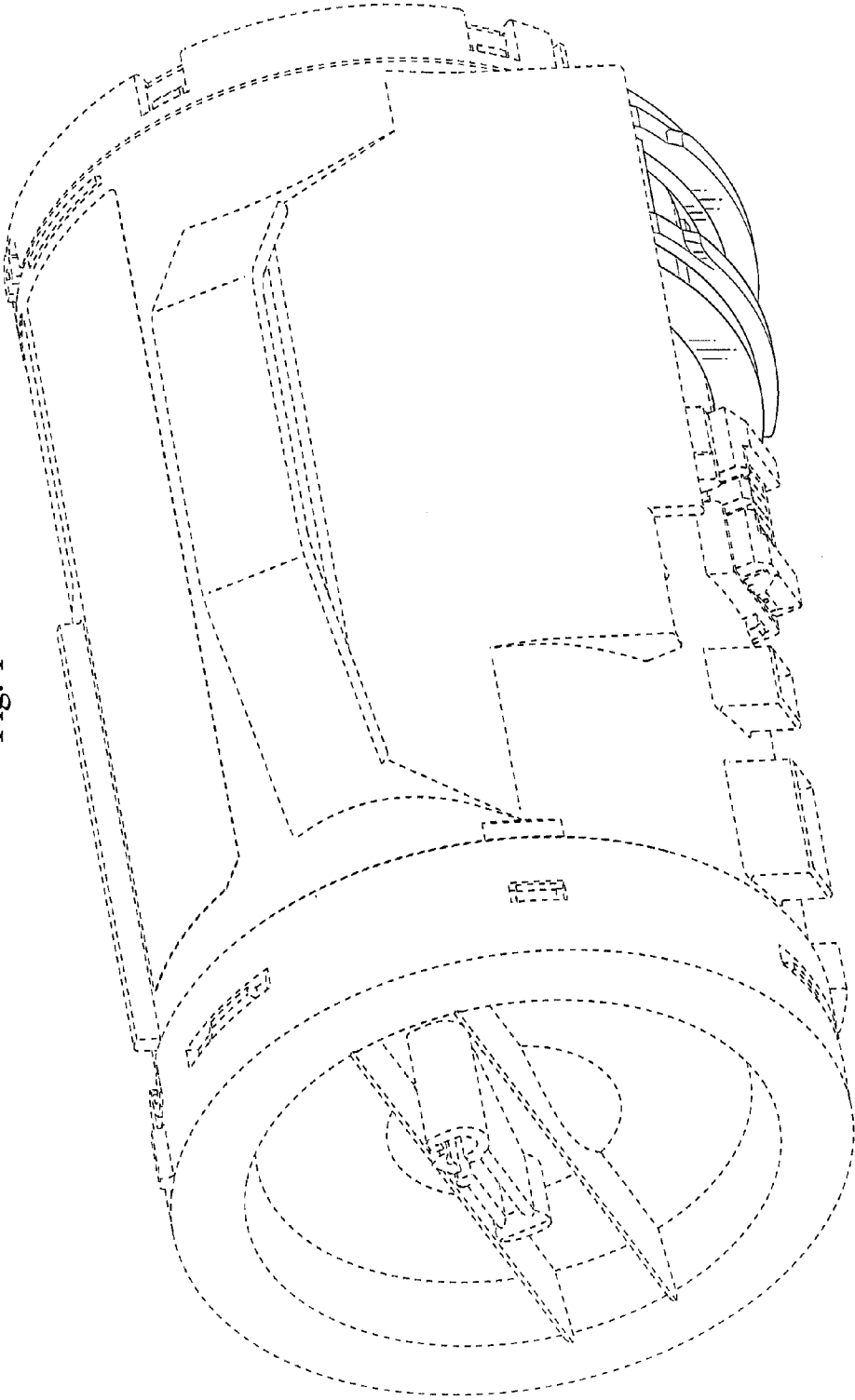
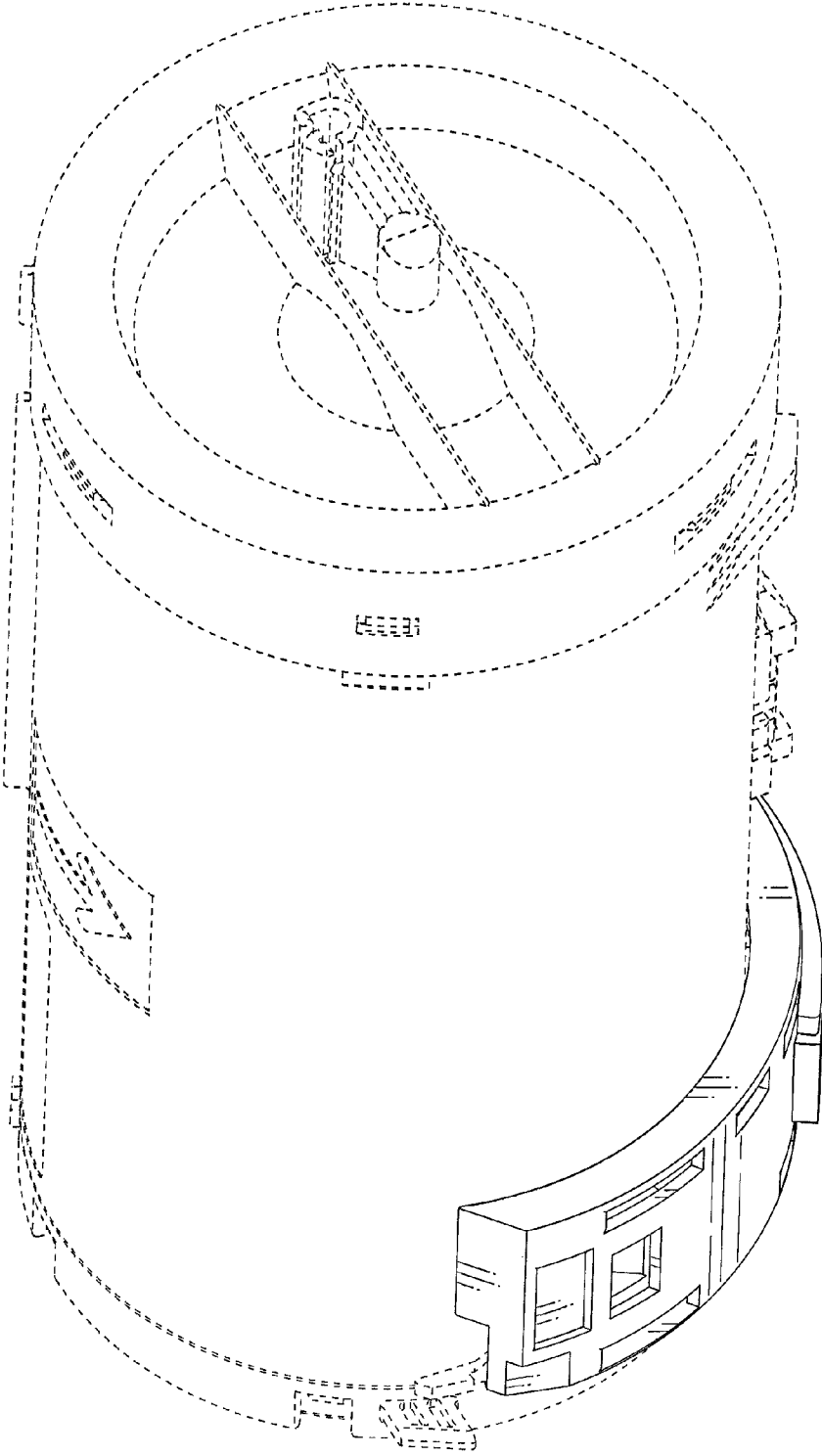

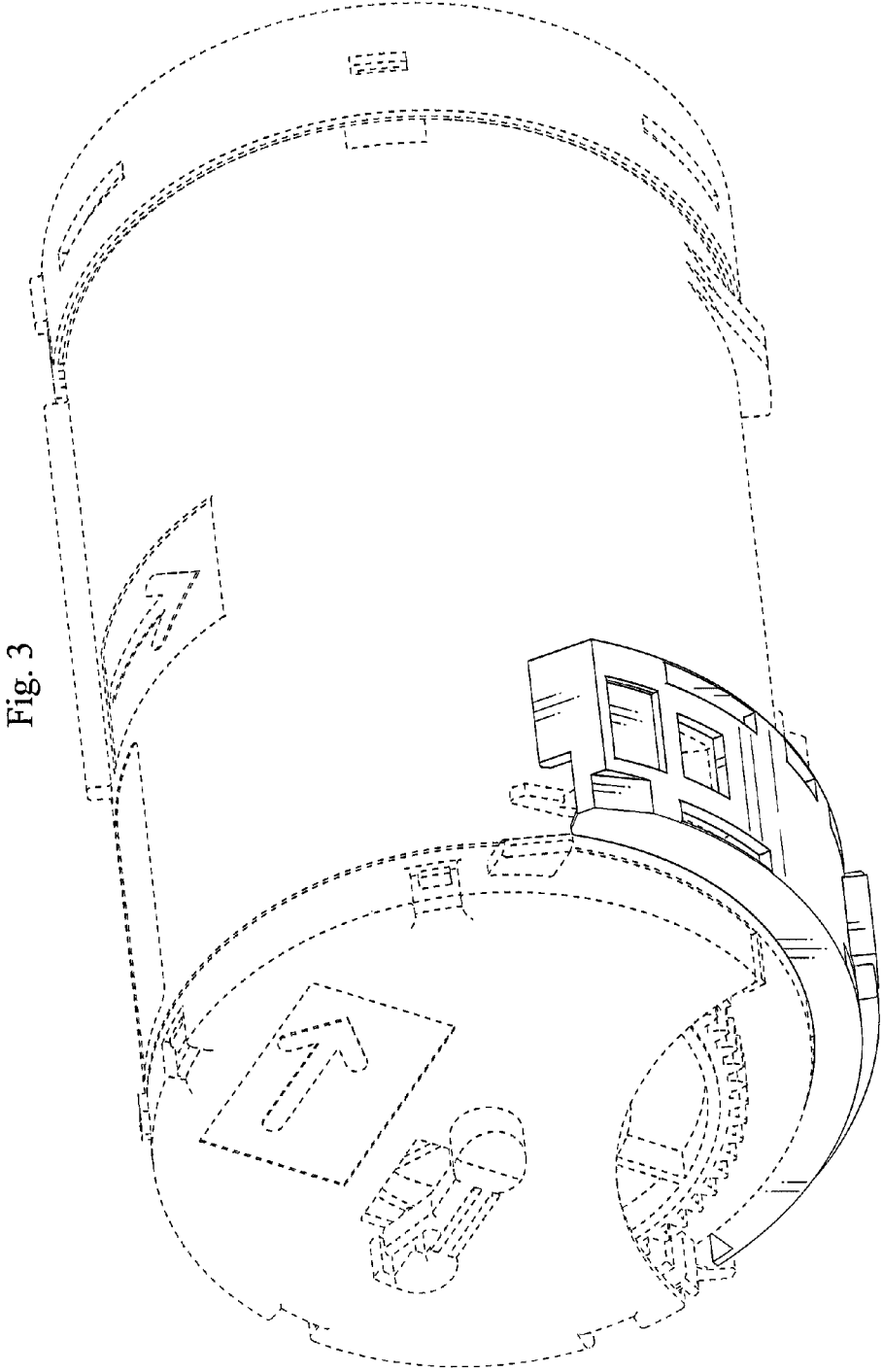

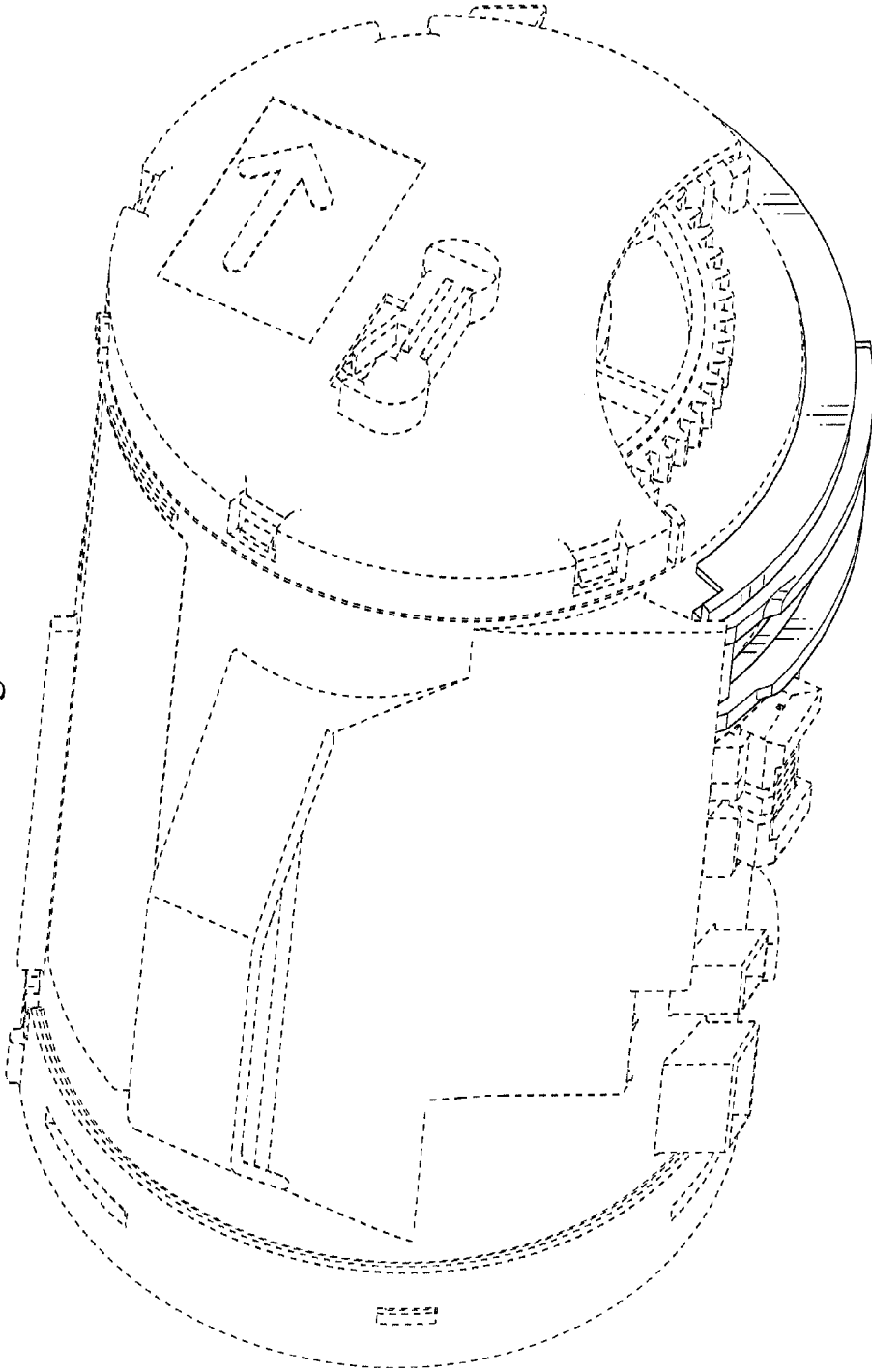

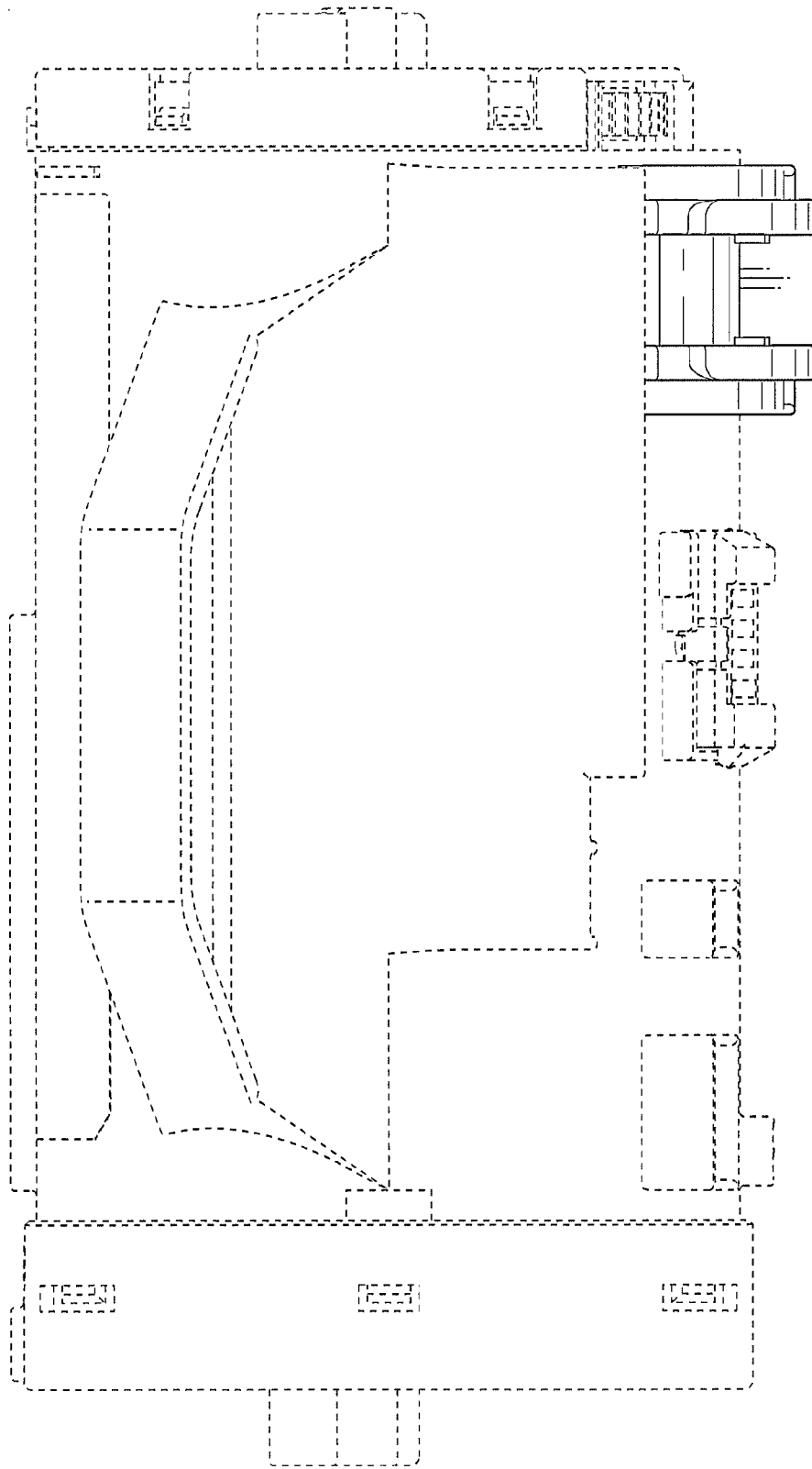

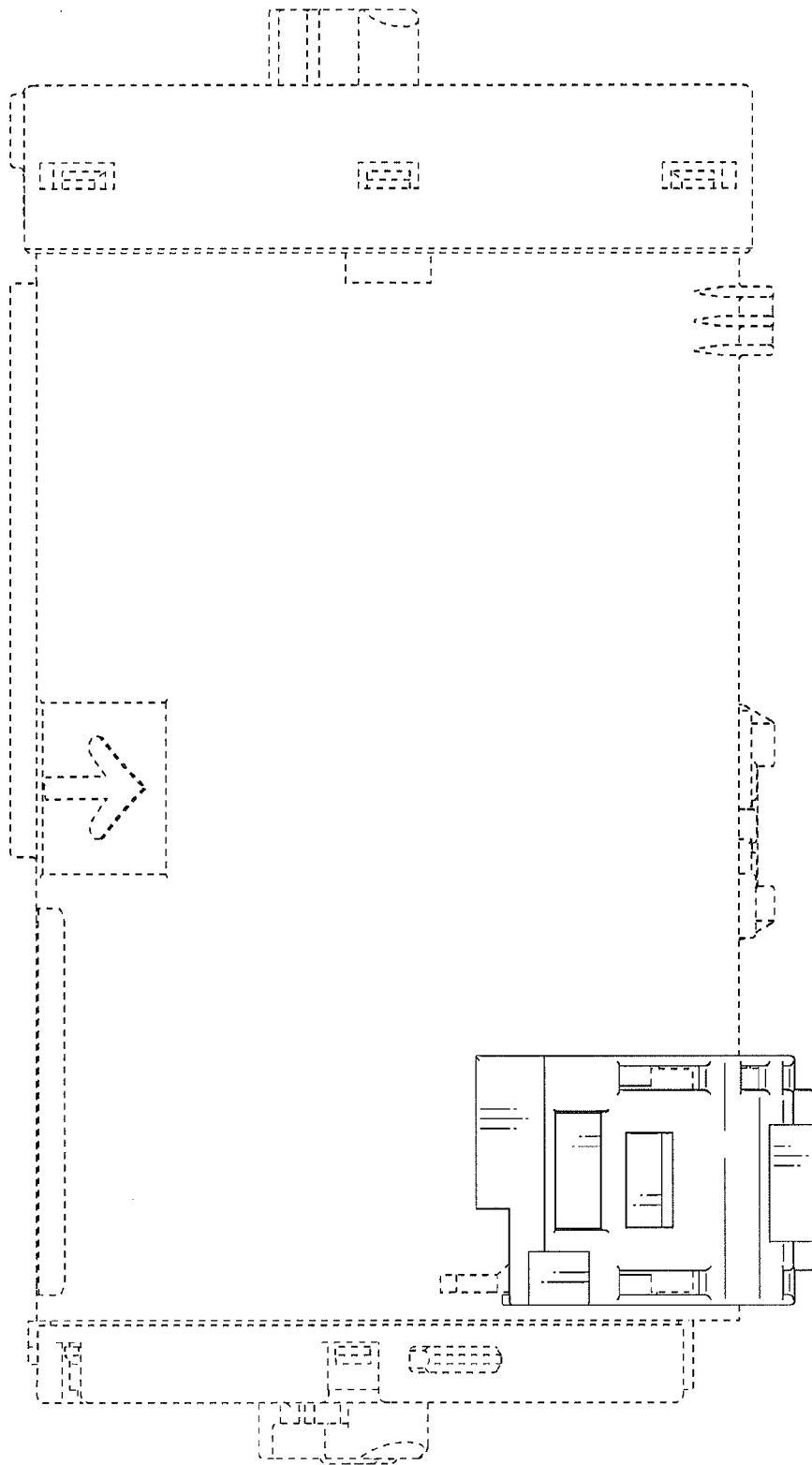

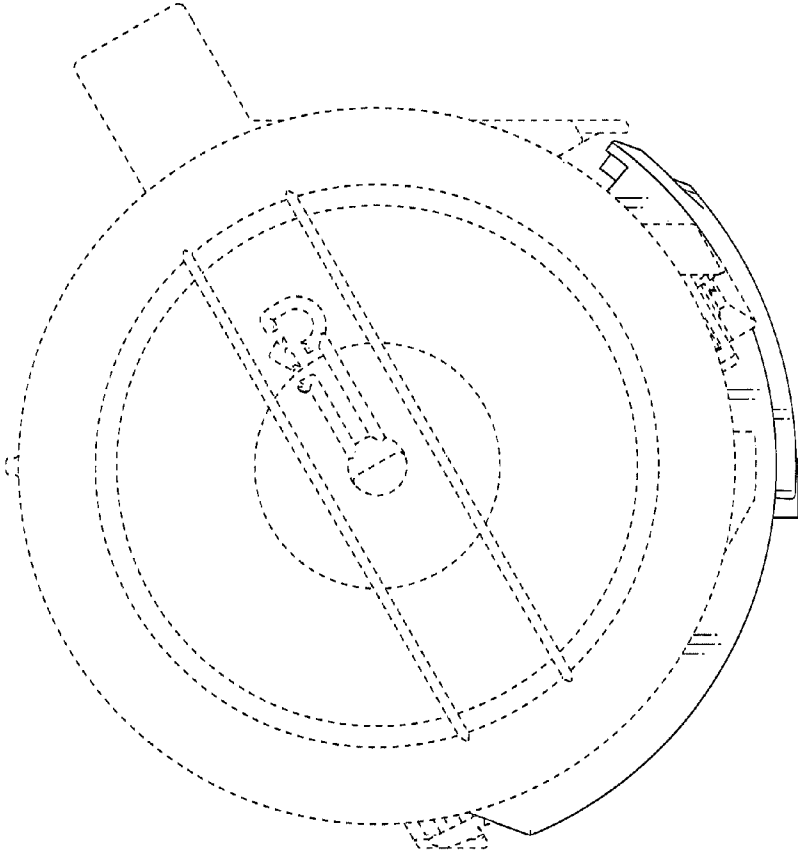

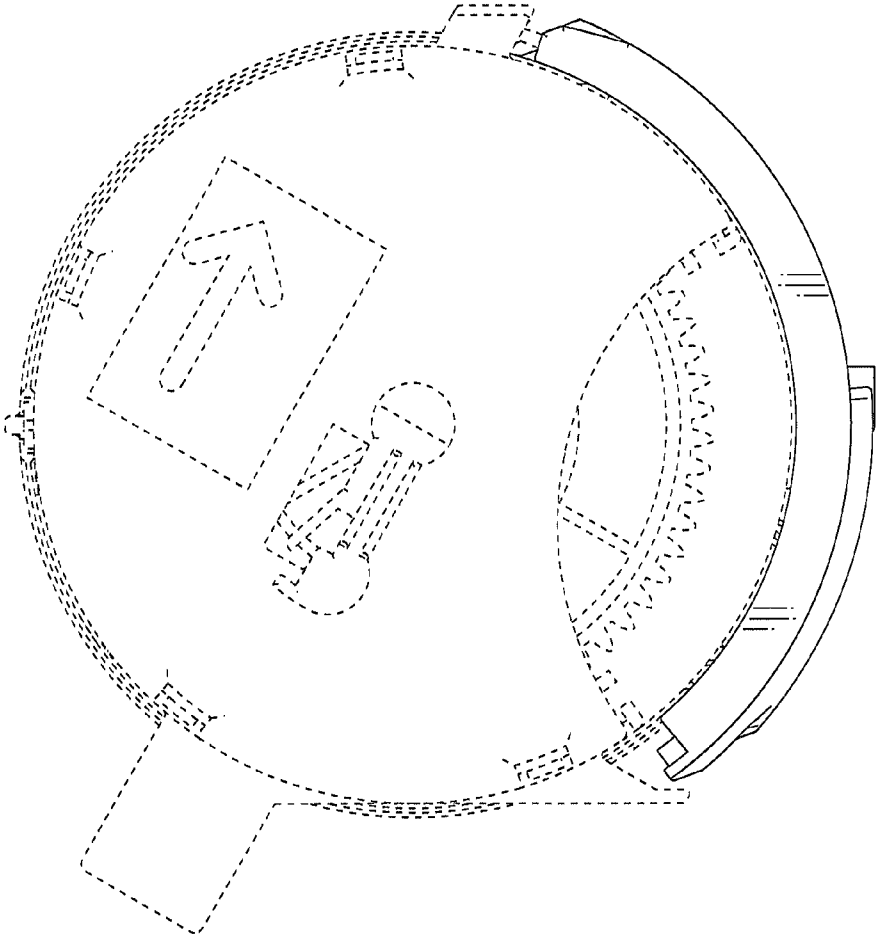

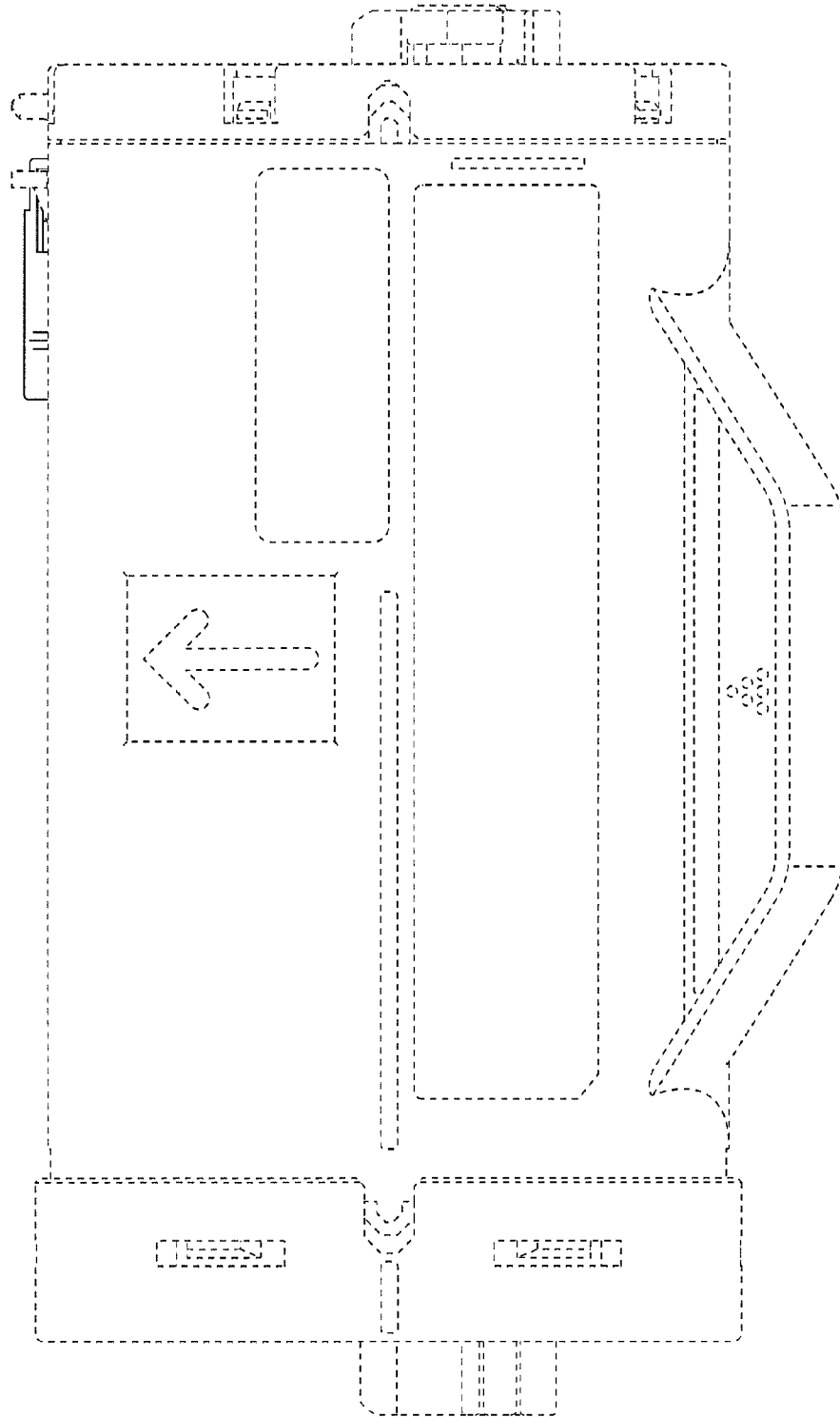
