


COMBINATION TRUNK AND TYPE-WRITER DESK.

To all whom it may concern:

Be it known that I, MARIE ROCHE SCHULTZE, a citizen of the United States, residing at Southampton, in the county of Suf-5 folk and State of New York, have invented certain new and useful Improvements in a Combination Trunk and Type-Writer Desk, of which the following is a specification.

My invention relates to improvements in 10 trunks for travelers and salesmen, the object of my improvements being: 1. To afford facilities for carrying a typewriter, hand sewing machine, or similar instrument. 2. To provide a convenient desk or support for the typewriter, sewing machine or similar in strument when in use. 3. To provide suitable receptacles conveniently located in relation to the typewriter or other instrument above referred to, for classifying and keeping 20 papers in the usual manner. 4. To provide sufficient trunk space for carrying clothing, samples or other articles.

For a full, clear and complete description of one form of my invention, reference may 25 be had to the following specification and to the accompanying drawing forming a part thereof, in which-

Figure 1 is a perspective view of the trunk with the cover open, the desk with a type-30 writer attached and ready for use, and the receptacle for papers in position to coöperate therewith. Fig. 2 is a perspective view of the trunk with the cover open, the other parts being placed in the positions assumed 35 during the transportation.

Referring to the drawings in which similar characters refer to similar parts in the different views, the letters E F X Y indicate one wall of the trunk that is hinged along its edge E—F so as to be capable of being turned outward to rest upon the re-

mainder of the same wall and thereby form a support or desk for the instrument, such as the typewriter indicated. The letters C—F'—P—N— and P' indicate a rectangu45 lar box or drawer that is preferably divided by partitions into pigeon holes, as indicated, and has hinged along one edge thereof, as the edge N—P', a door or cover N—P'—5—6. This door is adapted to close over one side of 50 the drawer and retain the papers or other articles within the pigeon holes. The said drawer C—F'—N—P is provided with suitable guides so that the same may slide easily in and out of the trunk. The cover of the trunk may be provided with the usual straps 1, 2, 3, 4, for holding clothing in position, and may also be provided with additional

drawers for clothing, etc., as indicated.

The typewriter may be turned 90° from 60 the position shown in Fig. 1, so that the keyboard is toward the edge X—Y, whereby the operator may face the machine and the pigeon holes at the same time.

What I claim and desire to protect by Let- 65 ters Patent is:

In combination with a traveler's trunk, a side thereof hinged on a line extending at right angles to the bottom and adjacent to one corner of the trunk so as to leave a fixed 70 portion of said side upon which the hinged portion may rest when open, and a slidable drawer having its top or open side adjacent a side of the trunk that is at right angles to the side carrying the hinged portion, said 75 open side of the drawer when drawn out being located below and laterally of said hinged portion when the latter is swung outward.
