[57] **CLAIM**


I claim the ornamental design for a surface mount box, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of the surface mount box showing the first embodiment of my new design;  
 FIG. 2 is a top view thereof;  
 FIG. 3 is a left side view thereof with the right side being a mirror image thereof;  
 FIG. 4 is a front view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a top perspective view of the surface mount box showing the second embodiment of my new design;  
 FIG. 7 is a top view thereof;  
 FIG. 8 is a left side view thereof with a right side being a mirror image thereof;  
 FIG. 9 is a front view thereof;  
 FIG. 10 is a rear view thereof;  
 FIG. 11 is a top perspective view of the surface mount box showing the third embodiment of my new design;  
 FIG. 12 is a top view thereof;  
 FIG. 13 is a left side view thereof with the right side being a mirror image thereof;  
 FIG. 14 is a front view thereof; and,  
 FIG. 15 is a rear view thereof.






























