


DESCRIPTION

FIG. 1 is a front elevational view of our door facing profile design embodied in a first door facing;
 FIG. 2 is a front elevational view of our door facing profile design embodied in a second door facing;
 FIG. 3 is a cross-sectional view taken along the line 3-3 of FIG. 1;
 FIG. 4 is a fragmentary cross-sectional view taken along the line 4-4 of FIG. 2;
 FIG. 5 is an enlarged view of a portion of FIGS. 3 and 4; and, FIG. 6 is a fragmentary perspective view of FIGS. 3 and 4. Upper and lower boundaries of the vertical solid lines along the left side of one of the panels shown in FIGS. 1 and 2 are represented by diagonal broken lines.
 The broken lines indicate portions of the door facing that form no part of the claimed design.








