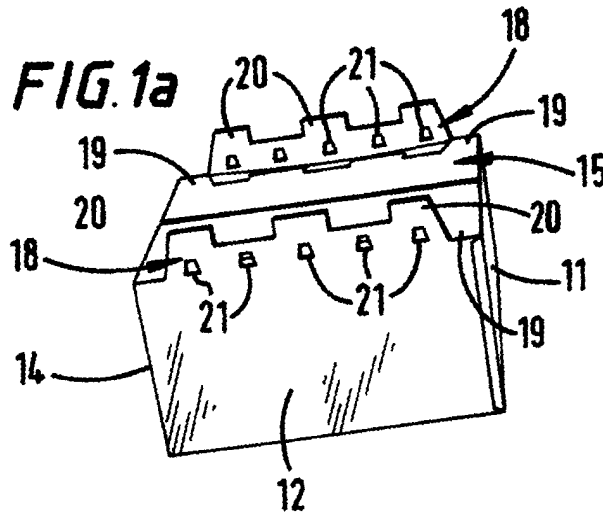

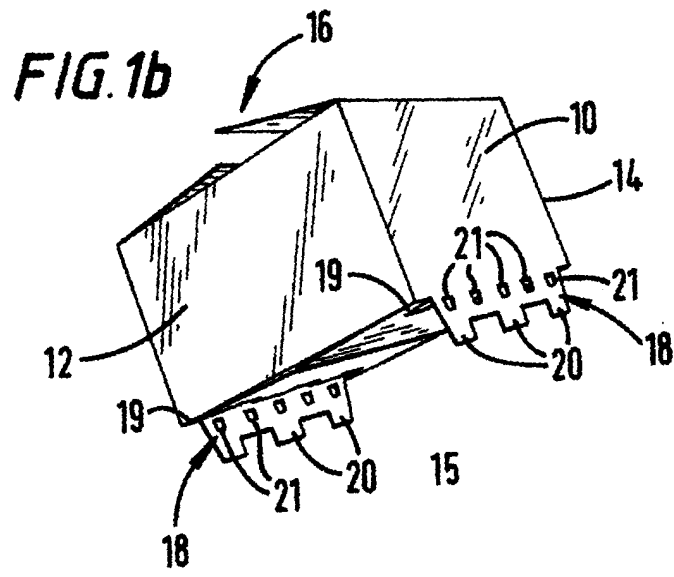

(54) **Carton and box pallet combined with it**

(57) A carton or carton part has a generally square or rectangular cross-section and is formed with depending portions (18) on two opposite side walls. The de-

pending portions have engagement means (21) which can engage formations (42) on a pallet (40) to secure the carton to the pallet (40).
