The ornamental design for a jersey-styled apron, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged front perspective view of a jersey-styled apron, showing my new design;

FIG. 2 is a front view of the jersey-styled apron of FIG. 1.

FIG. 3 is a back view of the jersey-styled apron of FIG. 1.

FIG. 4 is a right side view of the jersey-styled apron of FIG. 1.

FIG. 11 is a right side view of the jersey-styled apron of FIG. 8.

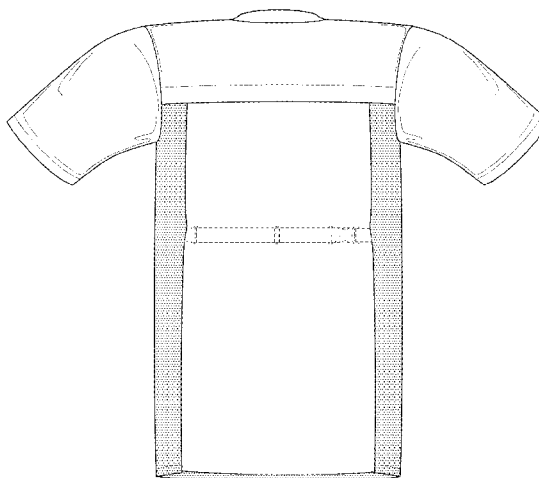
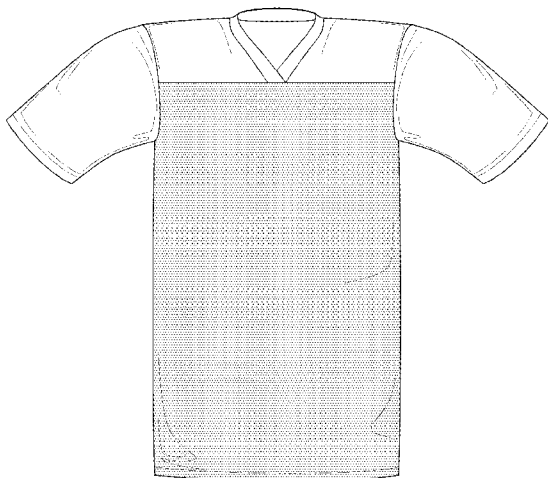
FIG. 12 is a left side view of the jersey-styled apron of FIG. 8.

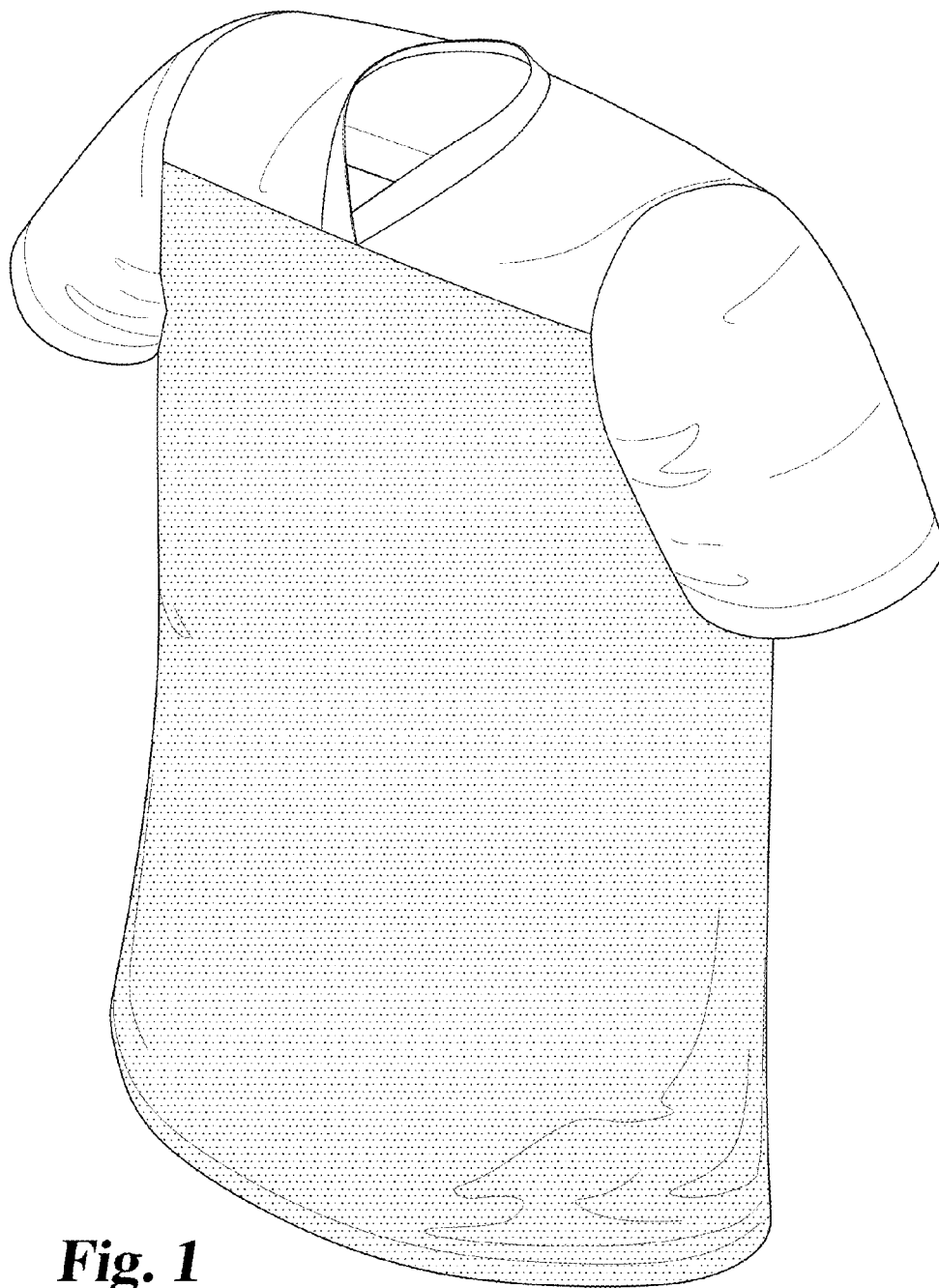

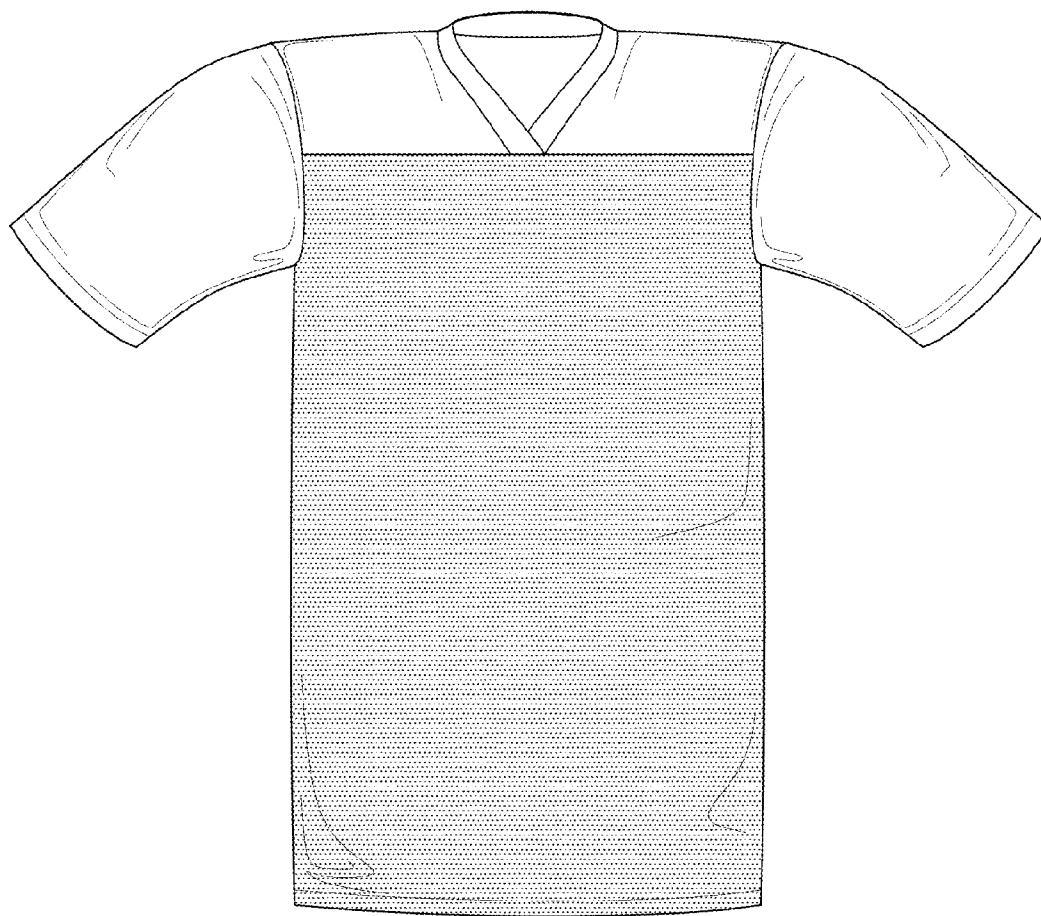

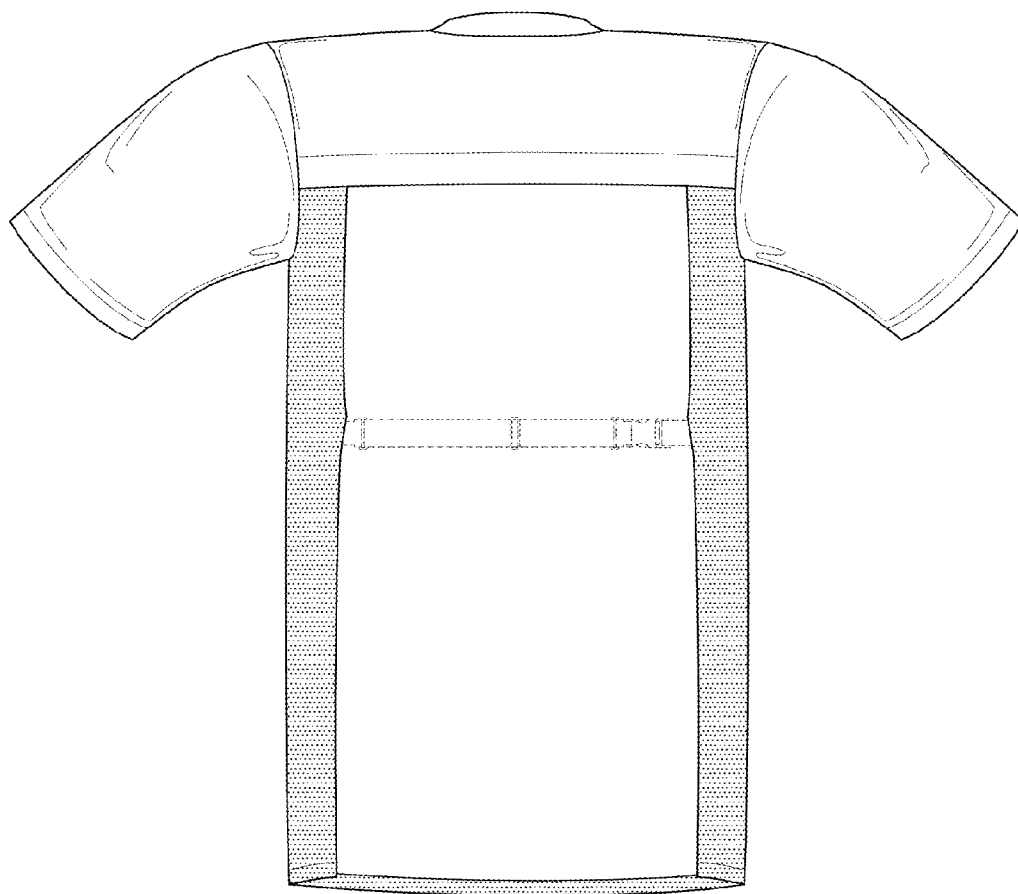

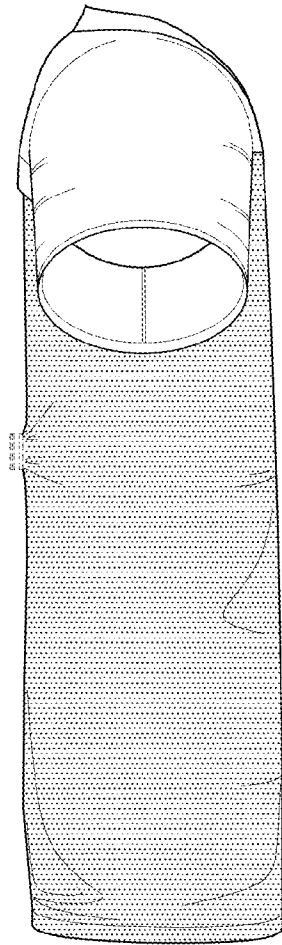

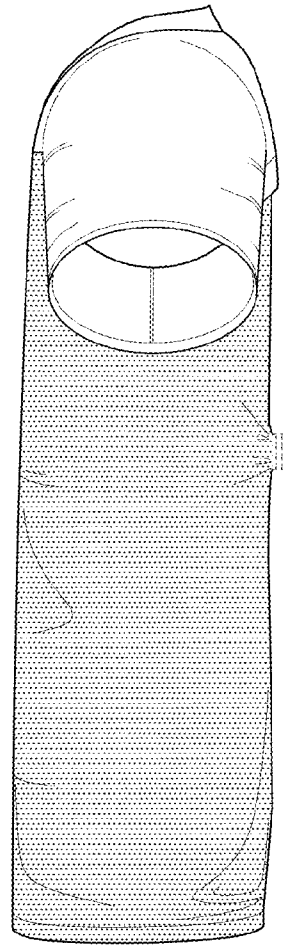

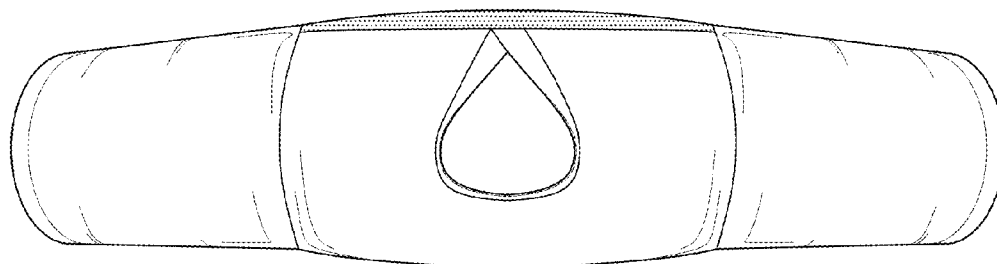

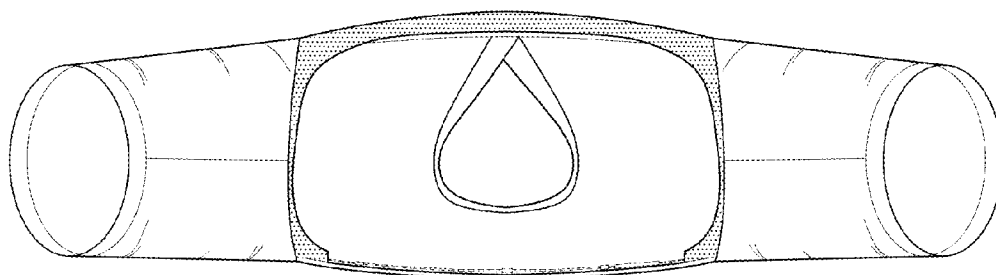

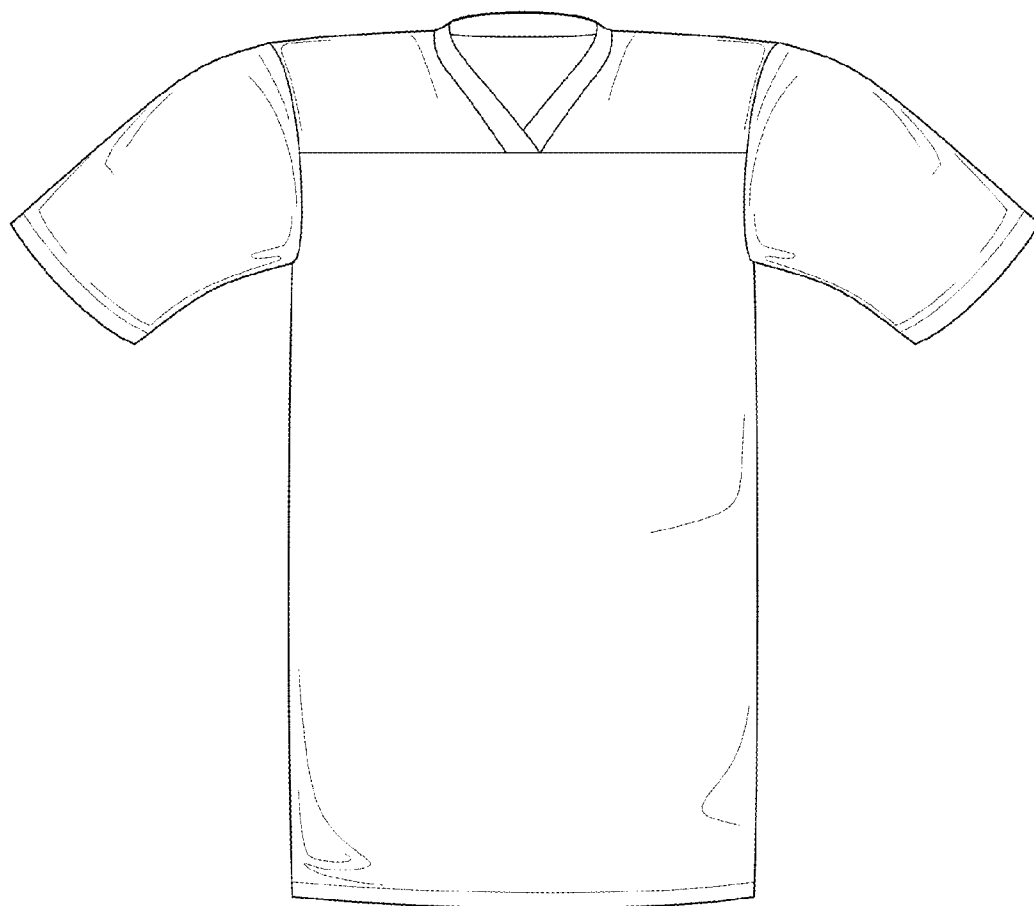

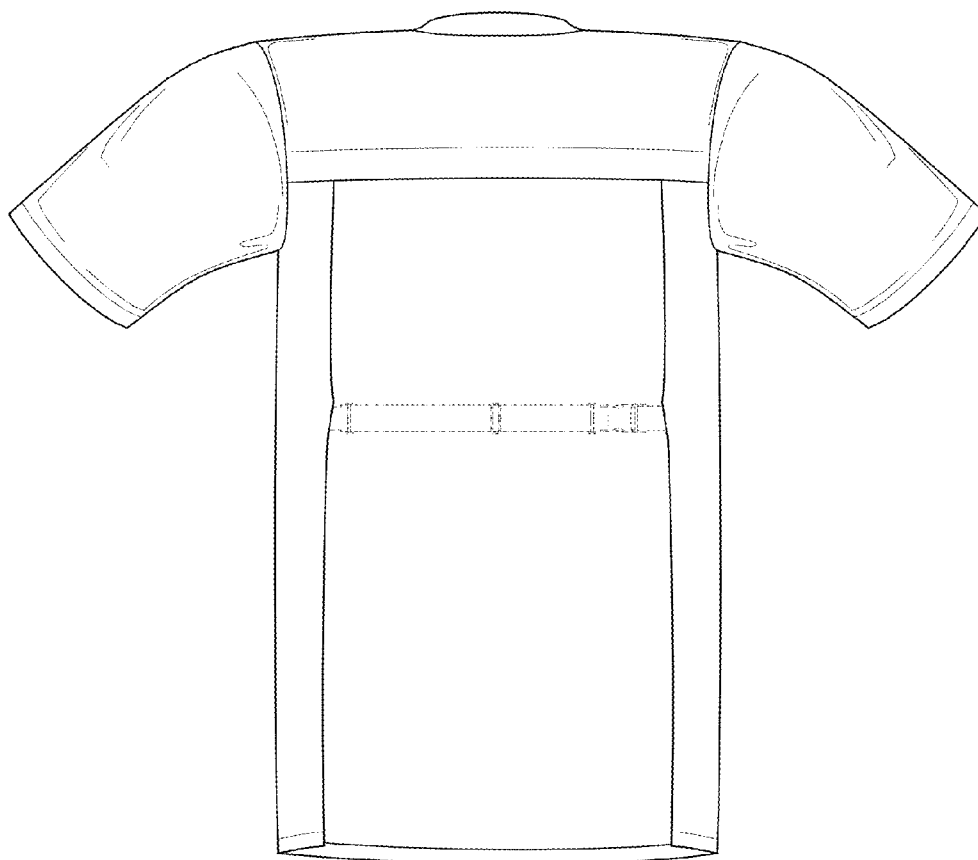

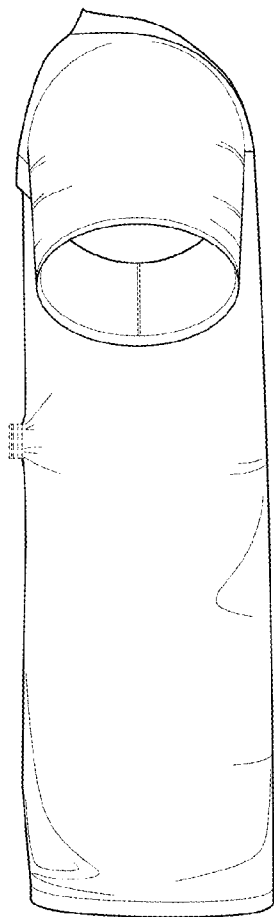

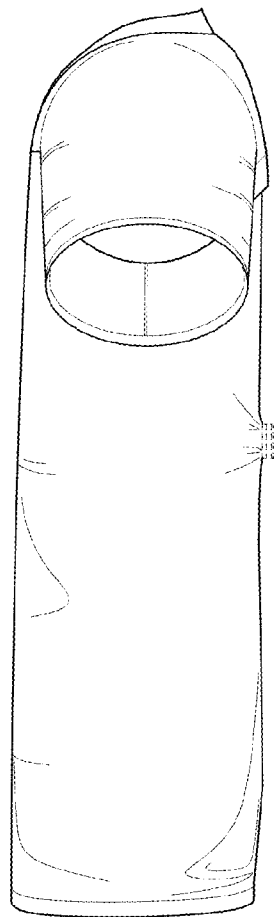

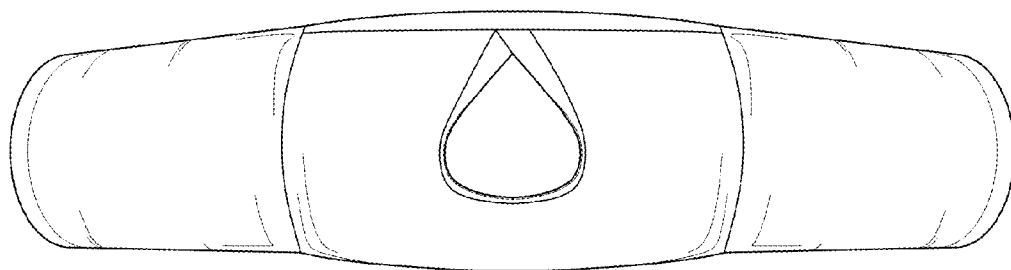

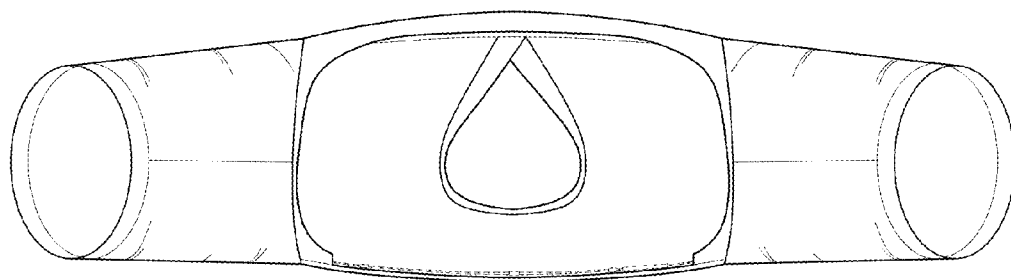
