(54) **Internal heat exchanger for an air conditioning system**

(57) An internal heat exchanger (1) for an air conditioning system (2), comprising an outer tube (3) and a line structure (4) arranged inside the outer tube (3), characterized in that the line structure (4) includes a first flow channel (5), and wherein a second flow channel (6) is formed between the outer tube (3) and line structure (4), wherein the first flow channel (5) has a meandering configuration.

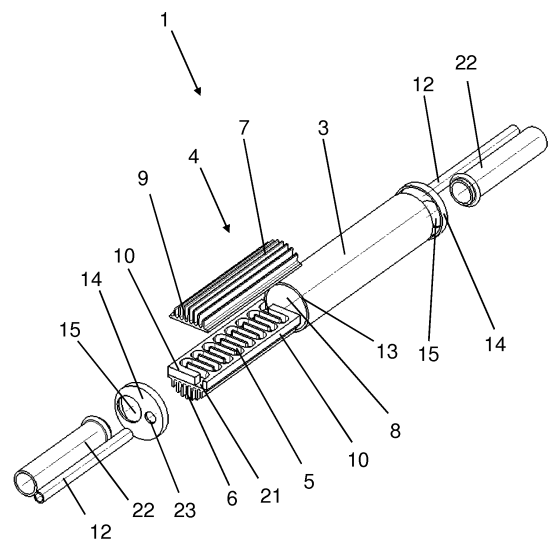
