(57) **CLAIM**

The ornamental design for a nonwoven fabric, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a nonwoven fabric, embodying the new design;
FIG. 2 is plan front view of the nonwoven fabric of FIG. 1;
FIG. 3 is a right-side view of the nonwoven fabric of FIG. 1;
FIG. 4 is a left-side view of the nonwoven fabric of FIG. 1;
FIG. 5 is a top-side view of the nonwoven fabric of FIG. 1; and,
FIG. 6 is a bottom-side view of the nonwoven fabric of FIG. 1.

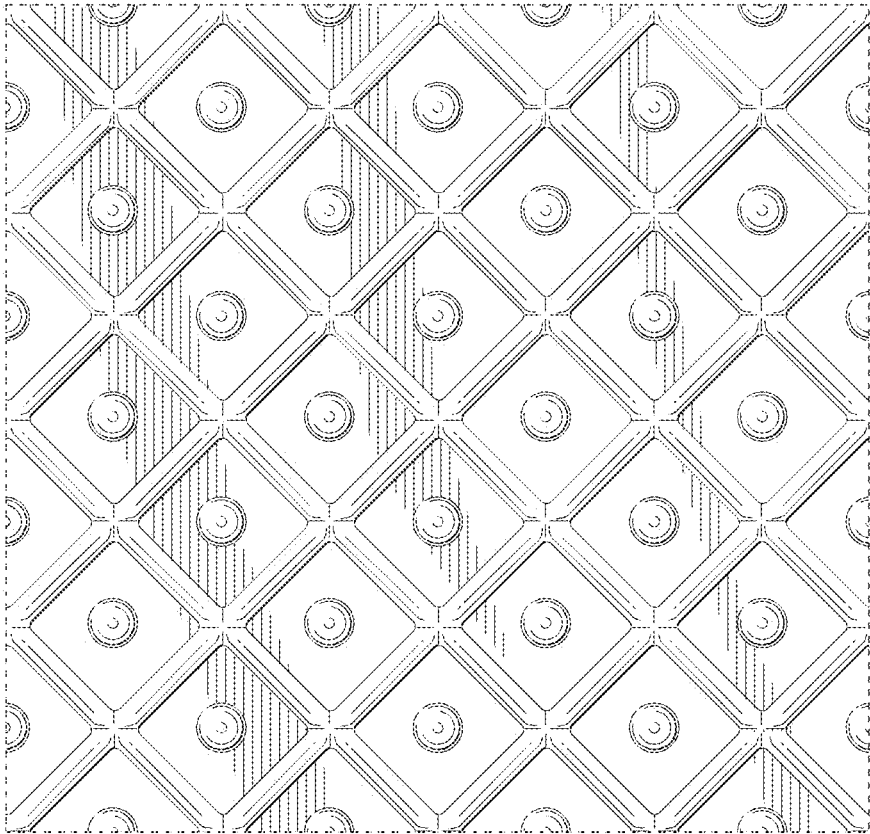

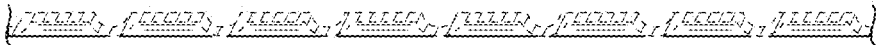

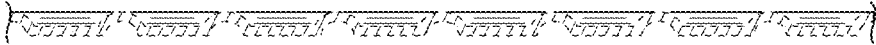
