(57) **CLAIM**

We claim the ornamental design for an LCD television receiver, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an LCD television receiver showing our new design:

FIG. 2 is a front elevation view thereof;

FIG. 4 is a left-side elevation view thereof;

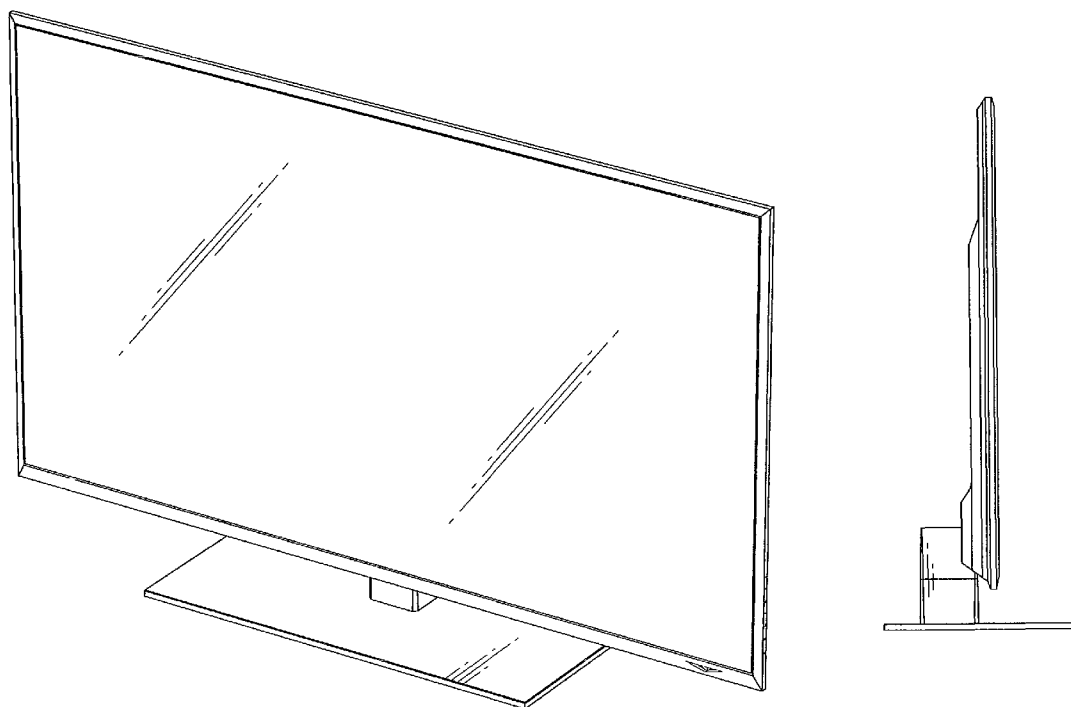

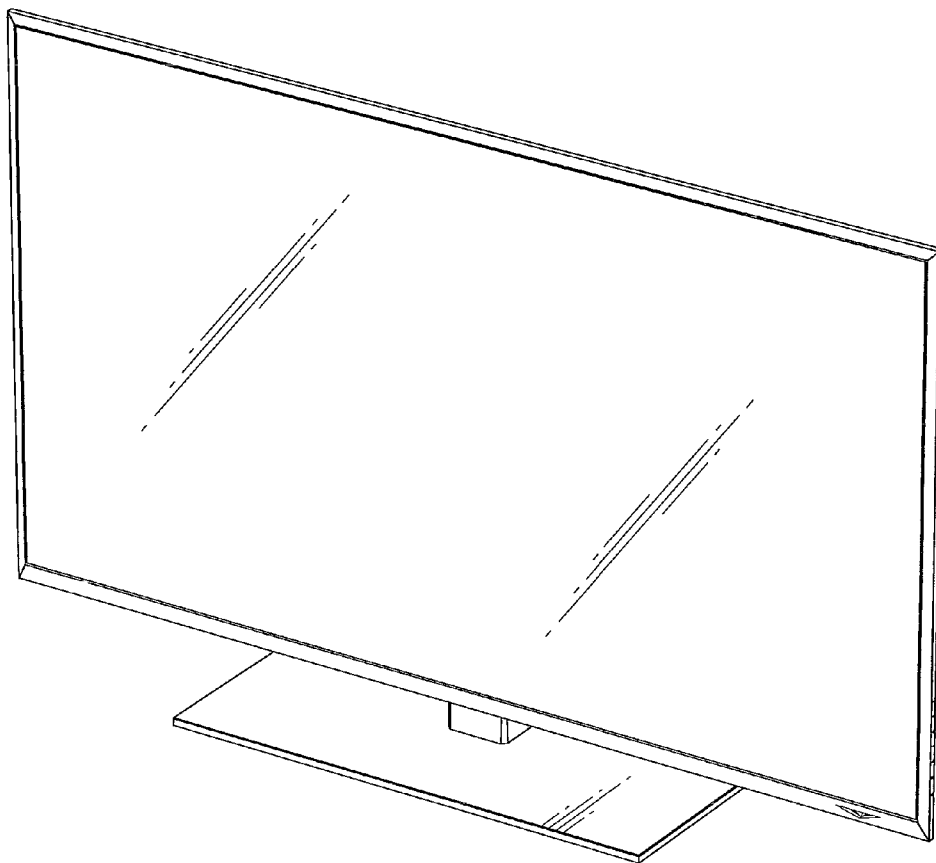

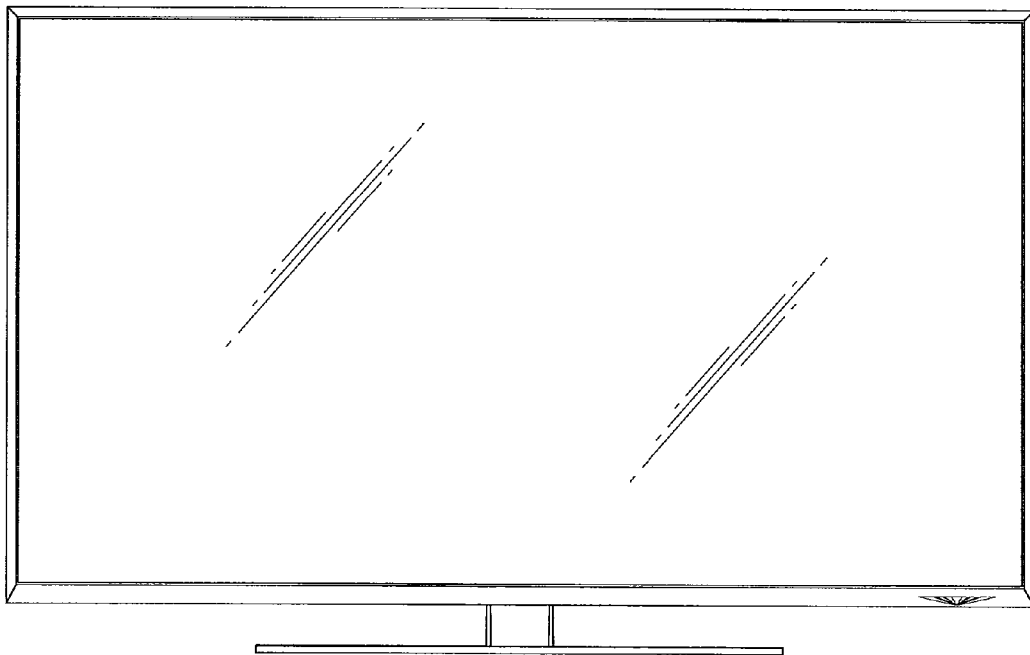

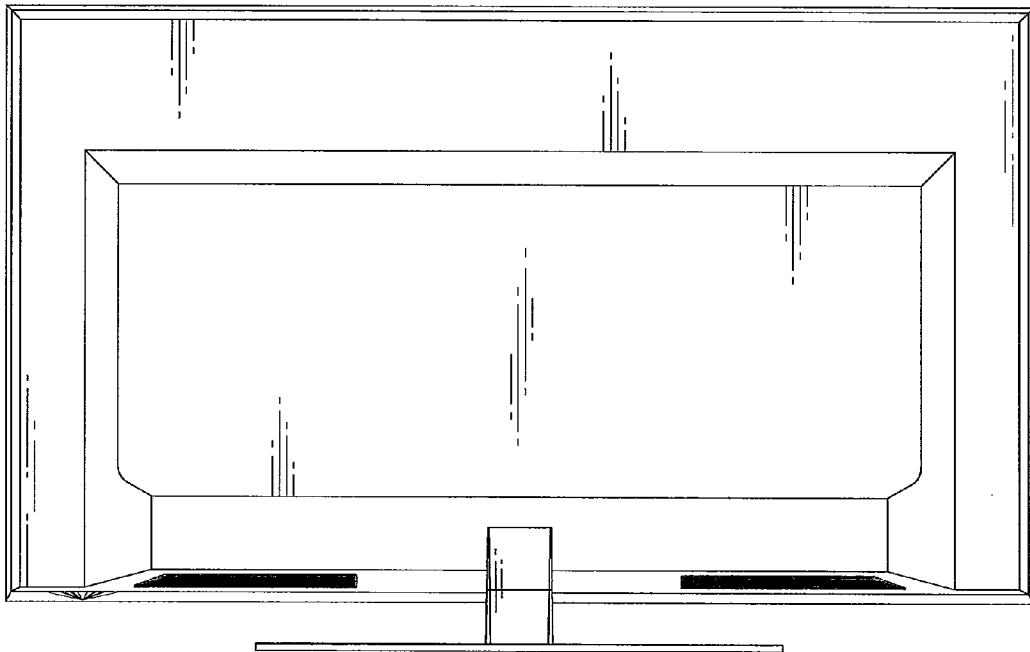

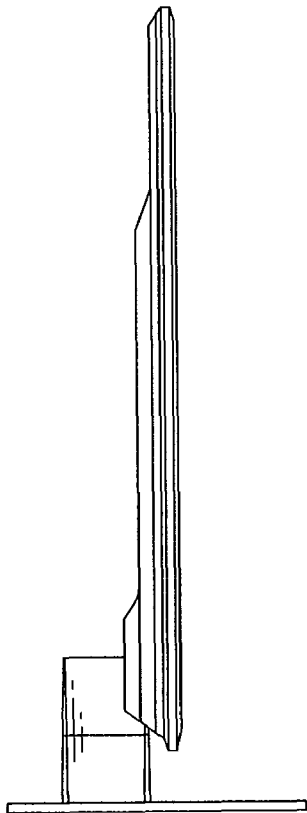

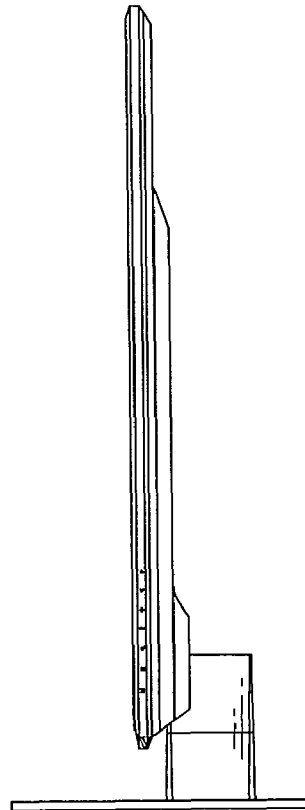

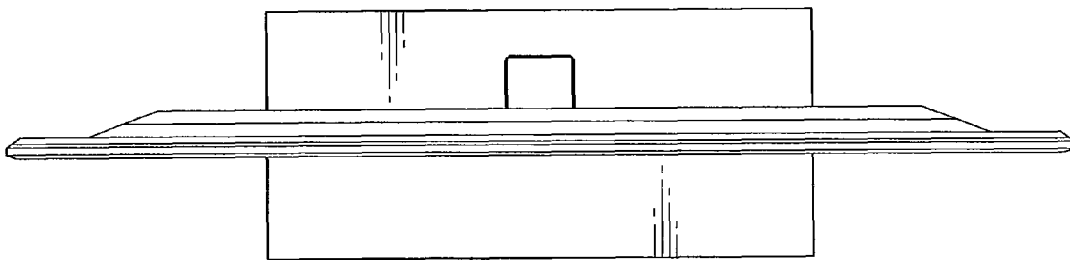
