(57) **CLAIM**

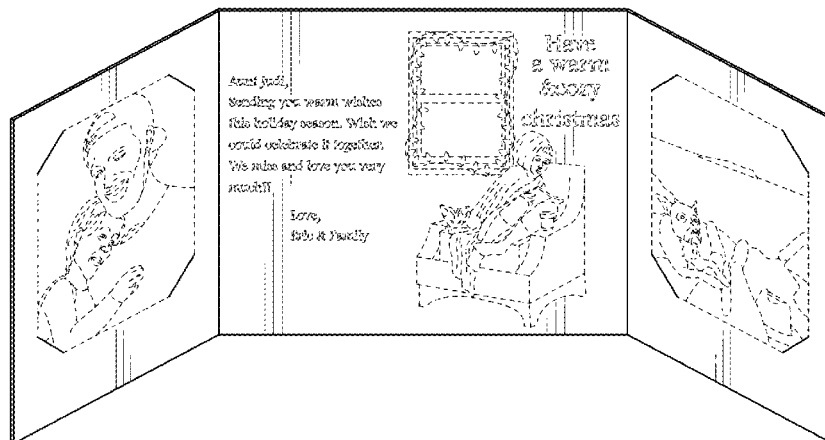
I claim the ornamental design for a greeting card with photograph inserts, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the greeting card with photograph inserts showing my new design; FIG. 2 is another perspective view thereof; FIG. 3 is a front elevational view of FIG. 2; FIG. 4 is a rear elevational view of FIG. 2; FIG. 5 is a left-side elevational view of FIG. 2, the right-side elevational view being a mirror image thereof; and, FIG. 6 is a top plan view of FIG. 2, the bottom plan view being a mirror image thereof.

The broken lines showing a text and images in FIGS. 1-4, and photographs in FIG. 1, depict portions of the greeting card that form no part of the claimed design.

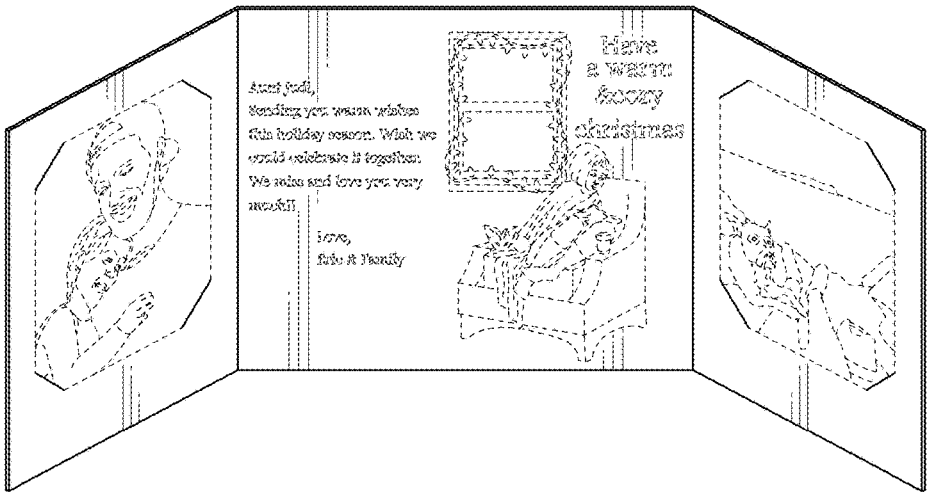

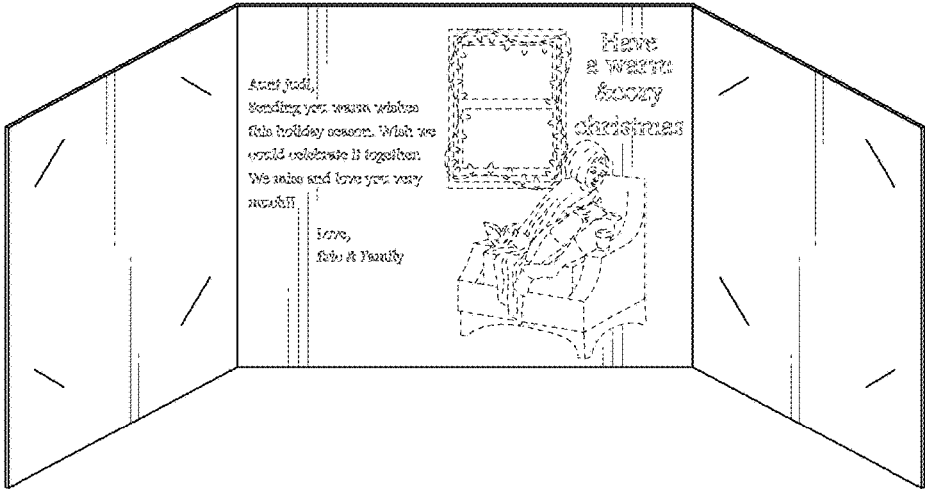

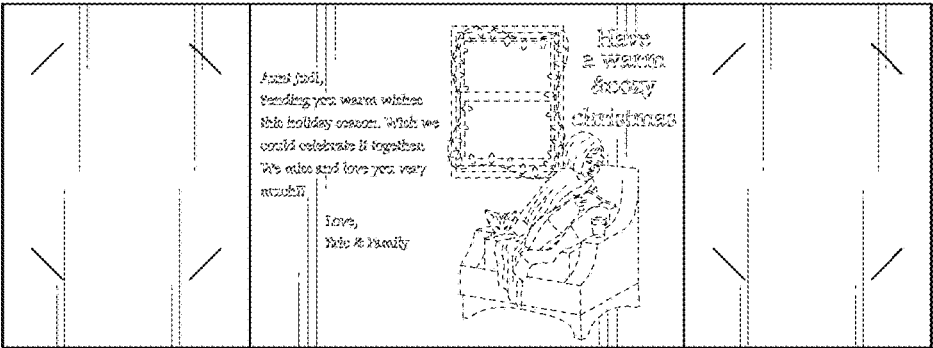

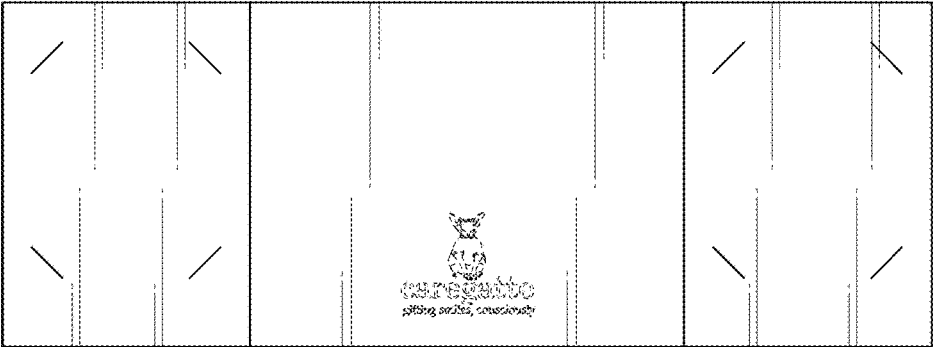

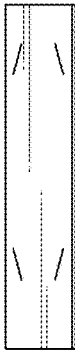
