The ornamental design for a tray for sterilization and drying of pistons for syringe, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a tray for sterilization and drying of pistons for syringe showing my new design;

FIG. 2 is a rear elevational view thereof;

FIG. 3 is a front perspective view thereof;

FIG. 4 is an enlarged front view of the part defined by the line 4-4 and 4'-4' of FIG. 1;

FIG. 5 is an enlarged rear elevational view of the part defined by the line 4-4 and 4'-4' of FIG. 1;

FIG. 6 is an enlarged front perspective view of the part defined by the line 4-4 and 4'-4' of FIG. 1; and

FIG. 7 is an enlarged rear perspective view of the part defined by the line 4-4 and 4'-4' of FIG. 1.

FIG. 8 is an enlarged cross-sectional view thereof taken along the line 8-8 in FIG. 4;

FIG. 9 is an enlarged cross-sectional view thereof taken along the line 9-9 in FIG. 4;

FIG. 10 is an enlarged front elevational view of the part defined by the lines 4-4 and 4'-4' of FIG. 1;

FIG. 11 is a combined sectional view thereof taken along the line 11-11'-11" in FIG. 10;

FIG. 12 is a combined sectional view thereof taken along the line 11-11'-11" in FIG. 10 showing the state of use.

FIG. 13 is a top plan view thereof;

FIG. 14 is a bottom plan view thereof;


FIG. 15 is a right side view thereof; and,

FIG. 16 is a left side view thereof.
































