
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is an opposite side front perspective view thereof; and, FIG. 4 is an opposite side view thereof. The wavy broken line on each side of the tongue region represents stitching which forms no part of the claimed design. The broken lines depicting the remainder of the shoe form no part of the claimed design.








